## Independent Auditor's Report

To the Plan Administrator of **Marcorp Limited 401(k) Plan**:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

**A. Description of Plan**

The following description of Marcorp Limited 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement or the Summary Plan Description for a more complete description of the Plan's provisions.

General

Marcorp Limited (the "Company") is the Plan Sponsor and the Plan Administrator. The Plan is a defined contribution, tax-deferred retirement savings plan covering eligible Company employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Salaried and hourly wage employees of the Company who are at least 21 years of age and have one year of service with the Company are eligible to participate in the Plan. Plan entry dates are quarterly on January 1, April 1, July 1, and October 1 of each year after meeting eligibility requirements.

Contributions

Each year, participants may contribute a portion of eligible compensation, not to exceed the maximum salary deferral limit and other limitations established by law. Eligible compensation is defined in the Plan as taxable income on Form W-2, plus elective deferrals, contributions made to a qualified cafeteria plan and certain other amounts, but excluding bonuses, reimbursements, expense allowances, fringe benefits, and certain other items of income.

New employees who have satisfied eligibility requirements are automatically enrolled as Plan participants after one year of employment and the Plan Administrator will automatically contribute 2% of the employee's compensation from each payroll into the Plan. The employee has the option to choose a different percentage, including zero.

Participants may elect to make deferral contributions either as pre-tax elective deferrals, after-tax Roth elective deferrals, or as a combination of both pre-tax and Roth elective deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as allowed by the Internal Revenue Code. Participants also may make rollover contributions as defined in the Plan. Participant contributions are invested according to direction of the participants.

The Plan provides for discretionary matching contributions to be made in a percentage or amount, if any, as determined by the Company. In 2024, the Company contributed matching contributions in the amount of 25% of employee deferrals, the amount of the matching not to exceed 4% of the employee's eligible compensation. Company contributions are invested according to participant investment elections.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company contributions. Investment earnings, losses, and changes in market value are allocated based upon the investment experience of each holding in a participant account. Certain transactional costs and service charges, if any, are allocated to the specific accounts involved in the transaction or receiving the service. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their own deferral and rollover contributions and earnings thereon. Participants vest in Company matching and profit sharing contributions and earnings thereon as follows: 20% vesting after two years of service, 40% vesting after three years of service, 60% vesting after four years of service, 80% vesting after five years of service, and 100% vesting after six years of service based on the elapsed time between the first and final days of service. Participants become 100% vested under certain circumstances, including attainment of age 65, the Plan's normal retirement age. Non-vested balances are subject to forfeiture upon termination of employment.

Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. One outstanding loan is allowed at any one time. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%, as specified in the Plan. Principal and interest are paid ratably through payroll deduction.

Payment of Benefits

Plan participants are eligible to receive benefit payments from the Plan at retirement, prior to retirement under certain circumstances, upon termination of employment with the Company, and at death. Benefit payments may be made as a lump-sum payment equal to the value of the participant's vested interest in his or her account, partial payments, or rollover to another qualified plan. Upon termination of employment, accounts with vested balances of less than \$5,000 may be distributed out of the Plan.

Forfeitures

At December 31, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$616 and \$541, respectively. Forfeitures can be used to offset Company contributions and Plan expenses. Forfeitures totaling \$941 were used to cover employer contributions and Plan expenses for the period ended December 31, 2024.

**B. Summary of Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

Preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation of the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. The loans are secured by vested participant account balances. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain administrative expenses of the Plan are paid by the Company. Expenses paid by the Company are excluded from these financial statements. Per-use transaction fees are charged directly to specific participant accounts for certain services, such as processing loans, in-service withdrawals, distributions, and other transactions. In addition to per-use transaction fees, participants with account balances share in the operational expense of the Plan. Investment operating expenses are included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events for disclosure in these financial statements through September 25, 2025, the date the financial statements were available to be issued.

**C. Information Prepared and Certified by the Plan Trustee**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Ascensus Trust Company, the trustee of the Plan, has certified the completeness and accuracy of reported investment balances and related investment activity in these financial statements and supplemental schedule, summarized as follows:

**D. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and the money market funds are valued at the daily closing price as reported by the fund. Mutual funds and the money market funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

**E. Related Party and Party-In-Interest Transactions**

Ascensus LLC (Ascensus), the Plan recordkeeper, and Ascensus Trust Company, Inc., the trustee of the Plan, receive fees for services provided to the Plan. Ascensus also receives fees for loan setup, distribution, and other administrative services. Merrill Lynch provides financial advisory services and receives fees for services. The Company provides the Plan with accounting and administrative services, for which no fees are charged to the Plan. The Plan allows loans to participants. These transactions qualify as party-in-interest transactions.

**F. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100 percent vested in their accounts, and the Company will arrange for distributions as soon as administratively feasible.

**G. Tax Status**

The Internal Revenue Service has determined and reported in its opinion letter dated June 30, 2020, that the form of adopted pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan administrator believes the Plan is currently being operated in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management believes that no uncertain tax positions have been taken or are expected to be taken that would require recognition or disclosure in the financial statements.

**H. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, including interest rate, market, and credit risks. Due to the level of risk associated with such investments, it is at least reasonably possible that changes in the values of Plan investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for benefits.
