To Cascade West Title Company, LLC dba CW Title 401(k) Plan and Participants

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

### **Notes to Financial Statements**

#### **1. DESCRIPTION OF PLAN**

The following description of the Cascade West Title Company, LLC dba CW Title 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering all employees of Cascade West Title Company, LLC dba CW Title (the "Company") who have attained age 18. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees. Effective March 1, 2024, the Plan was amended to recognize prior service for vesting purposes from another employer acquired by the Company during 2024. Effective May 19, 2025, the Plan was amended to recognize prior service for vesting purposes from another employer acquired by the Company subsequent to December 31, 2024.

##### **Contributions**

Eligible participants may elect to have a portion of their compensation contributed to the Plan as either pre-tax 401(k) contributions or as Roth 401(k) contributions on an after tax-basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and a collective investment as investment options for participants. The Plan allows the Company to make discretionary matching contributions and discretionary non-matching contributions. For 2024, the Company matched 50% of the salary deferrals on a payroll by payroll basis up to 3% of compensation deferred. Contributions are subject to certain statutory limitations.

##### **Participant accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of plan earnings and administrative expenses based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service (defined as 1,000 hours per year) as determined by the following vesting schedule: beginning with one year of service, 20% per year until 100% vested after five years of service.

### Notes to Financial Statements (Continued)

#### 1. DESCRIPTION OF PLAN (continued)

##### **Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The Plan limits the number of loans outstanding for each participant to one. The notes are secured by the balance in the participant's account and bear interest at the prime rate in effect on the date the loan is made plus 1%. Interest rates ranged from 4.25% to 9.50% in 2024. Principal and interest is paid ratably through monthly payroll deductions.

##### **Payment of benefits**

On termination of service due to death, disability, retirement or for other reasons, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in the account. A participant may also withdraw all or a portion of an account balance at any time if the participant is at least 59 ½ years old. The Plan also allows for financial hardship withdrawals. The Plan provides that if a participant is terminated and the participant's vested interest in the Plan does not exceed \$5,000, the account balance will automatically roll over to an Individual Retirement Account if not removed from the Plan within a specified amount of time.

##### **Forfeited accounts**

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1 and \$2,216, respectively. Forfeitures of participant balances are used to pay Plan administrative expenses and to reduce future employer contributions. In 2024, employer contributions were reduced by \$19,202 from forfeited nonvested accounts.

#### 2. SUMMARY OF ACCOUNTING POLICIES

##### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**2. SUMMARY OF ACCOUNTING POLICIES** (continued)

**Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Receivables**

Employer contributions receivable and participant contributions receivable are recognized in the period the employee contribution is withheld, are stated net of the allowance for credit losses and represent the amount expected to be collected. The Plan makes estimates of expected credit losses for the allowance for credit losses based upon its historical write-off experience adjusted for current conditions and reasonable and supportable forecasts of future economic conditions. An allowance for credit losses was not deemed necessary as of December 31, 2024 and 2023.

**Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Excess contributions payable**

As of December 31, 2024 and 2023, amounts payable to participants totaling \$17,435 and \$4,057, respectively, for contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction to 2024 and 2023 contributions. The Plan distributed the 2024 and 2023 excess prior to March 15, 2025 and 2024, respectively.

**Payment of benefits**

Benefits are recorded when paid.

##### **Expenses**

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. The Company may choose to pay investment advisory and management fees provided by external service providers from its own assets or Plan assets. Additionally, the Company may elect to pay Plan expenses using forfeitures.

##### **Date of management's review of subsequent events**

Subsequent events were evaluated through August 25, 2025, which is the date the financial statements were available to be issued.

#### **3. CERTIFIED INVESTMENTS**

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, the custodian of the Plan.

#### **4. FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There are no plan assets requiring the use of Level 2 and Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value as of December 31, 2024 and 2023.

##### **Level 1 Fair Value Measurements**

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

**Net Asset Value Measurements**

The Morley Stable Value Fund, held in a collective investment trust by Principal Global Investors Trust Company, invests in a variety of high-quality stable value investment contracts (the performance of which may be predicated on underlying fixed income securities) as well as cash and cash equivalents. The objective of the Morley Stable Value Fund is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile, and liquidity for benefit-responsive plan or participant payments. The Morley Stable Value Fund can be redeemed immediately at the current NAV of shares held. The NAV as reported by the Trustee is used as a practical expedient to estimate fair value, which is based on the fair value of the underlying assets in the trust, less its liabilities. As such, the Morley Stable Value Fund has not been classified in the fair value hierarchy.

**5. RELATED PARTY AND PARTY IN-INTEREST TRANSACTIONS**

Plan investments are managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the custodian as defined by the Plan and qualifies as a party-in-interest. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**7. TAX STATUS**

The Company adopted a Non-Standardized Pre-Approved 401(k) Plan which received an opinion letter from the Internal Revenue Service (IRS) on June 30, 2020. The letter states that the form of the Pre-Approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the Pre-Approved plan document, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan files U.S. Form 5500 Annual Return/Report of Employee Benefit Plan.

**8. RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
