### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Bramco Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, was presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Notes to the Financial Statements

#### 1. Description of the Plan

The following description of the Bramco Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution retirement plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), and became effective November 1, 1975 and was most recently restated effective January 1, 2022. The Plan covers all eligible employees of Bramco, Inc. (the Company, Plan Sponsor, and Plan Administrator) and related affiliates.

##### Eligibility

Employees are eligible to participate in the Plan on their hire date. Eligible participants are automatically enrolled into the Plan unless the participant elects otherwise. At that time, participants can begin deferring compensation into the Plan, and become eligible for both the employer matching and employer nonelective contributions.

##### Contributions

Eligible employees may make pre-tax, Roth, or after-tax contributions from their eligible compensation subject to limits set by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). The Company makes a matching contribution equal to 100% of the first 5% of eligible compensation contributed by a participant. The Company may also make additional contributions at the discretion of the Board of Directors. For the 2024 Plan year, there were no additional Company contributions.

Participants are automatically enrolled in an elective deferral contribution of 5% of compensation, unless the participant affirmatively elects a different percentage or elects not to make an elective deferral contribution. Employees that are automatically enrolled will have their contribution percentage rate annually increased by 1% up to a maximum of 10%, unless the participant elects a different percentage.

##### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution and the Plan Sponsor's contributions and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## BRAMCO RETIREMENT PLAN

### Notes to the Financial Statements, continued

#### 1. Description of the Plan, continued

##### Investment Options

Upon enrollment in the Plan, a participant may direct contributions in any combination of mutual fund and collective trust options provided under the Plan. Participants may also self-direct their investments, through an independent brokerage account, in a variety of securities, including stocks, index funds, mutual funds, and a money market fund. Participants may make changes to their investment selections at any time during the Plan year. The Plan Sponsor's contributions are automatically invested in the same investment options at the same percentage as participant deferral contributions.

##### Vesting

Participants are vested immediately in their contributions, plus actual earnings (losses) thereon and are not subject to forfeiture for any reason. Vesting in the Plan Sponsor's contribution portion of their accounts, plus actual earnings (losses) thereon, is based on years of continuous service. A participant vests 20% per year after the first year of service, and is 100% vested after five years of credited service. If a participant dies or becomes disabled, he or she is automatically 100% vested in all accounts.

##### Participant Loans

Participants may borrow a minimum of \$1,000, up to a maximum of the lesser of \$50,000 or 50% of their vested balance, reduced by the highest outstanding loan balance in the preceding 12 months. The loans are secured by the balance in the participant's account and bear interest at a rate of the prime rate plus 1%, which is commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

##### Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump sum distribution or a direct rollover to another qualified plan equal to the value of the participant's vested account. If a participant has more than \$5,000 in their account upon termination, they may elect to keep their account in the Plan indefinitely. Prior to termination, participants can elect to take a distribution in the event of certain hardships as defined by the Plan. The Plan requires automatic distributions to any terminated participant with a balance of less than \$5,000, and he or she will receive their benefits as a single lump sum payment.

##### Forfeited Accounts

All forfeitures are applied to Plan Sponsor contributions and Plan expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts, totaled \$36,025 and \$40,190, respectively. During 2024, forfeitures totaling \$115,000 were used to reduce the Plan Sponsor's contributions. Forfeited participant balances during 2024 totaled \$105,923.

#### 1. Description of the Plan, continued

##### Risks and Uncertainties

The Plan provides for participant directed investment options in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

#### 2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

##### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

##### Contributions

Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

##### Notes Receivable from Participants

Participant loans are classified as notes receivable from participants and measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based on the terms of the Plan agreement.

##### Payment of Benefits

Benefit payments to participants are recorded upon distribution.

As of December 31, 2024 and 2023, there were no outstanding payments to persons electing to withdraw from the Plan.

#### 2. Summary of Significant Accounting Policies, continued

##### Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid by the Plan as provided in the Plan agreement. All other administrative expenses are paid by the Plan Sponsor.

##### Subsequent Events

The Plan's management has evaluated subsequent events for accounting and disclosure requirements through October 9, 2025, the date that the financial statements were available to be issued.

#### 3. Information Certified or Provided by Bank of America N.A.

The Plan's asset information included in this note and throughout the Plan's financial statements and supplemental schedule was prepared by or derived from information provided by Bank of America N.A., the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Bank of America N.A. that asset information provided to the Plan Administrator by Bank of America N.A. is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditor's not to perform any auditing procedures with respect to asset information in this note and which appears throughout the financial statements and the ERISA-required supplemental schedule.

#### 4. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

*Collective trust fund:* Valued based on the NAV of units of the common collective trust. The NAV, as provided by Bank of America N.A., is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The collective trust fund invests in a stable value fund which includes investment contracts issued by insurance companies, cash equivalents, and separate account investment contracts. Investments in this category can be redeemed immediately upon request. The fair value of investments in this category has been estimated using the NAV of the units of participation in the fund.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3.

#### 5. Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Bank of America N.A. Bank of America N.A. is the trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest. Administrative expenses of \$119,744 for the year ended December 31, 2024 are comprised of fees paid by the Plan to Bank of America N.A. for recordkeeping and other services. The Plan pays additional direct fees to their investment advisor.

Additionally, indirect fees are paid to Bank of America N.A. based on investment account values. These fees range from 0.04% to 0.99% of the investment account value. The fees reduce net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

#### 6. Tax Status

The Plan uses a prototype Plan document sponsored by Bank of America N.A. Bank of America N.A. received an opinion letter from the Internal Revenue Services (IRS), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

#### **7. Plan Termination**

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
