Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of Wells Concrete Products Company Profit Sharing 401(k) and Laborers Union Supplemental Retirement Plan (the Plan) as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

Management has determined it is permissible in the circumstances and has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, as permitted by ERISA Section 103(a)(3)(C), the audit need not extend to any statements of information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis.

We are required to consider relevant Plan provisions that affect the risk of material misstatement at the relevant assertion level when designing and performing audit procedures. When audit work performed results in the identification of items that are not in accordance with specified criteria, such as Plan provisions as set forth in the Plan instrument, we are required as the auditor to evaluate whether the matter is a reportable finding. Reportable findings are matters that are one or more of the following:

- a. An identified instance of noncompliance or suspected noncompliance with laws or regulations.
- b. A finding arising from the audit that is, in the auditor's professional judgment, significant and relevant to those charged with governance regarding their responsibility to oversee the financial reporting process.
- c. An indication of deficiencies in internal control identified during the audit that have not been communicated to management by other parties and that, in the auditor's professional judgment, are of sufficient importance to merit management's attention.

A reportable finding may be a material weakness, a significant deficiency, or a control deficiency defined as follows:

A material weakness is a deficiency, or a combination of deficiencies, in internal control over financial reporting, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented or detected and corrected on a timely basis. A reasonable possibility exists when the likelihood of an event occurring is either reasonably possible or probable as defined as follows:

- *Reasonably possible.* The chance of the future event or events occurring is more than remote but less than likely.
- *Probable.* The future event or events are likely to occur.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control over financial reporting that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.

A control deficiency is a deficiency, or combination of deficiencies, in internal control that does not rise to the level of a material weakness or significant deficiency but is of sufficient importance to merit management's attention.

We consider the following reportable finding in the Plan's internal control to be a significant deficiency:

#### **Financial Reporting Process**

Your financial statements contain complex accounting and reporting matters including many footnote disclosure considerations under generally accepted accounting principles. As auditors, we were requested to draft the financial statements and accompanying footnotes. As such, a more-than-remote likelihood exists that a misstatement of the financial statements could occur absent our involvement in the financial statement preparation process. This circumstance is not unusual in a plan of your size. It is the responsibility of management and those charged with governance to make the decision whether to accept the degree of risk associated with this condition because of cost or other considerations.

We consider the following reportable findings in the Plan's internal control to be control deficiencies:

#### **Application of Forfeitures**

During our audit, we noted that amounts forfeited from participant accounts are not being utilized within the timeframe allowed per the Plan document. Plan provisions outline that disposition of forfeitures shall be made no later than the end of the Plan year following the Plan year during which the forfeiture occurred. If not used properly or within the timeframe allowed, the Plan may not be following the Plan document and potential corrective action may be required. We recommend you work with your third-party administrator to determine the proper method and time to utilize these funds.

#### **Documentation Contained in Personnel Files**

During our testing of participant data, we noted that there was an instance where an employee personnel file did not contain adequate support for the employees' dates of hire and/or did not contain the employee's date of birth. Birth, hire, and termination dates affect eligibility and incorrect dates could result in ineligible participants entering the Plan and violating the Plan document. We recommend that documentation be obtained and maintained in employee files to support Plan operations.

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be considered reportable findings, including material weaknesses, significant deficiencies, or control deficiencies, and, therefore, reportable findings in these categories may exist that were not identified.

This communication is intended solely for the information and use of management, the Investment Committee, and others within the Plan, and is not intended to be, and should not be, used by anyone other than these specified parties.

## Note 1 - Description of Plan

The following brief description of the Wells Concrete Products Company Profit Sharing 401(k) and Laborers Union Supplemental Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution Plan covering substantially all employees of The Wells Companies and its subsidiary, Wells Concrete Products Company (together, the Company or Sponsor) and covering qualified members of the following unions who are employed by the Company:

- North Dakota and Minnesota Laborers Local Union, No. 405 (Local 405)
- Colorado Laborers Union of the Laborers International Union of North America, No. 720 (Local 720)
- Great Lakes Unions (collective group):
  - Wisconsin Laborers District Council Local Union, No. 113
  - Laborers International Union of North America, No. 113
  - International Union of Operating Engineers, No. 139
  - Wisconsin Laborer District Council Laborers, No. 330
  - Construction and General Laborers, No. 330 (Local 330)
  - Teamsters Local Union, No. 662
  - Construction & General Laborers District Council of Chicago and Vicinity Local Union, No. 681

The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

### Eligibility

Employees are eligible to participate in the salary deferral arrangement of the Plan if they have completed three months of service. Under the Local 405 collective bargaining agreement, those union employees are eligible to participate in the non-elective employer contributions if they have completed 12 months of service. Under the Local 720 collective bargaining agreement, those union employees are eligible to participate in the non-elective employer contributions if they have completed three months of service. Under the Great Lakes Unions collective bargaining agreements, those union employees are not eligible to participate in non-elective employer contributions. Non-union employees and employees within other select groups are eligible to participate in the discretionary non-elective employer contributions if they have completed 12 months of service, were an active participant, and employed on the last day of the Plan year. Employees of Gate Precast, acquired by the Company on July 12, 2024, are eligible to participate in discretionary employer match contributions after completing three months of service.

Excluded employees are leased employees, employees covered by a collective bargain agreement outside of the Great Lakes Unions, Local 405 and Local 720 Unions (unless the agreement requires the employees to be included under the Plan), U.S. citizens or U.S. resident aliens outside the U.S., and employees in a division or facility of the Company which is not in existence on January 1, 2022.

## **Entry Date**

Employees may enter the Plan immediately upon satisfying the Plan's eligibility requirements.

## **Contributions**

Each year, participants may contribute up to 75% of their pretax annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Additional amounts may be contributed at the discretion of the Company's Board of Directors to non-union participants and other select groups of participants. Profit sharing and discretionary non-elective employer contributions are allocated to participants based upon the ratio of the participant's eligible compensation, as defined in the Plan document, to the total eligible compensation for all participants. Additional profit sharing and discretionary non-elective employer contributions of \$3,423,031 were contributed for the year ended December 31, 2024.

Union specified employer contributions to the Plan are non-elective and are determined in the collective bargaining agreements between the union and the Company. The employer contribution rate for Local 405 employees was \$0.85 per hour worked as defined in the collective bargaining agreement. The employer contribution rate for Local 720 employees was 6% of eligible compensation.

The Company also contributed a discretionary employer match contribution for 100% of the participant's elective deferrals that do not exceed 3% of eligible compensation, plus 50% of the next 2% of eligible compensation for Gate Precast employees. Gate Precast employees are not eligible for the discretionary non-elective employer contributions.

The Plan includes an auto-enrollment provision, whereby all newly eligible employees, except employees from the Great Lake Unions, are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation. The Plan also includes a step-up feature which automatically increases the deferral percentage by 1% each year until the participant's deferral reaches 10%.

## **Participant Accounts**

Each participant's account is credited with the participant's contributions, employer non-elective contributions, allocations of the Company's discretionary profit sharing and non-elective contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on the participant's compensation, account balances or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## **Investment Options**

Upon enrollment to the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

## **Vesting**

Participants are vested immediately in their contributions, plus actual earnings thereon and matching employer contributions. Vesting in the non-elective employer contribution portion of their accounts is based on years of continuous service. Depending on their union and admission into the Plan, participants can vest between two to six years of credited service.

Participants become 100% vested in employer contributions upon death, disability or retirement.

## **Forfeitures**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$240,851 and \$197,531, respectively. Union forfeitures are reallocated directly to eligible union employee accounts. The remaining forfeitures reduce discretionary non-elective employer contributions or reduce Plan expenses. During the year ended December 31, 2024, forfeitures of \$156,118 were allocated to union employee accounts or reduced discretionary non-elective employer contributions.

## **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The interest rate is set at 1% above the prime rate. Principal and interest is paid ratably through payroll deductions over a period not to exceed five years, unless the proceeds of the loan were used to acquire the participant's residence, in which case the loan term can range up to 10 years. A participant may have no more than two outstanding loans at any one time.

## **Payment of Benefits**

Participants may elect to receive either a lump-sum amount equal to the value of their vested interest, installment payments or partial withdrawals as defined in the Plan document upon retirement, termination of service, death, or disability. A terminated participant with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Effective April 12, 2024, the Plan was amended to increase the mandatory cash-out limit from \$1,000 to \$7,000 as allowed per the SECURE 2.0 Act. Distributions may be made at the participant's election prior to termination upon attainment of age 59½ or normal retirement age, for a hardship or for a qualified reservist distribution, as defined in the Plan document.

## **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

## **Note 2 - Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors, and trustees. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

## Contributions

Participant contributions, the related non-elective employer contributions and the discretionary employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation. Any discretionary non-elective employer contributions are recorded in the year to which they are attributed by the Company.

## Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

## Payments of Benefits

Benefit payments to participants are recorded upon distribution.

## Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

## Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds (including money market mutual funds) – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust fund – Valued at fair value based on the NAV of units held of the collective fund. The NAV, as provided by the trustee is used as a practical expedient to estimate fair value. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

#### Note 4 - Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

#### Note 5 - Tax Status

The Plan uses a pre-approved plan document sponsored by FMR, LLC which received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **Note 6 - Related Party and Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds, money market mutual funds, and a common collective trust fund managed by Fidelity Workplace Services, LLC, an entity served as the recordkeeper for the trustee as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

## **Note 7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **Note 8 - Plan Amendments**

Effective April 12, 2024, the Plan was amended to change the cash out provisions so that any terminated participants with a balance between \$1,000 and \$7,000 are automatically paid out if their balance is rolled into a qualified Individual Retirement Account. The Plan was amended to administratively increase the mandatory cash-out limit as allowed per the SECURE 2.0 Act. The Plan shall be formally amended by the end of December 2026 to adopt the provisions.

Effective July 12, 2024, the Plan was amended and restated to include Gate Precast as a predecessor employer and recognize predecessor service for purposes of eligibility and vesting. The Plan was also amended to include discretionary match employer contributions for former Gate Precast employees acquired by the Company on July 15, 2024, for which these employees will be eligible after three months of service and will be 100% vested immediately. The Company contributed 100% of the participant's elective deferrals that did not exceed 3% of eligible compensation, plus 50% of the participant's elective deferrals that exceeded 3% of eligible compensation but did not exceed 5% of eligible compensation. Gate Precast employees were not eligible for the discretionary non-elective employer contributions.

## **Note 9 - Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The amount of excess contributions was \$83,626 and \$0 as of December 31, 2024 and 2023, respectively.

**Note 11 - Subsequent Events**

Effective January 1, 2025, the Plan has been amended to update the eligible participants from Group 1 for participating in employer contributions where non-union employees except for Gate Precast employees have been removed and non-union employees except for Gate Union and Gate Hourly Production employees are included.

Effective January 1, 2025, the catch-up contribution limits for employees who attain age 60-63 in a given calendar year would be increased. The Plan was auto defaulted into this provision by Fidelity, and the Plan did not opt out of it. This was administratively adopted by the Plan.

The Plan sponsor has evaluated subsequent events through October 9, 2025, the date which the financial statements were available to be issued.
