Note 1: Description of the Plan

The following description of the Shepherd Center 403(b) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more comprehensive description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Shepherd Center, Inc. (the Employer or Plan Sponsor) other than employees participating in another 403(b) plan or another qualified cash or deferred arrangement, an employee who is a non-resident alien, or an employee who is a student performing services and those not normally working more than 20 hours per week. Employees are eligible to participate in the Plan immediately for purposes of making salary deferral contributions. For purposes of receiving an employer contribution, employees must have completed one year of service.

State Street Bank and Trust Company serves as Trustee of the Plan and Custodian of all Plan assets other than the Stable Value Fund, whose custody is held by Transamerica Financial Life Insurance Company. An administrative committee manages the Plan's operations.

Administration

The Employer serves as the plan administrator. The plan administrator has the responsibility to administer the Plan for the exclusive benefit of the participants and their beneficiaries. These duties include, but are not limited to, establishing procedures, maintaining records, interpreting provisions of the Plan and making determinations regarding questions which may affect eligibility for benefits. The plan administrator has engaged Transamerica Retirement Solutions Corporation (TRSC) as a third-party administrator to assist in the administration of the Plan.

The Trustee is responsible for the administration of investments for the benefit of the participants and their beneficiaries. The Trustee receives all contributions made under the Plan, holds plan assets, pays benefits as directed by the plan administrator, and assists in the administration of the Plan. TRSC serves as the intermediary for all asset purchases and redemptions and manages certain investment options of the Plan.

Contributions

A participant may make an elective deferral of up to 80% of their compensation to the Plan subject to limitations under the Internal Revenue Code (IRC). The Employer matches a portion of participant contributions. The Employer matches contributions according to the following schedule:

Full Years of Service	Percentage
1-4	25%
5-9	35%
10+	50%

Employees may deposit rollover contributions from another qualified plan.

Administrative Expenses

The Plan is liable for all administrative expenses which are not paid by the Employer. The Plan generally pays for all asset management, administrative, and transactional costs billed by the third-party administrator. The Employer pays for trustee, legal, and accounting fees on behalf of the Plan.

Participant Accounts

Each participant's account is credited with the pretax and rollover contributions made by the participant, any employer matching contribution, and the Plan's earnings or losses. Earnings, expenses, and gains and losses on investments are allocated based on account balances as defined by the plan agreement.

Vesting

A participant's contributions are 100% vested. Vesting in the Employer's matching contributions and earnings thereon, is based on years of service since the Plan's inception. A participant is 100% vested after three years of service.

Investment Options

Participants may direct their own contributions and the Employer contributions into any of the investment funds provided by the Plan. Participants are allowed to change their investment options daily.

Notes Receivable from Participants and Withdrawals

Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Participant loans are subject to specific rules provided in the plan agreement. Loans are secured by the participant's account balance and are payable in equal payments based on the participant's pay frequency over a period not to exceed five years. A loan used for financing the purchase of the participant's primary residence may be repaid over a period exceeding five years as determined on an individual basis, up to ten years. Should a participant default on a plan loan, as defined by the Plan loan policy, the loan would then be considered a distribution. Interest is charged on loans ranging from Prime Rate (7.50% at December 31, 2024) to Prime Rate plus 1%. Loan repayments are immediately reinvested in the individual participant's funds.

In general, a participant may withdraw up to 100% of the participant's pretax and rollover contributions in the event of a participant's heavy and immediate financial hardship, as defined in the plan agreement. Hardship distributions may not exceed the amount of the participant's financial hardship and may not be repaid by the participant.

In-service withdrawals of all or a portion of a participant's vested account balance, other than participant rollover, employer matching and profit sharing accounts, may be made by a participant after reaching age 59 ½.

Participants withdrawing from the Plan due to termination of employment with the Plan Sponsor, other than due to retirement (age 65), death, or disability, may receive the value of their vested account by transfer to another qualified plan, or individual retirement account, or through a lump sum distribution. In general, if the participant's account balance, as defined in the plan agreement, is greater than the involuntary cash-out amount, the account may not be distributed without the participant's consent. However, regardless of the participant's election as to the payment, the Plan may, upon termination of service of a participant for any reason, pay the benefits owed in a lump sum if the account balance is less than the involuntary cash-out amount.

Distributions from the Plan will normally be subject to income taxes and in certain circumstances may also be subject to IRC penalties, unless the distribution is transferred to another qualified plan or individual retirement account.

Forfeitures

Nonvested account balances of terminated employees are forfeited upon the complete distribution of the vested portion of their account, subject to the possibility of reinstatement before the end of five consecutive years of breaks in service, as defined in the plan agreement. Forfeitures of terminated employees' nonvested accounts will be used to reduce administrative expenses and Plan Sponsor matching contributions, as defined in the plan agreement. During 2024, the Company utilized \$250,827 of forfeitures to reduce administrative expenses and Plan Sponsor matching contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$64,788 and \$266,594, respectively.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates in Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect assets, liabilities, and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of the components of changes in net assets during the reporting period. Accordingly, actual results may differ from those estimates.

Benefit Payments

Benefit payments to participants are recorded upon distribution.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value (Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 4).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments represents the change in fair value during the year, including realized and unrealized gains and losses.

Risk and Uncertainties

The Plan invests in various mutual funds and a stable value fund. Investment securities are exposed to various risks such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits and statement of changes in net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Note 3: Information Certified by the Trustee and Custodians (Unaudited)

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the amounts for investment assets and transactions in those assets included in the accompanying financial statements and supplemental schedules and as outlined below as of December 31, 2024 and 2023 and for the year ended December 31, 2024 have been compiled from statements certified as complete and accurate by the Trustee and Custodians in accordance with DOL regulations.

Note 4: Fair Value Measurements

The accounting standards for fair value measurements provide a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

- Level 1: Quoted prices for identical instruments in active markets at the measurement date. Investments that are listed on a United States securities exchange are valued at their last sales price on the largest United States securities exchange on which such securities have traded.
- Level 2: Quoted prices for similar instruments in active markets; quoted prices for identical or similar instruments in markets that are not active and model-derived valuation in which all significant inputs and significant value drivers are observable in active markets at the date and for the anticipated term of the instrument.
- Level 3: Valuation derived from valuation techniques in which one or more significant inputs or significant value drivers are unobservable inputs that reflect the reporting entity's own assumptions about the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds are valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

During the years ended December 31, 2024 and 2023, there were no transfers of assets between Level 1, Level 2 and Level 3.

Note 5: Fully Benefit-Responsive Investment Contract

The Plan has entered into a traditional investment contract through a group annuity contract with the Custodian. The traditional investment contract held by the Plan is a guaranteed investment contract which meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to execute permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus interest credited under the terms of the contract, less participant withdrawals and administrative expenses. The Custodian maintains contributions in a general account secured by the general assets of the Custodian. Interest rates are declared quarterly for new deposits received during the quarter and are guaranteed for the balance of the calendar year. Renewal rates are declared annually on a calendar year basis for existing assets. Both principal and interest are guaranteed. Certain events such as plan termination or a plan merger initiated by the Plan Sponsor, may limit the ability of the Plan to transact at contract value. The Plan Sponsor does not believe that any events that may limit the ability of the Plan to transact at contract value are probable of occurring.

Note 6: Party-in-Interest Transactions

The Plan's Trustee, Custodians and its affiliates perform services for, sell products to, and maintain certain investments for the Plan for which fees are charged to the Plan. Party-in-interest transactions also include loans made to participants. Such transactions, while considered party-in-interest transactions under ERISA, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 7: Income Tax Status

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71. The plan administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 8: Reconciliation to Form 5500

The financial information of the Plan, as reported on Form 5500, does not include all amounts necessary for reporting on the accrual basis of accounting. A reconciliation of the amounts appearing on the 2024 Form 5500 to the accompanying financial statements follows:

Note 9: Plan Termination

While it is the Employer's intention to continue the Plan indefinitely, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA and the plan agreement, as amended. In the event of Plan termination, no contributions would be made to the Plan and the participants would become 100% vested in their accounts.

Note 10: Excess Contributions Payable

During 2024 and 2023, the Plan was not in compliance with IRC Section 403(b). As a result, excess contributions totaling \$482 and \$10,024 were payable to certain participants as of December 31, 2024 and 2023, respectively. Such amounts were deducted from participant contributions in the accompanying statement of changes in net assets available for benefits and are included in excess contributions payable in the accompanying statements of net assets available for benefits.

Note 11: Subsequent Events

The Plan Sponsor has evaluated events and transactions occurring subsequent to December 31, 2024 through the date of the report, the date the financial statements were available for issuance. Management has concluded that all subsequent events requiring recognition or disclosure have been incorporated into these financial statements herein.
