As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Description of plan

The following description of the Caffe Nero Americas 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Caffe Nero Americas, Inc. (the "Company") who have three months of service and are age twenty-one or older. The Plan will exclude union and leased employees as well as nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The trustee is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's trustee.

Contributions

Each year, participants may contribute up to 100% of their annual pretax compensation, as defined by the Plan. Participants may designate all or a portion of their contributions as Roth deferral contributions. Participants who attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% pre-tax of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company may contribute a discretionary matching or profit-sharing contribution. During the year ended December 31, 2024, the Company elected to contribute a matching contribution equal to 8.77% of first 8% of eligible compensation that a participant contributes to the Plan. The Company may also contribute a discretionary profit-sharing contribution, however, during the year ended December 31, 2024, no additional profit-sharing contribution was elected. Participants also direct the investment of Company contributions. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's discretionary matching and profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus their actual earnings. In the event of termination due to death or total and permanent disability, participants shall become 100% vested in the Company's discretionary matching and profit-sharing contribution portion of their account. For all other participants, the schedule below determines the vesting percentage for employer contributions:

<u>Years of service</u>	<u>Vested percentage</u>
Less than one year	0%
1 year but less than 2 years	20%
2 year but less than 3 years	40%
3 year but less than 4 years	60%
4 year but less than 5 years	80%
5 or more	100%

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$500, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participants account. The loan interest rate is equal to the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

Payment of benefits

Upon termination for any reason, a participant may receive a lump-sum amount equal to the vested value of the participant's interest in his or her account. Participants with a vested account balance less than \$1,000 will receive a mandatory lump-sum distribution. For terminated participants with a vested account balance greater than \$1,000 but less than \$7,000, the Plan administrator will make a direct rollover of the participant's account to an individual retirement account designated by the Plan administrator. Participants with a vested account balance greater than \$7,000 may elect to receive their benefit either as a lumpsum or installment payments, or defer payment of benefits until a later date.

Withdrawals from a participant's vested account balances may also be made in the event of a financial hardship or upon reaching age 59½ and are currently employed by the Company, in accordance with the provisions specified by the Plan.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$11,881 and \$11,732, respectively. These accounts will be used to reduce future employer contributions or pay Plan expenses. In 2024, from forfeited nonvested accounts \$10,000 was used to reduce employer contributions and \$203 was used to pay Plan expenses.

Note 2 - Summary of accounting policies

Basis of accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investments held by a defined contribution plan are required to be reported at fair value except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Contributions

The Contributions from Plan participant and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the U.S.GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

Payments of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in the net appreciation of fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") issued Accounting Standards Codification ("ASC") 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation of other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued using the net unit value, which is based on the fair value of the underlying assets of the account, as provided by the trustee. The net unit value is equivalent to the net asset value ("NAV"). The underlying investments of the pooled separate accounts are mutual funds and investment trusts.

The methods described above may produce fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

The Plan's investments at fair value as of December 31, 2024 and 2023 are made up of pooled separate accounts, which are measured at NAV as a practical expedient. In accordance with Subtopic 820-10, the pooled separate accounts have not been classified in the fair value hierarchy as they are measured at net unit value.

Note 4 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 5 - Tax status

The Plan has been designed using a volume submitter plan document designed by CCH Incorporated dba Fort William Companies. In an opinion letter dated June 30, 2020, the IRS stated that the volume submitter plan satisfies the applicable requirements of the Internal Revenue Code (the "IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Related party transactions and party-in-interest transactions

Certain Plan investments are proprietary investments managed by affiliates of Transamerica Life Insurance Company, Inc and Reliance Trust Company. Transamerica Life Insurance Company, Inc. and Reliance Trust Company are the recordkeeper and custodian, respectively, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Administrative expenses paid directly out of Plan assets to Transamerica Life Insurance Company, Inc. amounted to \$96,745 for the year ended December 31, 2023. The Plan allows participants to take loans against their account balances, which are also considered party-in-interest transactions. The Company pays directly any other fees related to the Plan's operations.

At December 31, 2024 and 2023, the Plan's revenue sharing account totaled \$1,355 and \$927, respectively. This account is used to pay Plan expenses and any excess amounts are re-allocated to participants' accounts. The Plan received revenue sharing credits from Capital Bank and Trust Company in the amount of \$14,182 for the year ended December 31, 2024, which has been included as part of the net appreciation in fair value of investments in the accompanying financial statements. The Plan utilized \$14,478 from the revenue sharing account to offset Plan related fees during the year ended December 31, 2024.

Note 7 - Fully benefit-responsive investment contract

The Plan has entered into a traditional investment contract with Transamerica Life Insurance Company, Inc. ("Transamerica"), via an investment in the Transamerica Stable Value Fund. The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The balance in the traditional investment contract as of December 31, 2024 and 2023 was \$14,762 and \$14,039, respectively.

The contract issuers are contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting interest rates are based on formulas agreed upon with the issuer which are reviewed periodically for resetting in accordance with the terms of the contracts, but may not be less than 0%.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuers. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contracts.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuers to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuers.

The contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity dates.

Note 8 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

Note 9 - Risks and uncertainties

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 10 - Compliance related matter

The Company has determined that during 2024 certain participants that earned eligible compensation was improperly excluded from deferral calculations. The Company has assessed the impact to the participants, estimating a correction of \$5,455, which has been included in employer contributions receivable as of December 31, 2024. The Company intends to finalize the calculation and remit corrective funding in 2025.
