Report on the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Pineapple Energy Inc. Employee Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

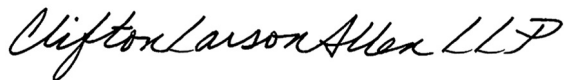

NOTE 1 DESCRIPTION OF PLAN

The following description of Pineapple Energy Inc. Employee Savings Plan, (the Plan) provides general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective July 1, 1984. The Plan has been amended throughout the years to comply with tax legislation. The Plan was last restated effective January 1, 2022 and last amended effective December 1, 2023. The Plan covers substantially all employees of Pineapple Energy Inc. (the Employer) and excludes employees covered by collective bargaining agreement, leased employees, nonresident aliens who have no earned income from sources within the United States, and reclassified employees. Effective October 1, 2023, employees of SUNation Solar Systems, Inc. who became employees of the Employer in connection with the SUNation Solar Systems, Inc. purchase agreement, became eligible employees for plan purposes. Employees are eligible to participate in the Plan after the completion of 250 hours of service within the three-month period following the date of employment and attainment of age 18. If 250 hours of service are not completed within the first three months of employment, the employee can become eligible after a year of service (as defined by the Plan). An eligible employee will begin participation in the Plan on the date of completing the eligibility requirements. The Plan is subject to ERISA. The Audit Committee is responsible for the oversight of the Plan. The Fiduciary Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Audit Committee.

Subsequent to year end, the Plan was amended on February 14, 2025 to change the Plan name to SUNation Energy, Inc. Employee Savings Plan.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, up to 60% of eligible compensation, contributed as pre-tax 401(k) or Roth contributions to the Plan. The Plan has an automatic enrollment feature whereby the Plan administrator will automatically withhold 6% as a pre-tax 401(k) contribution, unless otherwise elected by the participant. The Plan includes an automatic increase feature of 2% each year up to 10%. Participants age 50 or older are allowed to make catch-up contributions.

The Employer may make a discretionary matching and nonelective contribution to the Plan. For the years ended December 31, 2024 and 2023, the Employer authorized a matching contribution of 50% of the employee's deferral up to 6% of eligible compensation deferred. Participants must complete 1,000 hours of service and be employed on the last day of the Plan year to share in Employer nonelective discretionary contribution, unless termination is due to death, disability, or retirement. There were no discretionary nonelective contributions authorized for the years ended December 31, 2024 and 2023.

Contributions (Continued)

Participants direct the investment of contributions into various investment options offered by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans or conduit IRA's. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, an allocation of the Employer's discretionary matching and nonelective contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's discretionary matching and nonelective contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service using a graded vesting schedule. A participant is 100% vested after the completion of five years of credited service. Effective January 1, 2023, participants are immediately 100% vested in the Employer's discretionary matching and nonelective contributions made after January 1, 2023. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes are repaid ratably through payroll deductions. The notes are secured by the balance in the participant's account and bear interest at a rate equal to *The Wall Street Journal* prime rate plus 1%.

Forfeited Accounts

Forfeitures of nonvested Employer contribution accounts are used to pay plan expenses, allocated as an additional Employer contribution, or used to reduce future Employer contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$43,162 and \$2,164, respectively. There were \$190 and \$-0- of forfeitures used to pay administrative expenses during the years ended December 31, 2024 and 2023. There were \$24,617 and \$14,351 of forfeitures used to reduce Employer contributions for the years ended December 31, 2024 and 2023, respectively. There were no forfeitures allocated as an additional Employer contribution during the years ended December 31, 2024 and 2023.

Benefit Payments

Upon termination of service, death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution or installments. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If a participant terminates employment and the participant's account is between \$1,000 and \$5,000, the Plan administrator will authorize the benefit payment to be rolled into an IRA without the participant's consent. The Plan also allows for in-service distributions if a participant reaches age 59½ and hardship distributions, subject to Plan provisions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities. Estimates also affect the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Fiduciary Committee determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Certain fees related to the administration of benefits paid, notes receivable from participants, participant accounting, and investment advisory fees are charged directly to the participant's account and are included in the administrative expenses. Investment related expenses and any revenue sharing credits are included in the net appreciation (depreciation) of fair value of investments.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Matrix Trust Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of the notes receivable from participants and related interest income and the investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Fund: Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants will become 100% vested in their accounts.

During the year ended December 31, 2023, the Plan Sponsor terminated employees due to the sale of JDL Technologies and Ecessa Corporation. These terminations caused a partial termination of the Plan. As a result of this partial termination, all affected employees became fully vested in their accounts as of the date on which the employees were terminated.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter received from the IRS on the volume submitter plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

The Plan investments are managed by Matrix Trust Company and Milliman, Inc. Matrix Trust Company is the qualified institution and Milliman, Inc. provides third-party recordkeeping services to the Plan. Therefore, transactions with these parties qualify as party-in-interest.

NOTE 9 PLAN MERGER

The Employer's Board of Directors resolved to merge the SUNation Energy 401(k) Plan into the Pineapple Energy Inc. Employee Savings Plan effective December 1, 2023. Total assets in the amount of \$3,837,369 transferred into the Plan on December 1, 2023. Total assets in the amount of \$38,486 transferred into the Plan in 2024.

NOTE 10 NONEXEMPT TRANSACTIONS

During 2023, Pineapple Energy Inc. failed to remit employee contributions and loan repayments for certain participants within the timeframe prescribed by the Department of Labor in prior sponsored 401(k) Plans. These are deemed prohibited transactions in accordance with ERISA and the IRC under this Plan. The Plan sponsor is working to fully correct these transactions in 2025.
