1. Description of Plan

The following description of The Olympia Companies, LLC 401(k) Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is sponsored by The Olympia Companies LLC (the Company).

General

The Plan is a tax-exempt defined contribution plan covering substantially all employees of the Company. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participants should refer to the Summary Plan Description previously provided to them for a description of vesting and benefit provisions. All contributions to the Plan are participant-directed.

Contributions

Each year, participants may contribute up to 90% of pre- and/or after-tax annual compensation, as defined, to the Plan, subject to certain Internal Revenue Code (IRC) limitations. In addition, participant contributions may consist of rollovers from other qualified retirement plans. Participants are vested immediately in their contributions.

The Company may also make discretionary matching contributions to the Plan. Any such discretionary contributions will be allocated based on compensation to the Plan participants. The Company made a discretionary matching contribution for the year ended December 31, 2024, net of \$111,131 in forfeitures applied. Matching contributions vest using a six-year schedule. These contributions vest at a rate of 20% for each year after attaining two full years of service.

Distributions

No amounts may be distributed to participants from their accounts prior to their termination of employment or their attainment of age 59½ unless the participant has incurred a hardship, as defined in the Plan document.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Repayment terms range from 1-5 years or 1-30 years when the proceeds are used for the purchase of a primary residence. The notes are secured by the balance of the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Administrative Expenses of the Plan

The Plan allows for payment of any expenses incurred in administering the Plan to be paid by either the Company or the Plan. Distribution and loan fees are charged directly against applicable participants' account balances.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities, at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Subsequent Events

Management has considered transactions or events occurring through October 2, 2025, for disclosure in the financial statements, which is the date that the financial statements were available to be issued.

3. Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

Mutual funds: Valued at the quoted market price of shares held by the Plan at year-end.

Common/collective trust: Valued using the market approach based on the net asset value (NAV) of the units held by the Plan at year-end. The NAV is provided by the trustee and is used as a practical expedient to estimate fair value. No redemption notice is required prior to withdrawal of funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Parties-in-Interest

Reliance Trust Company, as the trustee of the Plan and ADP Retirement Services (ADP), as the Plan's recordkeeper, conduct certain loan and investment transactions in accordance with the instructions of the plan administrator. In addition, certain distributions of Plan assets are in the form of loans to the Plan's participants. These loans and investment transactions are considered party-in-interest transactions. Recordkeeping expenses paid to ADP by the Plan were \$37,870 for the year ended December 31, 2024.

Voya Financial Partners, Inc. (Voya) and Cetera Advisor Networks LLC (Cetera) serve as investment advisors to the Plan and therefore qualify as parties-in-interest. Third-party recordkeeping, trustee, and investment advisory expenses paid to Voya and Cetera by the Plan were \$38,403 for the year ended December 31, 2024.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Income Tax Status

The Company has adopted an ADP non-standardized pre-approved profit sharing plan which received a favorable opinion letter dated October 6, 2020, from the Internal Revenue Service stating that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
