NOTES TO FINANCIAL STATEMENTS

1. PLAN DESCRIPTION:

The following description of the Woods Rogers Vandeventer Black PLC Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General:

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan substantially all employees and partners of Woods Rogers Vandeventer Black PLC (“The Company”).

The Company’s Board of Directors oversees governance of the Plan. A Plan committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Board of Directors.

Investment options:

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers mutual funds (i.e. registered investment companies) and stable and large cap value funds (i.e. common collective trusts) as investment options for participants. In addition, participants may utilize an individual self-directed brokerage option, through which participants are able to invest in a variety of securities including stocks, bonds, mutual funds, money market funds, closed end funds, exchange traded funds, bank deposit accounts, unitized trusts, and government securities in accordance with the Plan’s investment policy.

Contributions:

Plan participants may elect to defer up to 80% of their eligible compensation, not to exceed the allowable amount under Section 402(g) of the Internal Revenue Code (“IRC”). Participant contributions are made through automatic payroll deductions every pay period. These contributions are not federally taxable to the participant until they are withdrawn from the Plan.

The Plan also has a Roth feature. Contributions are made from after-tax compensation. Participants will not be taxed on future distributions of their contributions and related earnings if certain requirements are met.

1. PLAN DESCRIPTION – (Continued):

Contributions – (Continued):

The Company may make discretionary matching and profit sharing contributions. For the year ended December 31, 2024, the Company made a discretionary matching contribution totaling \$1,145,497 which represented the lesser of 50% of the participants' contributions or 4% of participants' eligible compensation. The Company also made a profit sharing contribution of \$2,576,906 for the year ended December 31, 2024. The allocation method for profit sharing contributions is a compensation ratio basis, with permitted disparity.

Participants who were members of a former employer's qualified plan may elect to make rollover contributions from that plan to the Plan.

Participant accounts:

Each participant's account is credited with the participant's contributions, the employer's contributions, and an allocation of Plan earnings, and charged with applicable administrative expenses paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's employer matching and profit-sharing contributions, plus actual earnings are based on years of continuous service. A participant is 100% vested after six years of credited service.

Participant notes receivable:

Participants may borrow from their account a minimum of \$1,000, up to a maximum of \$50,000, or 50% of their vested account balance. The term of a loan cannot be longer than five years except for certain housing loans which may have a loan term of up to 10 years. Loans are secured by the balance in the participant's account and bear interest at rates of 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of benefits:

Upon termination of service, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants may also rollover all or part of their vested interest to an eligible retirement plan.

Prior to terminating service, a participant under certain hardship conditions and with the approval of the Plan Administrator, may elect to receive a distribution equal to the lesser of their vested account balance or the amount needed to satisfy the hardship.

In-service withdrawals of vested balances may be elected by participants who have reached 59.5 years of age.

1. PLAN DESCRIPTION – (Continued):

Forfeited accounts:

Forfeited amounts are available to pay Plan administrative expenses or reduce employer contributions. Forfeited non-vested accounts totaled \$98,832 and \$132,315 as of December 31, 2024 and 2023, respectfully. During the year ended December 31, 2024, a total of \$88,296 was used to pay Plan administrative expenses.

Administrative costs:

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net depreciation/appreciation in fair value of investments. Expenses related to specific participant transactions (participant notes receivable, benefits paid, and advisory services) are charged directly to the participant's account.

2. SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting:

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Valuation of investments and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. SIGNIFICANT ACCOUNTING POLICIES – (Continued):

Participant notes receivable:

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Benefit payments:

Benefits are recorded when paid.

3. FAIR VALUE MEASUREMENTS:

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

Level 1 - The fair values of mutual funds, exchange traded funds, common and preferred stocks, and publicly traded partnerships (included within registered investment companies and self-directed brokerage accounts) are based on quoted net asset values (“NAV”) of the shares held by the Plan at year end.

Level 2 – The common collective trusts are valued at the NAV of the units held by the Plan. The NAV is based upon the value of the underlying investments which are traded on an active market.

4. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan. Plan participants may direct their investments into funds issued and managed by the Plan trustee. Investments in funds issued by the trustee are considered related party transactions. Fees paid by the Plan for trustee and administrative and investment advisory services amounted to \$185,470 for December 31, 2024.

5. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. INCOME TAX STATUS:

The Company has adopted a volume submitter plan sponsored by Fidelity. The Internal Revenue Service has determined and informed Fidelity by a letter dated June 30, 2020 that the volume submitter plan and related trust are designed in accordance with applicable sections of the IRC. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate income tax positions taken by the Plan and recognize an income tax liability (or asset) if the Plan has taken an uncertain income tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the income tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain income tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by income tax authorities; however, there are currently no audits for any income tax periods in progress.

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

1. PLAN DESCRIPTION:

The following description of the Woods Rogers Vandeventer Black PLC Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General:

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan substantially all employees and partners of Woods Rogers Vandeventer Black PLC (“The Company”).

The Company’s Board of Directors oversees governance of the Plan. A Plan committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Board of Directors.

Investment options:

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers mutual funds (i.e. registered investment companies) and stable and large cap value funds (i.e. common collective trusts) as investment options for participants. In addition, participants may utilize an individual self-directed brokerage option, through which participants are able to invest in a variety of securities including stocks, bonds, mutual funds, money market funds, closed end funds, exchange traded funds, bank deposit accounts, unitized trusts, and government securities in accordance with the Plan’s investment policy.

Contributions:

Plan participants may elect to defer up to 80% of their eligible compensation, not to exceed the allowable amount under Section 402(g) of the Internal Revenue Code (“IRC”). Participant contributions are made through automatic payroll deductions every pay period. These contributions are not federally taxable to the participant until they are withdrawn from the Plan.

The Plan also has a Roth feature. Contributions are made from after-tax compensation. Participants will not be taxed on future distributions of their contributions and related earnings if certain requirements are met.

1. PLAN DESCRIPTION – (Continued):

Contributions – (Continued):

The Company may make discretionary matching and profit sharing contributions. For the year ended December 31, 2024, the Company made a discretionary matching contribution totaling \$1,145,497 which represented the lesser of 50% of the participants' contributions or 4% of participants' eligible compensation. The Company also made a profit sharing contribution of \$2,576,906 for the year ended December 31, 2024. The allocation method for profit sharing contributions is a compensation ratio basis, with permitted disparity.

Participants who were members of a former employer's qualified plan may elect to make rollover contributions from that plan to the Plan.

Participant accounts:

Each participant's account is credited with the participant's contributions, the employer's contributions, and an allocation of Plan earnings, and charged with applicable administrative expenses paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's employer matching and profit-sharing contributions, plus actual earnings are based on years of continuous service. A participant is 100% vested after six years of credited service.

Participant notes receivable:

Participants may borrow from their account a minimum of \$1,000, up to a maximum of \$50,000, or 50% of their vested account balance. The term of a loan cannot be longer than five years except for certain housing loans which may have a loan term of up to 10 years. Loans are secured by the balance in the participant's account and bear interest at rates of 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of benefits:

Upon termination of service, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants may also rollover all or part of their vested interest to an eligible retirement plan.

Prior to terminating service, a participant under certain hardship conditions and with the approval of the Plan Administrator, may elect to receive a distribution equal to the lesser of their vested account balance or the amount needed to satisfy the hardship.

In-service withdrawals of vested balances may be elected by participants who have reached 59.5 years of age.

1. PLAN DESCRIPTION – (Continued):

Forfeited accounts:

Forfeited amounts are available to pay Plan administrative expenses or reduce employer contributions. Forfeited non-vested accounts totaled \$98,832 and \$132,315 as of December 31, 2024 and 2023, respectfully. During the year ended December 31, 2024, a total of \$88,296 was used to pay Plan administrative expenses.

Administrative costs:

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net depreciation/appreciation in fair value of investments. Expenses related to specific participant transactions (participant notes receivable, benefits paid, and advisory services) are charged directly to the participant's account.

2. SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting:

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Valuation of investments and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. SIGNIFICANT ACCOUNTING POLICIES – (Continued):

Participant notes receivable:

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Benefit payments:

Benefits are recorded when paid.

3. FAIR VALUE MEASUREMENTS:

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

Level 1 - The fair values of mutual funds, exchange traded funds, common and preferred stocks, and publicly traded partnerships (included within registered investment companies and self-directed brokerage accounts) are based on quoted net asset values (“NAV”) of the shares held by the Plan at year end.

Level 2 – The common collective trusts are valued at the NAV of the units held by the Plan. The NAV is based upon the value of the underlying investments which are traded on an active market.

4. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan. Plan participants may direct their investments into funds issued and managed by the Plan trustee. Investments in funds issued by the trustee are considered related party transactions. Fees paid by the Plan for trustee and administrative and investment advisory services amounted to \$185,470 for December 31, 2024.

5. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. INCOME TAX STATUS:

The Company has adopted a volume submitter plan sponsored by Fidelity. The Internal Revenue Service has determined and informed Fidelity by a letter dated June 30, 2020 that the volume submitter plan and related trust are designed in accordance with applicable sections of the IRC. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate income tax positions taken by the Plan and recognize an income tax liability (or asset) if the Plan has taken an uncertain income tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the income tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain income tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by income tax authorities; however, there are currently no audits for any income tax periods in progress.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
