1. **Description of the Plan** The following description of the Sayres and Associates LLC 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Sayres and Associates LLC (the "Company") who are at least 21 years old, except for nonresident aliens. The Plan is subject to the provisions of the Employee Retirement and Income Security Act of 1974 ("ERISA").

**Contributions:** Each year, participants may contribute from one percent up to 90 percent of pretax annual compensation, as defined in the Plan. Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Any existing and newly eligible employee who has not affirmatively elected to contribute to the Plan or has not affirmatively declined to participate in the Plan will be automatically enrolled in the Plan with a three percent withholding of pretax annual compensation. The Plan allows for discretionary matching contributions. During 2024, the Company contributed 25 percent of the first ten percent of compensation that a participant contributed to the Plan. Profit sharing amounts may be contributed at the discretion of the Company. Participants must complete at least 1,000 hours of service during the Plan year and be employed on the last day of the Plan year to receive an allocation of any discretionary profit sharing contribution. There were no such contributions for the Plan year ended December 31, 2024. The Plan allows prevailing wage contributions on behalf of each participant who performs services subject to the Service Contract Act or similar federal, state or municipal prevailing wage statutes. The Company will make a prevailing wage contribution in an amount equal to the balance of the fringe benefit payment for each eligible participant based on the employment classification as designated on the appropriate prevailing wage determination reduced by the amount of benefits provided by the Company. There were no such contributions for the Plan year ended December 31, 2024. Participants direct the investment of their contribution and Company contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

**Participant accounts:** Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions, if any, allocations of the Company's discretionary profit sharing contribution, if any, prevailing wage contributions, as applicable, and Plan earnings and losses. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. Allocations of the Company's discretionary profit sharing contributions, if any, are based on the ratio of the participant's eligible compensation to total eligible compensation for the Plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are vested immediately in their contributions and Company prevailing wage contributions, as applicable, plus actual earnings thereon. Participants that have completed one hour of service on or after November 1, 2019 are also immediately vested in any discretionary Company matching and profit sharing contributions, plus actual earnings thereon. Vesting in the discretionary Company matching and profit sharing contributions for participants that have not completed an hour of service on or after November 1, 2019 is based on years of continuous service of at least 1,000 hours per year. These participants are 25 percent vested after one year of service is completed, and vest an additional 25 percent per year until full vesting after four years.

**Forfeited accounts:** At December 31, 2024 and 2023, there were no forfeited nonvested accounts. These accounts will be used to pay Plan expenses or to reduce future Company contributions. During 2024, \$4,232 of forfeited accounts was used to reduce Company contributions and none were used to pay Plan expenses.

**Payment of benefits:** Benefits are payable upon retirement at age 65, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time. Benefits are payable in lump sum and installment payments.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to thirty years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate based on geographic locale. Principal and interest are paid through payroll deductions.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as loan administration fees, are charged directly to the participant's account and are included in administrative expenses.

### 2. Significant accounting policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Investment valuation and income recognition:** Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

**Contributions:** Participant contributions and the related Company discretionary matching contributions are recognized in the period the participant contribution is withheld from compensation. Company discretionary profit sharing contributions are recognized in the period the related eligible compensation is paid to the participant. Company prevailing wage contributions are recognized in the period the related hours are earned.

**Payment of benefits:** Benefits are recorded when paid.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Subsequent events:** The Plan has evaluated subsequent events for disclosure in these financial statements through October 8, 2025, which is the date the financial statements were available to be issued.

- 3. Certified information** Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by American United Life Insurance Company, the insurance company of the Plan.
- 4. Fair value measurements** Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of the units of pooled separate accounts is based on the net asset value (“NAV”) on the last business day of the Plan year provided by the entity holding the accounts. The NAV is used as a practical expedient to estimate fair value and is determined by the insurance company based on the fair value of the underlying assets in the account, less the liabilities.

All investments of the Plan are measured using net asset value as practical expedient to estimate fair value and therefore, are not subject to the fair value hierarchy. Investments in all pooled separate accounts can be redeemed immediately at the current net asset value based on the fair value of the underlying assets. There are no withdrawal limits, redemption frequency limits or redemption notice periods. There were no unfunded commitments for these investments as of December 31, 2024 and 2023.

The investment objective of the large cap, mid cap, small cap, and international stock accounts is long term growth through large, medium, small, and international company investments, respectively. Target date accounts seek to maximize the return on investment consistent with the asset mix, which is adjusted over time as the target date of retirement approaches. Bond accounts seek a consistent return through bond investments. The balanced accounts seek a mix of current income and long term growth of capital through balanced common stock investments.

### **5. Guaranteed interest accounts**

The Plan participates in traditional benefit responsive investment contracts with American United Life Insurance Company ("AUL") via an investment in Guaranteed Interest Accounts ("GIA"). During 2022, the Company amended its contract with AUL to replace the AUL Fixed Interest Account with the AUL Stable Value Account. There was no market value adjustment for terminating the AUL Fixed Interest Account as all investments in the guaranteed interest account were transferred to another AUL guaranteed interest account. There are no significant changes in the terms of the investments. AUL commingles the assets of both GIA with other assets in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. AUL is contractually obligated to repay the principal and a respective specified interest rate that is guaranteed to the Plan. Contract value for both investments, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawals or transfer all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the Plan or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

- 6. Risks and uncertainties** The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.
- 7. Plan termination** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
- 8. Party-in-interest transactions** Certain Plan investments are managed by affiliates of American United Life Insurance Company. American United Life Insurance Company is the insurance company and recordkeeper as defined by the Plan. These transactions qualify as exempt party-in-interest transactions.
- During 2024 and 2023, the Company failed to remit to the insurance company certain employee contributions and loan repayments totaling \$95,987 and \$54, respectively, within the period prescribed by Department of Labor regulations. These delinquent remittances are considered nonexempt party-in-interest transactions. The Company made corrective contributions to the Plan in 2025 to compensate affected participants for lost earnings on the delinquent remittances.
- 9. Tax status** The Plan is a pre-approved defined contribution plan of OneAmerica Financial Partners Inc. which received an opinion letter on August 19, 2020, in which the Internal Revenue Service stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.
- Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **10. Subsequent events**

Effective September 1, 2025, a pre-approved plan sponsored by Actuarial Benefits & Design Company was adopted as an amendment and restatement of the Plan. Effective with this amendment and restatement, the age employees must attain to be eligible to participate in the Plan was reduced from 21 to 18 years. Additionally, a service requirement of 30 days was added to be eligible to participate in the Plan. Effective with the amendment and restatement September 1, 2025, participants may no longer take their benefits in installment payments and the maximum term permitted for a loan used for the purchase of a primary residence was reduced from 30 years to 10 years. In connection with the amendment and restatement, all net assets of the Plan were transferred to Nationwide Life & Annuity Insurance Company in September 2025.
