To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Granicus, LLC 401(k) (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from an agent on behalf of the qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are

required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. PLAN DESCRIPTION

The following description of the Granicus, LLC 401(k) (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s information.

General—The Plan is a defined contribution plan and covering substantially all employees of Granicus, LLC and Subsidiaries (the “Company”) who are not covered by another plan. The Company has appointed the Investment Committee to determine the appropriateness of the Plan’s investment offerings and monitor the investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan.

Eligibility—Employees are eligible to make salary deferral contributions once they attain age 18. Leased employees, nonresidents and employees covered by a collective bargaining agreement are not eligible to participate in the Plan. Employees enter the Plan on the first day of the payroll period after satisfying the eligibility requirement. In order to share in the discretionary matching and profit-sharing contributions, participants must have met the eligibility requirements and be employed on the last day of the plan year.

Contributions—Participants may elect salary deferral contributions (both pre- and post-tax contributions) up to the maximum allowed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect otherwise.

Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a target date retirement fund unless changed by the participant.

The Company may make a discretionary matching contribution to the Plan, which is currently 100% of the amount of the employee’s elective deferrals that do not exceed 1% of the employee’s compensation plus 50% of the amount of the employee’s elective deferrals that exceed 1%, but do not exceed 6% of the employee’s compensation. The Plan also allows for discretionary profit-sharing contributions. Profit sharing contributions are allocated on a pro rata basis to a participant based on their compensation divided by the total compensation of all participants. There were no discretionary profit sharing contributions for the year ended December 31, 2024.

Investment Elections—Contributions are allocated to the various investment options, including self-directed brokerage, offered by the Plan as directed by participants.

Participant Accounts—Individual accounts are maintained for each participant of the Plan. Each participant’s account is credited with the participant’s contribution and related matching and discretionary profit sharing contributions, if any, as well as allocations of Plan earnings. Participant

accounts are also charged with withdrawals and an allocation of Plan losses and administrative expenses that are paid by the Plan. Plan earnings and losses are allocated based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting—Participants are always 100% vested in their account balance attributable to salary reductions, rollover contributions and related earnings. The matching contribution and related earnings portion of their account is 100% vested after two years of service. The participant vests 20% each year, beginning after one year of service, and is 100% vested after six years of service, in their employer profit sharing contributions and earnings thereon. Upon termination of employment, any nonvested amount of employer-derived contributions is forfeited.

Notes Receivable from Participants—Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Loan terms range from one to five years; however, terms may exceed 5 years for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at the prime rate plus 1.0%. At December 31, 2024, the loans bear interest at 4.25% to 9.5% and are due at various dates through January 2036. Principal and interest are paid ratably through payroll deductions.

Normal Retirement—Normal retirement is age 59½; early retirement is not permitted. Participants vest 100% at age 59½ in their employer-derived contributions and earnings thereon.

Payment of Benefits—A participant or a participant's beneficiary is entitled to 100% of the account balance in the event of permanent disability or death, or their vested balance at retirement. Account balances of participants who terminate prior to attaining age 59½ with vested benefits of \$1,000 or less are automatically distributed in single lump sums as soon as practicable after the event occurs that entitles the distribution. Terminated participants with account balances outside of these requirements must provide their consent for distribution and may leave their accounts in the Plan. The Plan allows for in-service and hardship distributions, as defined.

Forfeited Accounts—When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. The plan document permits the use of forfeitures to reduce future employer contributions. However, if a participant is reemployed and fulfills certain requirements, as defined in the plan document, the account will be reinstated. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$18,612 and \$1,059,052, respectively. These accounts will be used to fund future employer contributions. During 2024, employer contributions of \$1,303,210 were reduced from forfeited nonvested accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States (US GAAP).

Use of Estimates—The preparation of financial statements in accordance with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition—The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The

Investment Committee determines the Plan’s valuation policies utilizing information provided by the Plan’s investment advisors, custodian and other third parties. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

Payment of Benefits—Benefits payments to participants are recorded upon distribution. Amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not yet been paid, were \$379,969 at December 31, 2024. There were no participants, who elected to withdraw from the Plan, but had not yet been paid at December 31, 2023.

Administrative Expenses—Certain administrative expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participants’ accounts and are included in administrative expenses. Investment management fees for investments are included as a reduction of investment return and not reflected separately in the statement of changes in net assets available for benefits.

Subsequent Events—Subsequent events were evaluated through October 10, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, Simpleview 401(k) plan with net assets available for benefits of approximately \$23,205,296 merged into the Plan.

3. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the Plan’s asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan’s financial statements and ERISA-required Supplemental Schedule, Schedule H, Line 4i—Schedule of Assets (Held At End of Year), obtained by management and agreed to or derived from information provided by Ascensus, LLC, as agent for Ascensus Trust Company. The Plan Administrator has obtained certifications from the agent on behalf of the custodian that information provided to the Plan Administrator by the agent on behalf of the custodian related to the following assets is complete and accurate.

Ascensus, LLC, as agent for Ascensus Trust Company, also certified to the completeness and accuracy of \$5,942,570 of net appreciation in fair value of investments, \$1,153,880 of interest and dividends related to the aforementioned investments, and \$26,338 of interest income on notes receivable from participants for the year ended December 31, 2024. All investment balances and investment

information, excluding the level of investments in Note 4, Fair Value Measurements and the unfunded commitment, frequency, and redemption notice period in Note 5, Net Asset Value (NAV) Per Share were also certified.

4. FAIR VALUE MEASUREMENTS

ASC 820, Fair Value Measurements and Disclosures, provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Level 1—Inputs to the valuation methodology are quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2—Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds—Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Interest-Bearing Cash—Held primarily in a short-term money market account, which are valued at cost plus accrued interest.

Collective Trust Fund—Valued at the NAV of units of a bank collective trust. The NAV as provided by the trustee is used as a practical expedient to estimate fair value and is based on the fair value of the

underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Self-Directed Brokerage Account—includes a variety of common stocks which are valued at the closing price reported on the active market on which the individual securities are traded.

6. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Wheeler Associates (Wheeler), which also provides investment management services for the Plan. Wheeler is not compensated by the Plan, but receives indirect compensation from the Plan's investments. Fees paid for investment management services were included as a reduction of the return earned on each fund.

In addition, the Plan also allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. The Plan pays Ascensus, LLC for the administration of the Plan. Fees paid by the Plan for plan administration are included in the statement of changes in net assets available for benefits. The Company directly paid other fees related to the Plan's operations. The Plan also issues loans to participants, which are secured by the vested balances in the participants' accounts. These transactions qualify as party-in-interest transactions.

7. INCOME TAX STATUS

The Plan uses a nonstandardized prototype plan document sponsored by Ascensus LLC. Ascensus LLC received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

9. RISKS AND UNCERTAINTIES

The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

10. NONEXEMPT PARTY-IN-INTEREST TRANSACTIONS

During 2024, the Company inadvertently failed to deposit \$316 of participant deferrals within the required timeframe as stated by the Department of Labor regulations. This transaction constitutes a prohibited transaction as defined by ERISA. The Company will correct this transaction and believes that the Plan has retained its tax qualification status and no tax liability has been accrued.
