To the Plan Administrator and Amcor US Benefits Committee of the
Amcor Supplemental Unemployment Benefit Plan

Opinion

We have audited the accompanying financial statements of the Amcor Supplemental Unemployment Benefit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits - cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - cash basis for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits - cash basis of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits - cash basis for the years then ended in accordance with the cash basis of accounting.

Emphasis of Matter - Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit for the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the cash basis of accounting described in Note 2. This includes determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

1. DESCRIPTION OF PLAN

The following description of the Amcor Supplemental Unemployment Benefit Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions, copies of which may be obtained from the Plan sponsor.

General

The Plan was established on April 1, 2013 to benefit those eligible employees, as defined in the plan document, of Amcor Flexibles North America, Inc., (the Company) and its adopting subsidiaries and affiliates who are involuntarily separated from service and who will experience a loss of future earnings, but not duplicate or replace, state unemployment benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's trust fund (the Trust) is administered under the terms of certain trust agreements between the Company and U.S. Bank, the trustee of the Plan.

Eligibility

Full-time employees, as defined in the plan document, become eligible to participate in the Plan after the first year of employment and have been subject to involuntary termination either as part of a workforce reduction, position elimination, discontinuance of a plant or operations, or other type of involuntary termination except for cause. Union employees and corporate officers are not eligible for benefits under the Plan.

Effective July 1, 2023, the Plan includes years of service in the calculation of benefits under the Plan with the Company's affiliates of Amcor Flexibles North America, Inc., even if the affiliates are not participating employers.

Benefits

The Plan provides for the payment of weekly, bi-weekly, or semi-monthly supplemental unemployment benefits. The benefits payable are reduced by any state unemployment benefits or any other compensation received. Benefits will cease upon re-employment or if hired by another company. If the employee becomes eligible for retirement and is not actively seeking work, unemployment benefits will no longer be paid. Hourly employees' benefits are accrued one week for each year of service, with a maximum of 16 weeks. Benefits for salaried employees are paid based on the employee's full number of years of completed service accruing two weeks for each year of service, with a minimum of four weeks and a maximum of 12 months (benefit period).

Benefits (Continued)

Employees who are re-employed by the Company, or by another company prior to the end of the benefit period, cease to continue to receive benefits, but are paid a re-employment bonus equal to 50% of their remaining benefit as a lump sum payment.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The statements of net assets available for benefits- cash basis and statements of changes in net assets available for benefits- cash basis are presented on the cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (US GAAP). Accordingly, certain liabilities and expenses are recognized when paid rather than when the obligation is incurred. The Company has not recognized employer contributions to the Plan and accounts payable for plan expenses and their related effects on the changes in net assets available for benefits. On the cash basis of accounting, contributions are recognized when received and expenses and claims when paid.

Use of Estimates

The preparation of financial statements in accordance with the cash basis of accounting, which is a basis of accounting other than US GAAP, requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, estimated health claims incurred but not reported (IBNR), and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates. Estimates that are particularly susceptible to significant change in the near-term are the liabilities for IBNR. Although it is not possible to measure the degree of variability inherent in these estimates, management believes that the liabilities reported are adequate. Any adjustment determined to be necessary is reflected in current operations.

Contributions

The Company may make contributions to the Trust on an as needed basis. The contributions are remitted to the Trust, and immediately paid out to the participants based on the benefit obligation required. Most of the benefit payments are paid directly out of the Company's general assets.

Payment of Benefits

Claims payments are recorded when paid by the trust and/or third-party claim administrator, and are recorded on the accompanying statements of changes in net assets available for benefits- cash basis.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Administrative Expenses

Administrative expenses paid by the Plan include trustee and third-party benefits administration fees. The Company pays the plan audit fee and provides accounting and other administration services to the Plan at no charge. Fees paid by the Company are excluded from these financial statements.

Recent Accounting and Regulatory Pronouncements

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management is evaluating the impact of the provisions of SECURE 2.0 and awaiting additional regulatory guidance from the Internal Revenue Service (IRS) and Department of Labor (DOL). The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements for the plan years ended December 31, 2024 and 2023. The Plan will be amended to reflect any changes made in response or are required by SECURE 2.0 prior to the deadline set by law or applicable regulations.

3. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

4. TAX STATUS

The Trust funding certain benefits of the Plan received an exemption letter from the IRS dated June 21, 2022, retroactively dated to May 15, 2018, stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the IRC. However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 or 2023 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

US GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. PARTIES-IN-INTEREST TRANSACTIONS

Certain employees of the Company provide administrative services to the Plan. These employees are not paid by the Plan for their services. Certain other administrative expenses incurred by the Plan are paid by the Company. These transactions qualify as party-in-interest.

6. POSTEMPLOYMENT TERMINATION OBLIGATIONS

Under the terms of the Plan, certain participants have a right to receive a benefit subsequent to their employment with the Company due to layoff or lack of work. The amount of the benefit is determined based on the accumulation of the participant's years of service and the position such participant held at the Company.
