### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Bradley Corporation Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and 2023 (ongoing), and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Bradley Corporation Pension Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 (in liquidation) and 2023 (ongoing), and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Bradley Corporation Pension Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

***Emphasis of Matter***

As discussed in Notes 1, 2, and 6 to the financial statements, the Board of Directors authorized the termination of the plan effective December 31, 2023 and Plan management determined liquidation is imminent in 2024. In accordance with accounting principles generally accepted in the United States of America, the plan has changed its basis of accounting from the ongoing basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Bradley Corporation Pension Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of Bradley Corporation Pension Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined benefit pension plan established by Bradley Company, LLC (formerly Bradley Corporation) on December 1, 1951, to provide retirement benefits for all eligible employees of the Company and its wholly owned subsidiaries Bradley Accessories Corporation, Bradley Fixtures Corporation and Bradley Aviation, LLC, (collectively referred to as the Company or Employer). The Plan was amended and restated throughout the years to comply with tax legislation and most recently amended effective December 31, 2023. On October 31, 2023, the Board of Directors approved to terminate the Plan effective December 31, 2023 and to allow for a lump sum option window.

The Plan was frozen to new participants as of January 1, 2009, and frozen to any additional benefits to current participants as of September 30, 2011. Therefore, no additional participants are eligible under the Plan, no further participant contributions are accepted under the Plan, and no further Company benefits accrue under the terms of the Plan after September 30, 2011. The Company has a 401(k) plan under which all existing and new participants obtain benefits subsequent to October 1, 2011.

**Pension Benefits**

The normal retirement benefit is a monthly pension commencing upon the later of age 65 or termination of employment. The normal form of payment is a joint and survivor or single life annuity. Participants who have attained age 55 with 10 years of service may elect to receive reduced early retirement benefits, as defined. Participants who terminate employment as a result of a disability shall be eligible for a disability retirement pension at age 65. Certain death benefits are available to beneficiaries of participants who were eligible to receive pension benefits, as defined. Per the frozen nature of the Plan, no further participant benefits accrue after September 30, 2011.

**Funding Policy**

The Plan is funded by annual contributions by the Company in amounts necessary to provide assets sufficient to meet the benefits to be paid to Plan participants. The Company made contributions of \$-0- and \$13,600,000 related to the years ended December 31, 2024 and 2023, respectively, and these contributions met the ERISA minimum funding requirements.

**Vesting**

Participants become fully vested in pension benefits upon the earlier of attainment of age 65 or actual retirement under the provisions of the Plan. As of December 31, 2023, participants were fully vested due to plan termination.

**Purchase of Annuity Contract**

Effective September 12, 2024, the Plan entered into an agreement with Legal and General America Life Insurance Company to purchase a single-premium group annuity contract to pay the accrued benefits for participants of Bradley Corporation Pension Plan. Legal and General America Life Insurance Company assumed an irrevocable commitment to pay the outstanding benefits for these participants commencing from and after January 1, 2025. Net premium payments were \$49,931,392 and \$-0- for the years ended December 31, 2024 and 2023, respectively.

**Plan Termination**

On October 31, 2023, the Board of Directors approved to amend and terminate the Plan effective December 31, 2023 (also see Note 6). As part of the plan for termination, the Plan was amended to allow for a lump sum distribution or purchase of an annuity. The Plan Administrator notified eligible participants of their options, subject to amended provisions. In September 2024, approximately \$14,500,000 in lump sum payments were paid out to participants who elected this option. See separate disclosure in Note 1 on the purchase of an annuity contract.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

As a result of the Plan termination effective December 31, 2023, Plan management determined liquidation of the Plan is imminent upon commencement of final distributions in 2024. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Under liquidation basis of accounting, assets are stated at their estimated net realized cash value expected to be collected in settling or disposing of assets during the liquidation process and liabilities are stated at their anticipated settlement amounts. As the Plan's assets were previously reported at fair value, the application of liquidation basis did not have a material impact on the Plan's financial statements.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated Plan benefits at the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

The Plan's expenses are paid either by the Plan or the Company as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain administrative expenses of maintaining the Plan are allocated and charged to participants based on participant account balances. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

**Subsequent Events**

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

**NOTE 3 ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS**

Accumulated Plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated Plan benefits include benefits expected to be paid to:

- retired or terminated employees or their beneficiaries,
- beneficiaries of employees who have died, and
- present employees or their beneficiaries.

Benefits under the Plan are accumulated based upon the benefit unit in effect upon retirement or termination and the number of credited years of service. The accumulated Plan benefits for active employees are based on the benefit unit in effect as of the actuarial valuation date. Benefits payable under all circumstances — retirement, death, and termination of employment — are included, to the extent they are deemed attributable to employee service rendered to the date at which benefit information is determined. The actuarial present value of accumulated Plan benefits is determined by an independent actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated Plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

Assumption changes noted in calculation of the change in actuarial present value of accumulated Plan benefits for the year ended December 31, 2023, is related to a decrease to the discount rate used. Discount rate used was 4.64% as of December 31, 2023, whereas 5.63% was used for the prior valuation.

The board approved to terminate the plan effective December 31, 2023 therefore the forgoing assumptions were on the presumption that the Plan would terminate. Subsequent to the benefit information date, the Plan satisfied all obligations by distribution of benefits to participants or transfer to an insurance carrier during the plan year ended December 31, 2024 (as disclosed in Note 1).

The computation of the actuarial present value of accumulated Plan benefits was made as of January 1, 2024. Had the valuation been performed as of December 31, 2023, there would be no material differences.

**NOTE 4 CERTIFICATION OF INVESTMENT INFORMATION**

Midwest Institutional Trust Company, BMO Harris Bank, N.A. and Aetna Life Insurance Company, the qualified institutions of the Plan, have supplied the Plan administrator with the certifications as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 (in liquidation) and 2023 (ongoing), the statements of changes in net assets available for benefits for the years then ended, the supplemental schedule of assets (held at end of year) as of December 31, 2024 (in liquidation) and the investment transactions as shown in the schedule of reportable transactions for the year ended December 31, 2024 (in liquidation).

Effective January 1, 2024, the Plan changed its qualified institution from BMO Harris Bank N.A., to Midwest Institutional Trust Company.

**NOTE 5 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Corporate, U.S. Government, Foreign, and Agency Obligations* – Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

*Pooled Separate Account* – Valued at the net asset value (NAV) of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions.

*Money Market* – Valued at \$1 cost, which is the value at which the fund is actively traded and approximates fair value based on the fair value of the fund's underlying investments.

**NOTE 6 PLAN TERMINATION**

The Company signed a formal resolution dated October 31, 2023, to terminate the Plan effective December 31, 2023. The Plan filed a notice with the Internal Revenue Service (IRS) to fully terminate the Plan effective December 31, 2023. As of the effective date of termination, all participants will become fully vested and the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

1. To participants and retired participants, who three years prior to the effective date of plan termination were receiving benefit payments or were eligible to receive retirement benefits at that time.
2. Other benefits eligible for termination insurance to vested participants that terminated prior to the effective date of plan termination or vested participants that were still employed as of the effective date of plan termination.
3. Other vested benefits to participants as follows:
  - a. Under normal or disability retirement, any participant who retired prior to the effective date of plan termination or was eligible to retire as of such date.
  - b. Under early retirement, any participant who had retired prior to the effective date of plan termination or participants eligible to retire as of such date.
  - c. To any vested participant that terminated prior to the effective date of the Plan termination or any employee that was vested as of such date.
4. To all other employees as of the effective date of plan termination according to the respective actuarial values of their accrued benefits as of such date.

If the assets of the Plan applicable to any of the above groups are insufficient to provide full benefits for all persons in such group, the benefits otherwise payable to such persons shall be reduced proportionately and no benefits shall be paid to any person in a succeeding group.

Certain benefits under the Plan are insured by the Pension Benefit Guaranty Corporation (the PBGC) in the event of plan termination. Whether all participants receive their benefits, should the Plan terminate at some future time, will depend on the sufficiency, at that time, of the Plan's net assets to provide those benefits and may also depend on the level of benefits guaranteed by the PBGC.

Whether all participants receive their benefits at some future time after the effective date of Plan termination will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Plan Sponsor and the level of benefits guaranteed by the PBGC.

Plan management has completed the standard requirements prescribed by ERISA to begin liquidation of assets in 2024 by distributing benefits to plan participants and transferring to an annuity carrier. Management has deemed liquidation to be imminent as of December 31, 2024, as the necessary steps were complete. After satisfaction of all obligations and expenses were complete, there were residual assets left in the Plan. The Plan Sponsor continued to evaluate and distribute plan assets subsequent to December 31, 2024, as allowable per Plan provisions.

Based on the estimates, the Plan accrued \$6,750,000 to be transferred to Watts Water Technologies, Inc. 401(k) Savings Plan, \$107,308 in administrative expenses to be incurred through liquidation and accrued investment income of \$17,967 expected to be received through liquidation.

The company expects the plan of liquidation to be complete before December 31, 2025.

**NOTE 7 PLAN TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated November 21, 2016, that the Plan and related trust are designed in accordance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since relying on the opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. On June 24, 2025 the Company received IRS acknowledgement that the termination of the Plan does not impact the Plan's qualified tax status.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated Plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**NOTE 9 PARTY-IN-INTEREST TRANSACTIONS**

The Plan investments are managed by the qualified institutions of the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions qualify as party in interest transactions, which are exempt from the prohibited transaction rules of ERISA.
