Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Alnylam Pharmaceuticals, Inc. Savings & Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

Note 1. Description of Plan

The following description of the Alnylam Pharmaceuticals, Inc. Savings & Investment Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering eligible employees sponsored by Alnylam Pharmaceuticals, Inc. (the Company). The Plan was established January 1, 2003, and subsequently amended and restated effective September 15, 2014. The Plan is subject to the provisions of the Internal Revenue Code (the Code) and the Employee Retirement Income Security Act of 1974 (ERISA). Fidelity Management Trust Company (Fidelity) serves as the trustee (Trustee) of the Plan and the Vice President of Finance and the President of the Company both serve as Plan Administrators.

Effective February 20, 2023, the Plan was amended to allow in-kind distributions of employer securities.

Eligibility: An employee is eligible to enter the Plan immediately upon employment, and there is no age requirement. The Plan is extended to Company employees who are U.S. citizens, who are not residents of Puerto Rico. Leased employees, students and special employees hired for a specified term or project whose employment terminates at the end of a specified task, are also not eligible for the Plan.

Participant contributions: Participants may contribute to the Plan on a pretax basis up to 60% of their plan compensation, as defined, not to exceed certain statutory limits. Effective December 21, 2023, the plan was amended to allow employee contributions up to a max of 100% of their plan compensation.

Employer contributions: In 2023, the Plan provided for a discretionary matching contribution of 100% of the first 2% and 50% of the next 4% of the eligible participant's compensation contributed to the Plan paid during the biweekly payroll. As of January 1, 2024, the Plan provides for a discretionary matching contribution of 100% of the first 4% and 50% of the next 2% of the eligible participant's compensation contributed to the Plan paid during the biweekly payroll.

Rollover contributions: The Plan may receive any amounts received by an employee as a distribution from another qualified plan, provided that the receipt of such amounts does not adversely affect the qualified tax status of the Plan. Participants are fully vested in these amounts.

Participant accounts: Each participant's account is credited with the participant's contributions, the employer's matching contributions, and an allocation of plan earnings. Each participant who receives a contribution has a separate individual investment account. Gains and losses of the account shall accrue to such account only. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Auto-enrollment: The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated fund until changed by the participant.

Investment elections: Participants may invest their accounts in any combination of mutual fund and common/collective trust fund investment options offered under the Plan. Participants may elect to transfer all or part of their account balances among the investment options. Participants may transfer assets out of Company common stock, but cannot transfer assets into Company common stock.

Vesting: Each participant is vested in 100% in all accounts immediately upon meeting the eligibility requirements.

Note 1. Description of Plan (Continued)

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loans are for a period not to exceed five years unless the loan is used to purchase a principal residence, in which case the loan may not exceed ten years. The loans are secured by the balance in the participant's account and bear interest rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates at issuance as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Payment of benefits: Amounts allocated to participants are distributable to participants or beneficiaries in the event of participants attaining normal retirement age, death or disability. Participants who cease to be employed prior to attaining normal retirement age for any reason other than death or disability can receive distribution of the vested portion of their accounts. At the option of the participants, benefit distributions may be made in installments or as a lump sum. Distributions are made in cash, except that distributions may be made in shares of marketable securities, other than shares of employer stock, pursuant to the qualifying rollover of such distribution to a Fidelity Investments individual retirement account. Participants may also withdraw funds upon certain hardship situations, as defined in the Plan.

Administrative expenses: Annual maintenance fees and loan origination fees are charged directly to the participant accounts. Administrative expenses are paid by the Plan (either by available forfeiture balances or by participant accounts) unless paid by the Company at its discretion.

Unallocated funds: Unallocated funds consist of forfeitures and revenue credits. Forfeitures are first applied to pay for administrative expenses under the Plan. Any remaining amounts are used to reduce cash required to fund future employer matching contributions. The Plan receives revenue credits through the Fidelity Revenue Credit Program (RCP), which may be used to pay for plan expenses. Amounts unused for expenses may be allocated to participant accounts. Forfeited non-vested accounts totaled \$12,101 and \$1,692 at December 31, 2024 and 2023, respectively. Total forfeitures amounted to \$10,409, during the year ended December 31, 2024. There were no forfeitures used to reduce employer contributions and to pay plan expenses during the year ended December 31, 2024. Unallocated funds related to the revenue credits earned totaled \$190,271 and \$246,660 at December 31, 2024 and 2023, respectively. Total revenue credits amounted to \$17,982 during the year ended December 31, 2024. Total revenue credits used to pay plan expenses totaled \$74,371 during the year ended December 31, 2024.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements have been prepared in accordance with accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets generally accepted accounting principles (GAAP) to ensure net assets available for benefits and changes in net assets available for benefits are consistently reported. References to GAAP issued by the FASB in these footnotes are to the FASB Accounting Standards Codification (ASC).

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment valuation and income recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and has terminated employment, the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Use of estimates: The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Payment of benefits: Benefits are recorded when paid to the participants.

Income taxes: GAAP requires plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require revenue recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds and money market fund: Valued at the daily closing price as reported by the fund. Mutual funds and the money market fund are held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded and are classified as Level 1.

Company common stock: Common stock is valued at the closing price reported on the active market on which the individual security is traded, and classified as Level 1 as it is actively traded and no valuation adjustments have been applied.

Common/collective trust fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the NAV of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.
