

Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Columbia Reach Pack 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Columbia Reach Pack 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Columbia Reach Pack 401(k) Profit Sharing Plan Notes to Financial Statements

Note 1 – Description of Plan

The following description of the Columbia Reach Pack 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of Plan provisions.

General – The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of Chiawana, Inc., dba Columbia Reach Pack (the Company). In addition, the employees of Chiawana Orchards, LLC, are included in the Plan. Chiawana Orchards, LLC, is considered to be part of a controlled group with the Company for purposes of the Plan. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Company is the Plan's sponsor and serves as Plan administrator.

Eligibility – Employees of the Company are eligible to participate in the Plan upon reaching age 21 and eligibility for entry to the Plan is immediate for elective deferrals, employer match and non-elective. Participants must be employed as of the last day of the Plan year, to be eligible to receive any employer-paid contributions.

Contributions

Participant contributions – Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Employer match and profit sharing contributions – The Company may elect to make discretionary matching and profit sharing contributions to the Plan. For the year ended December 31, 2024, the Company elected to make matching contributions to the Plan in the amount of \$83,692. Profit sharing contributions are allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation.

Contributions are subject to regulatory limitations.

Participant accounts – Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of transaction and investment expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

Columbia Reach Pack 401(k) Profit Sharing Plan Notes to Financial Statements

Vesting – Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Participants vest in the Company's contributions based on the following schedule:

Notes receivable from participants – Participant loans are not permitted by the Plan.

Payment of benefits – On termination of service, other than death, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or partial payments as requested from time to time by the participant. The Plan allows for the automatic distribution of participant vested account balances that do not exceed \$5,000. Any death benefits paid from a participant's account will be as a lump-sum distribution. The Plan permits participants to make penalty-free in-service distributions from all contribution sources in their account upon reaching the age of 59.5.

Forfeitures – Forfeitures are the nonvested portion of a participant's account that is lost upon termination of employment. Forfeitures are retained in the Plan and will be used to reduce future Company contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,659 and \$2,394, respectively. During the year ended December 31, 2024, the Company's 2024 matching contributions were reduced by \$6,224 from forfeited nonvested accounts.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

Use of estimates – The preparation of financial statements in accordance with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments are reported at fair value. The Plan's custodian, John Hancock Life Insurance Company, certifies the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Columbia Reach Pack 401(k) Profit Sharing Plan Notes to Financial Statements

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

Payment of benefits – Benefits are recorded when paid.

Expenses – Generally, expenses of maintaining the Plan are paid by the Company. Certain transaction and investment fees are paid by the Plan.

Excess contributions payable – Excess contributions payable represent amounts refunded to participants after year end.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before financial statements are available to be issued.

The Plan has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available to be issued. Volatility in the financial markets has had an impact on the global economy and investment values. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of such securities, it is reasonably possible that investment values have declined in subsequent periods.

Note 3 – Fair Value Measurements

Following is a description of the valuation method used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Collective trust – Units held in collective trusts (CTs) are valued using the net asset value practical expedient (NAV practical expedient) of the CTs as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTs, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a CT is calculated based on a compilation of primarily observable market information. The Plan has investments in the John Hancock Stable Value Fund, which is a collective trust that invests primarily in benefit-responsive contracts issued by state regulated insurance companies and banks, including but not limited to John Hancock Life & Health Insurance Company. The CT seeks to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term.

Pooled separate accounts – Units held in pooled separate accounts (PSAs) are valued using the net asset value practical expedient (NAV practical expedient) of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding.

The Plan has investments in the following PSAs with investment objectives as follows:

- American Funds at 2020, American Funds at 2025, American Funds at 2030, American Funds at 2035, American Funds at 2040, American Funds at 2045, American Funds at 2050, American Funds at 2055, American Funds at 2060, and American Funds at 2065 (target date funds) seek high total return until the target retirement date, with a greater focus on income as the target date approaches. The funds primarily invest in underlying funds using an asset allocation strategy designed for investors expected to retire at a specific date.
- Parnassus Equity Income (blend fund) seeks to achieve both capital appreciation and current income. The fund invests primarily in a diversified portfolio of equity securities.
- Mutual Global Discovery (international fund) seeks capital appreciation. The fund invests primarily in equity securities (including securities convertible into, or that the investment manager expects to be exchanged for, common or preferred stock) of U.S. and foreign companies at market prices less than their value based on certain recognized or objective criteria (intrinsic value).
- High Yield Fund (bond fund) seeks high current income with capital appreciation as a secondary goal. The fund normally invests at least 80% of its assets in U.S. and foreign fixed-income securities rated BB/Ba or lower and their unrated equivalents.
- Vanguard Small Cap Growth Index (growth fund) seeks capital appreciation. The fund normally invests at least 80% of its net assets (plus any borrowings for investment purposes) in equity securities of small-capitalization companies.
- Templeton Global Bond Fund (bond fund) seeks capital appreciation and growth of income. The fund normally invests at least 80% of its net assets in bonds.
- JP Morgan Mid-Cap Value Fund (blend fund) seeks capital appreciation. The fund invests primarily in mid-cap stocks.
- Small-Cap Value Fund (blend fund) seeks long-term capital appreciation. The fund primarily invests in small-cap value stocks, which historically generate strong risk-adjusted returns.
- The U.S. Targeted Value Portfolio (value fund) purchases small and mid-cap companies with high book value in relation to their price.
- John Hancock Bond Fund (bond fund) seeks capital appreciation and growth of income. The fund normally invests at least 80% of its net assets in bonds.
- New Perspective Fund's (growth fund) primary objective is to provide long-term growth of capital with future income as a secondary objective primarily through common stocks.
- Templeton World Bond Fund (international fund) invests in equities located around the world, primarily common stocks, while hedging against currency risks.
- US Small-Cap Fund (blend fund) seeks long-term capital appreciation. This fund normally invests in stocks that have both growth and value characteristics.

- Disciplined Value Fund seeks to provide long-term of capital.
- Blue Chip Growth Fund seeks to provide long-term growth of capital. Current income is a secondary objective.
- Mid Value Fund seeks long-term capital appreciation.
- Mid Cap Growth Fund seeks to provide long-term growth of capital and capital appreciation.

For each of the investments valued at NAV, the redemption frequency is daily, there is no redemption notice period, and there are no redemption restrictions.

Note 4 – Tax Status

The Plan document is a prototype standardized defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on November 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, management has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

Note 6 – Certified Investment Information

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company, a qualified institution:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

Note 7 – Party-in-Interest Transactions

Certain Plan investments are managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the custodian of the Plan and, therefore, transactions with this entity qualify as exempt party-in-interest transactions. Fees of \$21,871 were paid by the Plan for investment management services to John Hancock Life Insurance Company for the year ended December 31, 2024.

Note 8 – Plan Termination

Although it has not expressed any intention to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.
