**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Indeed, Inc. 401(k) Profit-sharing Plan Trust (the Plan) provides only general information. Indeed, Inc. (the Company) is the Plan sponsor. Participants should refer to the Plan document and summary plan description for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established to provide retirement benefits for substantially all full-time and part-time employees of the Company who have reached the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Fidelity Management Trust Company serves as trustee of the Plan and Fidelity Investments Inc. serves as the record keeper of the Plan (collectively Fidelity).

**Contributions**

Participants may contribute between 1% and 96% of compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may direct all or a portion of their contributions as Roth or after-tax contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). The Company made a matching contribution equal to 100% of the first 5% of compensation contributed by each participant annually for the years ended December 31, 2024 and 2023. Matching contributions are funded on a pay period basis and a true-up contribution is calculated at year-end. In addition, the Company may also make discretionary profit-sharing contributions. There were no discretionary profit-sharing contributions for the years ended December 31, 2024 and 2023. All contributions are subject to certain limitations imposed by the Plan and the Internal Revenue Code (IRC).

**Participant Accounts**

Each participant's account is credited with the participant's contributions, Company contributions, and allocations of plan earnings. Investment income and administrative expenses are allocated to the participant's account regularly. Allocations of investment income, administrative expenses, and discretionary profit-sharing contributions are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options**

Participants may direct their contributions into any of the funds offered by the Plan. These funds include a variety of investment options with various objectives and degrees of financial risk.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Vesting**

Participants are immediately vested in their deferral and rollover contributions, including the earnings on those amounts. Participants are also immediately vested in employer matching contributions. Vesting in the discretionary employer profit-sharing contributions is based on years of continuous service. Participants are fully vested in discretionary employer profit-sharing contributions upon the completion of four years of service. Participants are also fully vested upon reaching normal retirement age, death, or total disability.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. Loan terms range from one to five years, except for loans to purchase a primary residence, which may be offered over a term of up to 10 years. The loans are secured by the balance in the participants' accounts and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator. The notes currently bear interest at rates ranging from 4.25% to 9.5%. Participants may only have one loan outstanding at any given time. Generally, principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

The benefit to which a participant is entitled is the benefit that can be provided by the participant's account. Upon termination of service, death, disability, or reaching normal retirement age, the participant may receive the value of the vested interest in his or her account in various forms of payment, as described in the Plan document.

The Plan also allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions.

The Plan also provides for automatic cash-out and/or rollover distributions into an individual retirement account for terminated participants whose balance does not exceed certain limits as prescribed by the Plan document and IRC.

**Forfeitures**

Forfeitures of matching contributions due to legacy vesting schedules are used to pay plan expenses or reduce the Company's future matching contributions. Forfeited nonvested matching contributions totaled \$49,806 and \$308,627 at December 31, 2024 and 2023, respectively. The Company utilized \$50,130 of forfeitures to reduce the 2024 matching contribution true-up deposited in 2025. The Company utilized \$338,441 of forfeitures to reduce the 2023 matching contribution true-up deposited in 2024.

**Partial Plan Termination**

During the year ended December 31, 2023, a partial plan termination occurred as defined by Department of Labor and Internal Revenue Service (IRS) regulations. When a partial plan termination occurs, affected employees become immediately vested in all account balances. However, since all affected participants were already 100% vested in their accounts, there was no impact to participant accounts as a result of the partial plan termination.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) require the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes gains and losses on investments sold during the year as well as appreciation and depreciation of the investments held at the end of the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits**

Benefits to participants are recorded when paid.

**Plan Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Administrative expenses are presented on the statement of changes in net assets available for benefits net of credits received from Fidelity as part of a revenue-sharing arrangement. For the year ended December 31, 2024, the Plan received credits totaling \$243,956, of which \$100,759 was reallocated back to participant accounts. For the year ended December 31, 2023, the Plan received credits totaling \$184,483, of which \$60,401 was reallocated back to participant accounts. As of December 31, 2024 and 2023, the balance in the revenue sharing account totaled \$294,500 and \$140,855, respectively.

**Risks and Uncertainties**

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**Subsequent Events**

Subsequent events were evaluated through September 16, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION BY THE INVESTMENT TRUSTEE**

Information presented in the accompanying statements and schedule as of and for the years ended December 31, 2024 and 2023, for investments, notes receivable from participants, investment income, and interest income on notes receivable from participants was derived, without audit, from information certified to be complete and accurate by Fidelity Management Trust Company, the trustee, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 4 FAIR VALUE MEASUREMENTS**

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

*Money Market and Mutual Funds:* Money market and mutual funds are valued using the quoted price of shares held by the Plan at year-end.

*Common and Collective Trusts:* Common and collective trusts are stated at their net asset values as reported by the investment manager of the fund based on the fair value of the underlying assets and liabilities at the measurement date. The net asset value is used as a practical expedient to estimate fair value.

*Self-Directed Brokerage Accounts:* Self-directed brokerage account investments include money market funds, mutual funds, common stocks, preferred stocks, warrants, options, certificates of deposit, corporate bonds, and exchange traded funds.

Money market and mutual funds held within self-directed brokerage accounts are valued at the quoted price of shares held by the Plan at year-end.

Common stocks, preferred stocks, warrants, options, corporate bonds, and exchange traded funds held within self-directed brokerage accounts are valued at the closing price reported in the active market in which the individual securities are traded.

Certificates of deposit are valued by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain Plan investments are investments managed by affiliates of Fidelity. Fidelity is a trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments. Certain employees of the Company who participate in the Plan perform administrative services to the Plan at no cost to the Plan. Notes receivable from participants are also party-in-interest transactions.

**NOTE 6 INCOME TAX STATUS**

The Plan has adopted a preapproved plan document that received a favorable opinion letter from the IRS that it was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
