Note 1 - Plan Description

The following description of LG Electronics Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of LG Electronics USA, Inc.; LG Electronics Alabama, Inc.; LG Electronics Mobile Research USA, LLC; LG Electronics MobileComm U.S.A., Inc.; LG Electronics Mexicali, S.A. de C.V.; LG Electronics Reynosa, S.A. de C.V.; Zenith Electronics, LLC; LG Electronics Vehicle Components USA, LLC; and LG Technology Ventures, LLC (collectively, the "Companies"). The Plan does not cover leased employees and employees who are covered by a collective bargaining agreement that does not provide for their participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Any covered employee is eligible to participate in the Plan after completing 1 hour of service. Special status (temporary, seasonal, or part-time) employees must be at least 21 years old and have completed at least one year of service, during which the employee worked at least 1,000 hours of service, to be eligible to participate in the Plan. Participation in the Plan starts on the first day an employee has completed 1 hour of service provided that the applicable payroll authorization and enrollment forms have been completed. For a special status employee, participation starts on the first day of the month after the employee has met the eligibility requirements.

Contributions

The Plan provides for employee 401(k) deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants who have attained age 50 may make catch-up contributions in addition to their regular contributions. Participants may designate all or a portion of their deferral contributions as Roth deferral contributions, which are after-tax contributions that are also subject to certain IRC limitations.

Participants have the option to elect the Plan's auto-escalation features. Participants who have elected to participate in the annual increase program will have their contributions automatically increase by 1 percent each year following the date of election. There is no cap on the maximum deferral election percentage for the annual increase program.

Effective January 1, 2024, the Plan adopted a provision to include an auto-enrollment feature of 3 percent starting the first pay period after the first month of service.

Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Employer safe harbor matching contributions are equal to 100 percent of the first 3 percent of each participant's deferral contribution and 50 percent of the next 2 percent of a participant's deferral contribution.

The Companies may also make a discretionary contribution subject to the approval of the board of directors. Such contribution, if any, shall be allocated among participants who were employed by the Companies on the last day of the plan year or who were terminated before the end of the plan year because of retirement, disability, death, or reduction in force. Such allocations are based upon participants' compensation, as defined. There was no discretionary contribution made for the year ended December 31, 2024.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. Loan terms range from 1 to 5 years. Loans for the purchase of a principal residence can be paid over a reasonable period of time, not to exceed 15 years. The notes receivable are secured by the balance in the participant's account and bear interest at the prime rate plus 1 percent. Rates ranged from 4.25 percent to 9.50 percent in the current plan year. Principal and interest are paid ratably through monthly payroll deductions.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Companies' safe harbor match, and allocations of any discretionary contributions from the Companies and plan earnings. Participants' accounts are also charged with an allocation of administrative expenses and plan losses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants' contributions, the employer match contribution, and the employer discretionary contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, active participants may also begin taking penalty-free distributions from the Plan upon reaching the age of 59½.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company or its affiliates. Fidelity Management Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Additionally, certain administrative expenses of the Plan are paid by the Companies, which qualify as party-in-interest transactions.

Termination

While it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer liability in an orderly transaction between market participants at the measurement date. See Note 4 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Companies.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 2, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Note 4 - Fair Value Measurements (Continued)

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Common/Collective Trust Funds

The common/collective trust fund is valued at net asset value per share or its equivalent of the fund, which is based on the fair value of the fund's underlying net assets. There are no redemption restrictions or unfunded commitments on these investments.

Self-directed Brokerage Accounts

The Plan allows participants to invest in self-directed brokerage accounts. The self-directed brokerage accounts include various investments in publicly traded securities, which are valued at the quoted prices reported in active markets.

Note 1 - Plan Description

The following description of LG Electronics Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of LG Electronics USA, Inc.; LG Electronics Alabama, Inc.; LG Electronics Mobile Research USA, LLC; LG Electronics MobileComm U.S.A., Inc.; LG Electronics Mexicali, S.A. de C.V.; LG Electronics Reynosa, S.A. de C.V.; Zenith Electronics, LLC; LG Electronics Vehicle Components USA, LLC; and LG Technology Ventures, LLC (collectively, the "Companies"). The Plan does not cover leased employees and employees who are covered by a collective bargaining agreement that does not provide for their participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Any covered employee is eligible to participate in the Plan after completing 1 hour of service. Special status (temporary, seasonal, or part-time) employees must be at least 21 years old and have completed at least one year of service, during which the employee worked at least 1,000 hours of service, to be eligible to participate in the Plan. Participation in the Plan starts on the first day an employee has completed 1 hour of service provided that the applicable payroll authorization and enrollment forms have been completed. For a special status employee, participation starts on the first day of the month after the employee has met the eligibility requirements.

Contributions

The Plan provides for employee 401(k) deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants who have attained age 50 may make catch-up contributions in addition to their regular contributions. Participants may designate all or a portion of their deferral contributions as Roth deferral contributions, which are after-tax contributions that are also subject to certain IRC limitations.

Participants have the option to elect the Plan's auto-escalation features. Participants who have elected to participate in the annual increase program will have their contributions automatically increase by 1 percent each year following the date of election. There is no cap on the maximum deferral election percentage for the annual increase program.

Effective January 1, 2024, the Plan adopted a provision to include an auto-enrollment feature of 3 percent starting the first pay period after the first month of service.

Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Employer safe harbor matching contributions are equal to 100 percent of the first 3 percent of each participant's deferral contribution and 50 percent of the next 2 percent of a participant's deferral contribution.

The Companies may also make a discretionary contribution subject to the approval of the board of directors. Such contribution, if any, shall be allocated among participants who were employed by the Companies on the last day of the plan year or who were terminated before the end of the plan year because of retirement, disability, death, or reduction in force. Such allocations are based upon participants' compensation, as defined. There was no discretionary contribution made for the year ended December 31, 2024.

Note 1 - Plan Description (Continued)

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. Loan terms range from 1 to 5 years. Loans for the purchase of a principal residence can be paid over a reasonable period of time, not to exceed 15 years. The notes receivable are secured by the balance in the participant's account and bear interest at the prime rate plus 1 percent. Rates ranged from 4.25 percent to 9.50 percent in the current plan year. Principal and interest are paid ratably through monthly payroll deductions.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Companies' safe harbor match, and allocations of any discretionary contributions from the Companies and plan earnings. Participants' accounts are also charged with an allocation of administrative expenses and plan losses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants' contributions, the employer match contribution, and the employer discretionary contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, active participants may also begin taking penalty-free distributions from the Plan upon reaching the age of 59½.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company or its affiliates. Fidelity Management Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Additionally, certain administrative expenses of the Plan are paid by the Companies, which qualify as party-in-interest transactions.

Termination

While it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer liability in an orderly transaction between market participants at the measurement date. See Note 4 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Companies.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 2, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Note 4 - Fair Value Measurements (Continued)

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Common/Collective Trust Funds

The common/collective trust fund is valued at net asset value per share or its equivalent of the fund, which is based on the fair value of the fund's underlying net assets. There are no redemption restrictions or unfunded commitments on these investments.

Self-directed Brokerage Accounts

The Plan allows participants to invest in self-directed brokerage accounts. The self-directed brokerage accounts include various investments in publicly traded securities, which are valued at the quoted prices reported in active markets.
