INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and participants of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Smith, Gambrell & Russell, LLP 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from the qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by the qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Notes to Financial Statements December 31, 2024 and 2023

1. Description of Plan

The following description of the Smith, Gambrell & Russell, LLP 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the summary plan description, which is a summary of the Plan document, for a description of the Plan's provisions. Copies are available from the plan administrator.

General

The Plan is a defined contribution plan covering all partners and eligible full-time employees, as defined in the Plan document, of Smith, Gambrell & Russell, LLP (the Employer), who are age 21 or older and completed three months of service. Certain participants of previous employer plans receive recognition of service from those previous employers as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Upon satisfying the service requirement, participants are automatically enrolled in the Plan at 3% of eligible compensation on the first day of the following month, unless they elect otherwise. Participants may elect to contribute pre-tax and/or Roth contributions of up to 100% of eligible compensation, as defined by the Plan document, not to exceed a maximum of \$23,000 in 2024, plus additional catch-up contributions of \$7,500 for those participants who have attained age 50. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan allows for in-plan Roth conversions for participants that are currently employed with the Employer. In-plan Roth conversions allow participants to transfer amounts from their pre-tax accounts into a Roth account and pay all applicable taxes in the year of the transfer.

The Employer may make a profit-sharing contribution out of its net profits where amounts are determined by the Employer in its sole discretion, based on various employee groups as stated in the Plan document. Participants become eligible for Employer contributions on the first day of the first or seventh month of the Plan year, coinciding with or next following the date they attain age 21 and complete one year of service.

Participant Accounts

Each participant's account is credited with the participant's contribution, rollovers, earnings and losses on the investments in their account, and an allocation of the Employer's contributions, if any, and is charged with certain administrative expenses. Upon enrollment in the Plan, a participant may direct contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The Plan also offers a

self-directed brokerage account as an additional investment option for participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and the Employer's contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account balance. The notes are secured by the vested balance in the participant's account and bear interest at rates determined quarterly by the plan administrator. During 2024, notes had fixed rates of 4.25% to 9.50% for the term of the note, not to exceed 10 years or, 15 years if used for the purchase of a primary residence. Principal and interest are paid through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, termination of employment or retirement, a participant or their beneficiary may elect to receive payment of the vested interest in their account in a lump-sum distribution, installment payments, or a series of distribution payments. In-service withdrawals of the vested interest of the participant account are allowed when they reach age 59½. In-service withdrawals of rollover contributions are allowed at any time. Effective January 1, 2024, if a participant terminates employment and has an account balance less than \$7,000, the balance will be rolled into an individual retirement account in the participant's name. The participant may also receive a distribution for certain hardship situations when certain conditions are met.

Administrative Expenses

The Plan allows for payment of Plan expenses to be made from the Plan's assets, which will generally be based on an annual per participant basis. Fees to obtain a participant loan and certain transaction fees are charged to that participant. These expenses are paid to a service provider of the Plan and therefore qualify as party-in-interest transactions. All other Plan administrative expenses are paid by the Employer. The Employer does not expect reimbursement from the Plan for any expenses paid on behalf of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. Employer contributions are considered payable to the Plan when they are approved to be paid by the Employer and the related participant's contributions are payable to the Plan. Any unfunded participant or Employer contributions are included in the participant and employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value except for the insurance policies, which are stated at cash surrender value, which approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes interest, dividends as well as realized and unrealized gains and losses on those investments. Interest income is recorded when received. Dividends on common stock are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recorded when received by the Plan. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced, and a benefit payment is recorded. Notes receivable from participants qualify as party-in-interest transactions.

Payment of Benefits

Benefit payments are recorded when paid.

Subsequent Events

The plan administrator evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

Except for the cash surrender values of the insurance policies at December 31, 2024 and 2023, disclosed in the accompanying financial statements and supplemental schedule, all information regarding investments and notes receivable from participants, including investments held and notes receivable from participants as of December 31, 2024 and 2023, and the net change in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by T. Rowe Price Trust Company (T. Rowe Price), the Plan's qualified institution.

4. Investments

Certain Plan investments include shares of common collective trusts, mutual funds, and a stable value fund, which are managed by T. Rowe Price. T. Rowe Price is a service provider of the Plan; therefore, transactions in these investments qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net change in fair value of investments, as they are paid through revenue sharing rather than direct payment.

Investments are exposed to various risks, such as market, currency, interest rate, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, and significant cybersecurity attacks. It is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest

priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for similar assets or liabilities in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in the common collective trusts are valued daily using their net asset value (NAV). The NAV is based on the fair value of the mutual funds, stocks, debt instruments, and other securities in the account. Participants can trade the common collective trusts daily at their published NAV (Level 1).

Investments in mutual funds are based on quoted market prices for the identical asset in an active market (Level 1).

Investments in the self-directed brokerage accounts include common stock, preferred stock, money market funds, unit investment trusts, and mutual funds. All assets are traded through a broker and are considered Level 1 assets.

The Plan invests in a stable value fund held in a common collective trust. The stable value fund invests in fully benefit-responsive guaranteed investment contracts (GICs), which are general obligations of the insurance companies that issue the contracts, as well as synthetic GICs. The stable value fund trades at the NAV which is based on contract value of the underlying investments (Level 1). The stable value fund includes certain redemption restrictions. If the Plan chose to redeem all or a significant portion of the stable value fund, the issuer may require a 12-month wait period to redeem.

Insurance policies are carried at cash surrender value, which management believes approximates fair value, and are considered Level 2 assets.

5. Income Tax Status

The Plan operates under a volume submitter plan document prepared by FIS Business Systems LLC (FIS). FIS is the sponsor of the volume submitter plan document and has obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service states that the volume submitter document is in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has not received an individual determination letter, the plan administrator believes that the Plan is designed and is currently operating in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by the taxing authorities and may change upon examination.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA.
