Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of the Covenant Care Services, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Note 1 - Description of plan:

The following description of the Covenant Care Services, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan Sponsor is Covenant Care Services, LLC (the Company, Administrator, Sponsor, or Employer). The Plan is a defined contribution plan covering all employees of the Company who meet certain eligibility requirements, with the exception of collectively bargained employees, leased employees, and non-resident aliens. The Plan was formed with an effective date of January 1, 2024. Participants began contributing to the Plan in February 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

To be eligible to participate in the Plan, employees must be at least 21 years of age and complete one year of service. Employees are allowed to begin participation in the Plan on January 1 and July 1 of each Plan year after the eligibility requirements are met. Participants are allowed to make contributions up to the maximum amount allowed by the Internal Revenue Code (IRC). Additionally, employees are given the option to make Roth contributions under the Plan, subject to IRC limitations. Employees have the ability to modify contribution elections each payroll period. Participants who have attained age 50 before the end of the Plan year are permitted to make additional catch-up contributions.

Each year the Company is required to make an employer safe-harbor contribution at a minimum of 3% of compensation for all eligible employees. For the year ended December 31, 2024, the Company provided an employer safe-harbor contribution of 3% of eligible employee's compensation totaling \$294,191. The employer safe-harbor contribution is calculated and remitted in the subsequent Plan year. Additionally, the Company may make discretionary employer profit-sharing contributions in an amount determined by management. Participants credited with 1,000 hours of service during the Plan year and employed on the last day of the Plan year are eligible to receive an allocation of employer profit-sharing contributions. The Company made a discretionary employer profit-sharing contribution of \$19,425 for the year ended December 31, 2024.

Note 1 - Description of plan - continued:

Participant accounts

Each participant's account is credited with the participant's contributions, the Company's safe-harbor contribution, an allocation of the Company's profit-sharing contribution, Plan earnings, and administrative expenses. Profit-sharing contribution allocations are made by creating a profit-sharing group for each participant. Management can allocate profit-sharing contributions to each group (participant) using any method they choose, as provided for in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and employer safe-harbor contributions, plus actual earnings thereon. Participants vest in Company discretionary profit-sharing contributions in accordance with the following schedule:

Participants are immediately vested upon termination of the plan, attainment of the retirement age of 65, or disability or death while employed.

Payment of benefits

Participants are entitled to a lump sum distribution of the vested value of their account upon termination of service, disability, death, or attainment age 59 1/2. Participants who experience proven financial hardship may request a withdrawal of any of their fully vested accounts. If a participant's account balance, excluding participant rollover contributions, is less than \$5,000 but more than \$1,000 upon termination of service, the participant's account may be rolled over to an individual retirement account (IRA). If a participant's account balance is less than \$1,000 upon termination of service, the participants account balance may be distributed to the participant. If a participant's account balance is \$5,000 or more upon termination of service, they may maintain their account balance in the Plan.

Administrative expenses of the Plan are paid by either the Company or by the Plan, as determined by the Plan Sponsor. The Company pays a portion of administrative expenses of the Plan. Fees charged for processing distributions, administrative fees, and investment advisory fees, as well as other account transactions, are charged directly to the accounts of applicable participants. Total administrative fees paid by the Plan during the year ended December 31, 2024 totaled \$10,294.

Note 2 - Summary of significant accounting policies:

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment valuation and income recognition

The Plan's pooled separate account investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Investment valuation and income recognition - continued

Inputs other than quoted prices that are observable for the asset or liability;
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Pooled separate account investments are in underlying investments in shares of mutual funds. The net asset value value of the investment in the mutual funds is adjusted to apply the expense factor disclosed in the annuity contract. The unit value is determined by dividing the net assets by the number of units outstanding.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Payment of benefits

Benefits are recorded when paid.

Subsequent events

The Plan has evaluated subsequent events through October 10, 2025, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of December 31, 2024, have been incorporated into these financial statements.

Note 3 - Investments and information certified by the custodian:

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the custodian, John Hancock Life Insurance Company USA.

Note 4 - Party-in-interest transactions:

The custodian and its affiliates perform services for the Plan, sell products to the Plan, and manage and maintain certain investments of the Plan for which fees are charged to the Plan. The Plan also has a third party administrator. The Plan pays a portion of administrative expenses while the Plan Sponsor pays the remainder of administrative expense. Such transactions, while considered party-in-interest transactions under ERISA, are specifically exempt from the prohibited transaction rules.

Note 5 - Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participant accounts will become fully vested.

Note 6 - Tax status:

The underlying prototype plan has received an opinion letter from the IRS dated June 30, 2020 stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC), and therefore, the related trust is tax-exempt. The Plan Administrator has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator has indicated that it will take the necessary steps to bring the Plan's operations into compliance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for Plan years prior to 2024.

Note 7 - Correction of operational issues:

For the 2024 Plan year, multiple delinquent contributions were identified that require corrective action. The total delinquent contributions for the year are listed in Schedule H, Line 4a - Schedule of Delinquent Participant Contributions in the supplemental information accompanying these financial statements.

Note 8 - Subsequent event:

The Plan was amended, with an effective date of April 1, 2025, to modify the available money sources for hardship distributions. This amendment removes employer contributions as available sources for hardship distributions. Employee contributions are the only sources available for hardship distributions.
