NOTE 1 Description of plan

The following description of the Metz Culinary Management, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Metz Culinary Management, LLC (the Company) that have completed one month of service and attained age eighteen. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Contributions

Each year, participants of the Plan may contribute up to 50% of pretax compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Company's matching policy is equal to 10% of participant elective deferral contributions not to exceed 10% of participant elective deferral contributions. Profit-sharing contributions are discretionary. Effective June 1, 2024, Arcadia regular full-time bargaining unit employees who enrolled and participated in the Plan receive a contribution of fifty-five cents (\$.55) per hour worked including holidays and vacation. These employees must work or be regularly scheduled a minimum of thirty hours per week in order to qualify for the contribution. There was an employer matching contribution of \$337,324 for 2024. There were no forfeitures used to decrease the employer matching contribution in 2024. There was no profit-sharing contribution in 2024. Contributions are subject to certain IRS limitations. Participants direct the investment of their accounts into various investment options offered by the Plan.

Participant accounts

A separate account is maintained for each participant. Each participant's account is credited with the participant's contributions, including rollovers, company matching contributions, if any, and allocations of the Company's profit-sharing contributions, if any, and Plan earnings. Each participant's account is also charged with an allocation of certain administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the Company's contribution portion of their account is based on years of credited service and a graded vesting schedule, with 100% vesting after four years of credited service.

Notes receivable from participants

Participants may borrow from their account balance a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Participants may not have more than one loan outstanding. The loans are secured by the balance in the participant's account and bear an interest rate equal to the prime rate as published in the Wall Street Journal plus one percentage point. Principal and interest is paid ratably through payroll deductions.

Payment of benefits

A participant is eligible to receive a distribution of his or her vested account upon retirement, disability, death or termination of employment. The normal form of benefit payment for a married participant is a qualified joint and survivor annuity and a life annuity for participants who are not married. Participants may elect to receive their distribution in a lump sum, in equal monthly, quarterly or annual installments or in payments for life with a guarantee of payments for a specific number of years certain. The Plan also provides for in-service withdrawals for hardship withdrawals.

Forfeitures

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account represents a forfeiture. Forfeitures will first be used to pay administrative expenses. Any excess forfeitures related to employer matching contributions will be used to reduce employer matching contributions to the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$99,337 and \$64,361, respectively.

SECURE 2.0 Act

President Biden signed the Consolidated Appropriations Act (CAA), including the SECURE 2.0 Act, into law on December 29, 2022. SECURE 2.0 builds on changes made by the SECURE Act of 2019 and the Plan document has been amended for provisions required to be effective in 2024 and will be amended in accordance with the required timeline of the act to meet the applicable provisions effective after December 31, 2024.

NOTE 2 Summary of significant accounting policies

Basis of accounting

The accompanying financial statements are prepared under the accrual basis of accounting.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on investments bought and sold as well as held during the year.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and uncertainties

The Plan provides for various investment options in various combinations of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded based on the terms of the plan document.

Payment of benefits

Payments are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Certain expenses of maintaining the Plan paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of the fair value of investments.

NOTE 3 Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest bearing cash (money market): Valued at principal value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: The stable value collective trust fund invests in conventional and synthetic investment contracts issued by life insurance companies, banks and other financial institutions and is valued at the net asset value per unit as determined by the common collective trust as of the valuation date. The NAV is the basis for current transactions and the stable value can be redeemed at NAV as of the measurement date. Therefore, this investment has a "Readily Determinable Fair Value". The fair value of conventional investment contracts held by the fund is determined based on present value of the contracts expected cash flows, discounted by current market interest rates for like-duration and like-quality investments. These inputs are "observable for the asset or liability, either directly or indirectly", including quoted prices for similar securities, interest rates, credit risk, etc. that are determined for an asset based on independent market data. The stable value included as level 2 have NAVs that are considered published. The fair value of synthetic investment contracts held by the fund are based on the fair value of the underlying securities, which consist primarily of over-the-counter market securities and open-end mutual funds. There are no unfunded commitments or redemption restrictions.

The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers of investments into or out of Level 3. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 Related-party transactions and party in interest transactions

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. The Plan made a direct payment to a third-party administrator of \$137,785 for the year ended December 31, 2024, which was not covered by revenue sharing.

Fidelity Management Trust Company is the Trustee as defined by the Plan, provides certain administrative services to the Plan pursuant to a Service Agreement between the Company and the Trustee. The Trustee receives revenue from certain service providers for services the Trustee provides to the funds. This revenue is used to offset certain amounts that would be owed to the Trustee from the Plan for its administrative services to the Plan had the arrangements with the service providers not been in place.

The Plan issues loans to participants, which are secured by the balances in the participants' accounts. Administrative expenses, other than those allocated to participant accounts, are paid by the Company. Certain administrative functions to the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

NOTE 5 Tax status

The Plan operates under a Non-Standardized Pre-Approved Profit Sharing Plan with CODA, which received an opinion letter dated June 30, 2020 from the Internal Revenue Service ("IRS") indicating this plan was an acceptable plan under applicable sections of the Internal Revenue Code ("IRC") for use of employers for the benefit of their employees. An employer who adopts this plan will be considered to have a plan qualified under Code Section 401(a), providing all the terms of the Plan are followed and the eligibility requirements and contribution or benefit provisions are not more favorable to officers, owners or highly compensated employees than for other employees. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
