Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of SIRVA Employee Savings Plan and Trust 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 Financial Statements).

Note 1. Description of Plan

The following description of SIRVA Employee Savings Plan and Trust 401(k) Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan was established to enable employees to save toward retirement through payroll deductions. The Plan allows employees to put money into the Plan on a before-tax basis. Income taxes are generally not incurred by employees until the employee receives money from the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation.

On August 1, 2022, SIRVA, Inc. completed a strategic merger with BGRS, a direct competitor, and began operating as SIRVA BGRS Worldwide, Inc. The Plan previously sponsored by BGRS was frozen for participation as of December 31, 2022, with the merger and transferring of the assets into the Plan occurring on January 13, 2023.

General

The Plan covers all full-time and part-time employees of SIRVA, Inc. (Company) and participating subsidiaries that are not covered by a collective bargaining agreement. Employees become eligible to participate in the Plan following completion of 30 days of continuous service. Upon satisfying the Plan's eligibility requirements, employees are eligible to participate in the Plan as of the next payroll period.

Contributions

Participants may contribute up to 100% of eligible compensation, not to exceed the amount allowable under the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company may make discretionary matching contributions in the amount of 60% of the first 6% of compensation deferred. Additional profit-sharing amounts may be contributed at the option of the Company's Board of Directors. No profit-sharing contribution was authorized for the 2024 plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures

Forfeitures of nonvested Company contributions and earnings thereon are used to reduce future Company contributions and pay administrative expenses. At December 31, 2024 and 2023, there were \$125,305 and \$39,812, respectively, of unallocated forfeitures. In 2024, forfeitures of \$91,140, were used to reduce Company contributions and \$1,721 were used to pay administrative expenses.

Vesting

Participants are fully vested in the value of their employee-directed contributions to the Plan and the earnings thereon. Vesting in the remainder of their accounts, plus earnings thereon, is based on years of continuous service. Participants are 100% vested following three years of service.

Investments

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers self-directed brokerage accounts, various registered investment companies and a stable value collective trust fund as investment options for participants.

Notes Receivable From Participants

Participants may borrow from their accounts a maximum amount of \$50,000 not to exceed 50% of their vested account balance. The loan cannot exceed five years, except for loans to purchase a home, which can be ten years in length. Loans may be issued from any fund in which the participant has a balance, with repayments credited to the investment funds currently designated by the participant. Loans are secured by the balance in the participant's account and bear interest at the prime rate as reported by the *Wall Street Journal* as of the first day of the calendar quarter in which the participant's loan is processed, plus 1.0%. Principal and interest are paid through payroll deductions.

Payment of Benefits

Each participant is entitled to receive a distribution equal to his or her vested account balance upon his or her death, retirement, termination or disability in either a lump-sum amount or in annual installments over a ten-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. A participant may be eligible for an in-service withdrawal upon attainment of age 59 ½ or for hardship purposes as detailed in the plan.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Administrative Expenses

Certain expenses of administering and operating the Plan are paid by the Company. The Plan pays certain administrative expenses and transaction costs related to participant loans and investment fees. Investment fees are included in net appreciation (depreciation) in fair value of investments.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value as disclosed in Note 4.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participant's account balances.

Note 3. Information Certified by the Plan's Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income components and interest income from notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of shares of registered investment companies is determined by obtaining quoted market prices on nationally recognized securities exchanges (Level 1 inputs).

Self-directed brokerage accounts consist of investments in mutual funds, exchange traded funds, and common stocks. Fair values are obtained through quoted market prices on nationally recognized securities exchanges (Level 1 inputs).

Stable value collective trust fund value is based upon the net asset values of such funds as reported in the audited financial statements of the fund. Units of participation are redeemable upon receipt of unit holder's instruction based on the next determined net asset value per unit. Net asset value per unit is determined each business day.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Income Tax Status

The Plan and related trust documents has been filed with the appropriate agency and the sponsor has obtained a Non-standardized Pre-Approved Profit Sharing Plan opinion letter dated June 30, 2020, from the Internal Revenue Service stating that the Plan constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, each participant will be fully vested in the value of their account.

Note 7. Party-in-Interest Transactions

Certain plan investments are managed by Fidelity Investments, Inc., the trustee of the Plan, and therefore these transactions qualify as exempt party-in-interest transactions. Notes receivable from participants also reflects party-in-interest transactions. The Company provides certain administrative services at no cost to the Plan.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Note 1. Description of Plan

The following description of SIRVA Employee Savings Plan and Trust 401(k) Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan was established to enable employees to save toward retirement through payroll deductions. The Plan allows employees to put money into the Plan on a before-tax basis. Income taxes are generally not incurred by employees until the employee receives money from the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation.

On August 1, 2022, SIRVA, Inc. completed a strategic merger with BGRS, a direct competitor, and began operating as SIRVA BGRS Worldwide, Inc. The Plan previously sponsored by BGRS was frozen for participation as of December 31, 2022, with the merger and transferring of the assets into the Plan occurring on January 13, 2023.

General

The Plan covers all full-time and part-time employees of SIRVA, Inc. (Company) and participating subsidiaries that are not covered by a collective bargaining agreement. Employees become eligible to participate in the Plan following completion of 30 days of continuous service. Upon satisfying the Plan's eligibility requirements, employees are eligible to participate in the Plan as of the next payroll period.

Contributions

Participants may contribute up to 100% of eligible compensation, not to exceed the amount allowable under the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company may make discretionary matching contributions in the amount of 60% of the first 6% of compensation deferred. Additional profit-sharing amounts may be contributed at the option of the Company's Board of Directors. No profit-sharing contribution was authorized for the 2024 plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures

Forfeitures of nonvested Company contributions and earnings thereon are used to reduce future Company contributions and pay administrative expenses. At December 31, 2024 and 2023, there were \$125,305 and \$39,812, respectively, of unallocated forfeitures. In 2024, forfeitures of \$91,140, were used to reduce Company contributions and \$1,721 were used to pay administrative expenses.

Vesting

Participants are fully vested in the value of their employee-directed contributions to the Plan and the earnings thereon. Vesting in the remainder of their accounts, plus earnings thereon, is based on years of continuous service. Participants are 100% vested following three years of service.

Investments

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers self-directed brokerage accounts, various registered investment companies and a stable value collective trust fund as investment options for participants.

Notes Receivable From Participants

Participants may borrow from their accounts a maximum amount of \$50,000 not to exceed 50% of their vested account balance. The loan cannot exceed five years, except for loans to purchase a home, which can be ten years in length. Loans may be issued from any fund in which the participant has a balance, with repayments credited to the investment funds currently designated by the participant. Loans are secured by the balance in the participant's account and bear interest at the prime rate as reported by the *Wall Street Journal* as of the first day of the calendar quarter in which the participant's loan is processed, plus 1.0%. Principal and interest are paid through payroll deductions.

Payment of Benefits

Each participant is entitled to receive a distribution equal to his or her vested account balance upon his or her death, retirement, termination or disability in either a lump-sum amount or in annual installments over a ten-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. A participant may be eligible for an in-service withdrawal upon attainment of age 59 ½ or for hardship purposes as detailed in the plan.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Administrative Expenses

Certain expenses of administering and operating the Plan are paid by the Company. The Plan pays certain administrative expenses and transaction costs related to participant loans and investment fees. Investment fees are included in net appreciation (depreciation) in fair value of investments.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value as disclosed in Note 4.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participant's account balances.

Note 3. Information Certified by the Plan's Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income components and interest income from notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of shares of registered investment companies is determined by obtaining quoted market prices on nationally recognized securities exchanges (Level 1 inputs).

Self-directed brokerage accounts consist of investments in mutual funds, exchange traded funds, and common stocks. Fair values are obtained through quoted market prices on nationally recognized securities exchanges (Level 1 inputs).

Stable value collective trust fund value is based upon the net asset values of such funds as reported in the audited financial statements of the fund. Units of participation are redeemable upon receipt of unit holder's instruction based on the next determined net asset value per unit. Net asset value per unit is determined each business day.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Income Tax Status

The Plan and related trust documents has been filed with the appropriate agency and the sponsor has obtained a Non-standardized Pre-Approved Profit Sharing Plan opinion letter dated June 30, 2020, from the Internal Revenue Service stating that the Plan constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, each participant will be fully vested in the value of their account.

Note 7. Party-in-Interest Transactions

Certain plan investments are managed by Fidelity Investments, Inc., the trustee of the Plan, and therefore these transactions qualify as exempt party-in-interest transactions. Notes receivable from participants also reflects party-in-interest transactions. The Company provides certain administrative services at no cost to the Plan.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
