1. Description of Plan

The following description of the EMS-Chemie (North America) Inc. Retirement Plan (the "Plan") provides only general information. Participants may refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which provides retirement benefits to eligible employees of EMS-Chemie (North America) Inc. (the "Company"). Employees are immediately enrolled in the Plan upon employment and are immediately eligible to share in the Company's contributions. After one month of employment, employees may commence salary deferral contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute up to 100 percent of their eligible compensation, as defined in the Plan, subject to limitations specified by law. Participants who have attained the age of fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified benefit plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically-enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. The Plan also includes an auto-escalation provision whereby each participant's deferral rate is increased by 1%, annually, up to a maximum deferral rate of 6%, unless the participant affirmatively elects not to increase their deferral rate. The Company makes safe harbor non-elective contributions equal to 6% of eligible compensation for all eligible employees. For the years ended December 31, 2024 and 2023, safe harbor non-elective contributions totaled approximately \$836,000 and \$680,000, respectively. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts

Each participant's account is credited with the participant's elective deferral contributions, employer safe harbor non-elective contributions, plus investment earnings or losses, and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of Plan (continued)

Vesting

Participants are immediately vested in their elective deferral contributions and employer safe harbor non-elective contributions, plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. Loan terms may not exceed five years, except for the purchase of a primary residence. The notes are secured by the balance in the participant's account. The loan interest rate, which is established when the loan originates, is equal to the prime interest rate plus 1% (8.50% at December 31, 2024). Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement a participant may, subject to certain conditions, elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or in annual installments over a five year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Hardship distributions are permitted upon demonstration of financial hardship.

All fully vested balances are available for distribution after the participant reaches the age of 59 ½.

Administrative Expenses

Fees related to third party administration, investment management services, loan transactions, and distributions to participants are charged directly to participant accounts and are included in administrative expenses. Certain other expenses to maintain the Plan are paid directly by the Company and are excluded from the financial statements. Investment-related expenses are included in net appreciation in the fair value of investments.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. Basis of Presentation and Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States ("US GAAP").

Estimates

The preparation of financial statements in conformity with US GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for a fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan's investments include the Principal Fixed Income Guaranteed Option, a fully benefit-responsive guaranteed interest contract with Principal Life Insurance Company ("Principal"). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed interest contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement for this Plan asset. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Company or other Company events that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Unrealized gains and losses from the guaranteed interest contract are not reported in the statements of changes in net assets available for Plan benefits as the account is presented at contract value.

Risks and Uncertainties

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that these changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for plan benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are classified as distributions.

Payment of Benefits

Benefit payments are recorded when paid.

3. Certified Information

Information disclosed in the accompanying financial statements as of and for the years ended December 31, 2024 and 2023, related to investments, notes receivable from participants, net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Principal Trust Company (the custodian of the Plan).

4. Fair Value Measurements

US GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs to the valuation methodology are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The Plan's mutual fund investments were valued using Level 1 inputs, based on quoted market prices of the shares held by the Plan.

The Plan's investments include collective trusts and a stable value fund that invest in a variety of fully benefit-responsive investment contracts. The collective trusts and stable value fund are valued at net asset value ("NAV") of units of the accounts. The NAV, as provided by the issuer, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held less the account's liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of these investments, the issuers reserve the right to temporarily delay withdrawal from the trusts in order to ensure that security liquidations are carried out in an orderly business manner.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

5. Income Tax Status

The Plan is a non-standardized pre-approved profit sharing plan with cash or deferred arrangement ("CODA"), provided by Principal, designed to be in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The IRS has determined and informed Principal by a letter dated June 30, 2020, that the non-standardized pre-approved profit sharing plan with CODA, as then designed, was in accordance with applicable sections of the IRC. Although the Plan has been amended and formally restated since the date of this letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

5. Income Tax Status (continued)

During 2024, operational errors were discovered related to non-elective contributions for certain participants stretching back to 2021, which resulted in an underpayment of such contributions to the Plan. Management has taken the necessary corrective actions to ensure that these errors have no impact on the Plan's tax-exempt status and to ensure that the impacted participants are made whole.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain tax positions that more likely than not would not be sustained upon examination by the IRS. No such liabilities were identified at December 31, 2024 and 2023. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

6. Party-in-Interest Transactions

Certain Plan investments are managed by Principal Trust Company, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for custodial, recordkeeping, and investment advisory services amounted to approximately \$56,000 and \$39,000 for the years ended December 31, 2024 and 2023, respectively. These transactions are exempt from the prohibited transaction rules of ERISA.

7. Subsequent Events

Management evaluated events and transactions after December 31, 2024 through October 10, 2025, the date the financial statements were available to be issued, for subsequent events, and determined there were no subsequent events to report.
