Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Richard E. 1. DESCRIPTION OF THE PLAN

The following description of the Richard E. Pierson Construction Co., Inc. 401 (k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the Companies meeting the plan requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The participating employers of this plan are Richard E. Pierson Construction Co., Inc., and Richard E. Pierson Materials Corp.

Employees can become a participant as of the first day of the Plan year in which the employee completes the age and service requirements. The employee must be aged twenty and complete one year of service.

Contributions

Each year, the participants may contribute an amount equal to a maximum of 20% of their gross wages, subject to deferral limitations under federal law. The Companies elected a Safe Harbor Cash or Deferred Arrangement (CODA) for all participants. In 2024, the Companies made matching contributions totaling \$975,909.

Participant accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, safe-harbor contributions, and actual earnings thereon. Vesting in the Company's matching and profit-sharing contributions is based on years of continuous service. A participant is fully vested after 5 years of service. Participants are 100% vested in special non-elective contributions at the time of contribution.

Payment of benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the account, or installments over a period not to exceed the life expectancy of the participant or designated beneficiary.

Participant loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum value of 50% of their vested account balance. Loan transactions are treated as a transfer from the investment fund to the participants' fund. Loan terms generally range from 1 to 5 years. The loans are secured by the balance in the participants account and bear interest at a rate commensurate with local prevailing rates as determined by the trustee. Principal and interest is paid ratably through weekly payroll deductions.

Forfeited accounts

Forfeited amounts will be used to reduce future employer contributions. In 2024, there was no reduction in employer contributions from forfeited non-vested accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following accounting policies, which conform with generally accepted accounting principles, have been used consistently in the preparation of the Plan's financial reports:

Basis of accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Risks and uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statement of Net Assets Available for Benefits.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by participating employers and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Payments of benefits

Benefit payments are recorded when paid.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date and all dividends are reinvested into the Plan. Net appreciation (depreciation) in fair value of investments includes the Plan's realized and unrealized gains and losses held or sold during the year and indirect investment expenses.

Payments of benefits

Benefit payments are recorded when paid.

Subsequent events

Subsequent events were evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY TRUSTEE (UNAUDITED)

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, Ascensus Trust Company has certified the following information, which has not been subject to audit by independent auditors, to be complete and accurate:

- Investment and notes receivable from participants' balances included in the statements of net assets available for benefits at December 31, 2024 and 2023, and in the notes to the financial statements.
- Investment income (loss) and interest income on notes receivable from participants included in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and in the notes to the financial statements.
- Information included in the accompanying schedule of assets (held at end of year).

4. TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the letter of determination. However, the plan administrator and the plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

In accordance with ASC 740, Income Taxes, the Plan has evaluated all uncertain tax positions and deems that more likely than not, all positions taken will be sustained under examination. Positions taken prior to 2021 are no longer subject to examination. The Plan recognizes interest accrued related to unrecognized income tax benefits in interest expense and penalties in administrative expense. No such interest or penalties were recognized during 2024. The Plan is subject to examination by the IRS for the tax years ending 2021, 2022 and 2023, generally for three years after they are filed.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Companies have the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the participants will become 100 percent vested in their accounts.

6. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments held during 2024 and 2023 are managed by Vanguard. Vanguard is the recordkeeper for the Plan; Ascensus, Inc. (Ascensus) is retained as a sub-contractor to provide services under the terms of the recordkeeping agreement. Accordingly, transactions with Vanguard and Ascensus qualify as party-in-interest transactions.

The recordkeeper provides certain administrative services to the Plan pursuant to the recordkeeping service agreement. The recordkeeper also receives revenue from registered investment company service providers for services provided to the funds. This revenue is used to offset certain amounts owed to the recordkeeper for its administrative services to the Plan.

Amounts received by the recordkeeper from such registered investment company service providers in excess of the amount owed under the agreement are remitted to the Plan's trust. Such amounts are applied to pay Plan administrative expenses. During 2024, there were no excess amounts. The Plan Sponsor pays for administrative expenses not covered by revenue sharing.

The Plan issues loans to participants, which are secured by the participants' account balances. These transactions qualify as party-in-interest transactions.
