1. Description of the Plan

The following description of the Epec, LLC 401(k) Plan (the "Plan") is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

General

The Plan is a defined contribution plan covering all employees of the sponsoring organization Epec, LLC and a related employer, Liberty Electric Sales, Inc., (collectively the "Employer"). All employees who have attained the age of 18 and completed 1 month of service, except for leased employees and residents of Puerto Rico, are eligible to participate in the Plan, ("Participants"). Employees may enter the Plan on the first day of the month coinciding with or next following the date on which they meet the eligibility requirements. Fidelity Management Trust Company ("FMTC") provides asset custodian services and also serves as trustee for the Plan. Fidelity Workplace Services, LLC ("FWS"), an affiliate of FMTC, provides recordkeeping services for the Plan. The Plan is subject to the provisions of the Internal Revenue Code (the "IRC") and the Employee Retirement Income Security Act of 1974 ("ERISA"). All investments are participant-directed.

Plan Administration

The Employer is the Plan administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan. Individual Participant accounts may be charged directly with an allocation of administrative expenses, if not paid by the Employer. If paid by the employer, then administrative expenses are excluded from these financial statements.

Participant Contributions

Each year, Participants may defer up to 100% of their eligible compensation, as defined by the Plan document, not to exceed a dollar limit established under the IRC. Participants may make pre-tax or Roth contributions to their accounts. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans ("Participant Rollovers").

Employer Contributions

Each year, the Employer will contribute a safe harbor matching contribution equal to the sum of 100% of the amount of the Participant's elective deferrals that do not exceed 3% of the Participant's eligible compensation and 50% of the next 2% of Participant's elective deferrals of the Participant's eligible compensation, as defined in the Plan document. All Participants who are eligible and deferring into the Plan are eligible for the employer safe harbor matching contribution. The total employer safe harbor matching contributions were \$345,021 for the year ended December 31, 2024.

The Employer, at its discretion, may make non-elective contributions to the Plan. Non-elective contributions are allocated to each eligible Participant so that each such eligible Participant receives an amount that is identical to the amount received by all other eligible Participants in the Participants' group. The Participant group consists of all eligible employees of Epec, LLC, excluding the owner of the Employer and related employers.

Employer Contributions (continued)

To be eligible, Participants must have reached the age of 18, earned at least 500 hours of service during the Plan year and be employed by the Employer on the last day of the Plan year. For the year ended December 31, 2024, the Employer elected to make a non-elective contribution in the amount of \$200,000.

Participant Accounts

Each Participant's account is credited with the Participant's contributions, the respective employer contributions, an allocation of the Plan's investment earnings or losses, and is charged with an allocation of certain expenses. Allocations are based on Participant compensation or account balance, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account balance.

Vesting

Participants are immediately vested in their Participant deferral contributions, rollover contributions, and Employer safe harbor matching contributions plus allocated earnings thereon. Participants begin vesting in Employer non-elective contributions plus actual earnings after two years of service and become fully vested after six years of service. Upon death, disability, or attainment of normal retirement age, a Participant is fully vested in all of their accounts.

Payment of Benefits

Upon termination of service due to death, disability, termination, or retirement, a Participant or beneficiary may elect to receive a lump-sum distribution in an amount equal to the value of the Participant's vested interest in his or her account. The payment can either be a cash distribution to the Participant or a tax free rollover to another qualified plan. If a terminated Participant's vested account balance is less than \$7,000, the plan administrator, after notification, may distribute the account balance to the Participant in a lump-sum payment.

In-service withdrawals from all Participants' vested account balances are permitted upon reaching age 59 ½, an active military distribution, a qualified reservist distribution, a normal retirement age distribution or disability. In service withdrawals are also allowed due to financial hardship, as defined in the Plan document, from Participant deferral accounts and subject to a \$500 minimum.

1. Description of the Plan (continued)

Notes Receivable from Participants

Subject to approval by the Plan administrator, Participants may borrow from their accounts up to a maximum amount equal to the lesser of \$50,000 reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made or 50% of their vested account balance. Loan terms range from one to five years (or longer for the purchase of a primary residence).

Loans are secured by the vested balance in the Participant's account and bear interest at a fixed rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions or by check if the employee has terminated employment. If a Participant ceases to make loan payments and the plan administrator deems the loan to be in default, the Participant's loan balance is reduced and a benefit payment is deemed to have been made in accordance with the Plan document.

Interest rates for outstanding loans range from 4.25% to 9.50% at December 31, 2024 and 2023 and mature at various dates through November 2029.

Forfeitures

A Participant who leaves the employment of the Employer forfeits any non-vested balance. Forfeited balances of terminated Participants' accounts are used to pay administrative expenses and to reduce Employer safe harbor matching or non-elective contributions. During 2024, \$14,187 of forfeitures were used to reduce Employer safe harbor matching contributions. At December 31, 2024 and 2023, there were \$219 and \$13,032 unused forfeiture balances, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investments, Investment Valuation, and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investments, Investment Valuation, and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Mutual funds: As of December 31, 2024 and 2023, mutual funds amounted to \$10,202,961 and \$8,207,196, respectively, which are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are valued using the level 1 fair value measurement.

Payment of Benefits

Benefit payments to Participants are recorded during the period in which they are paid.

Notes Receivable from Participants

Loans to Participants are reported as notes receivable from Participants at the unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from Participants is recognized on the accrual basis of accounting. Related fees are recorded as administrative fees and expensed when incurred.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and in the ERISA-required supplemental Schedule H, Part IV, Line 4i, Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the FMTC, trustee for the Plan, a qualified institution.

4. Risks and Uncertainties

The Plan invests in investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

5. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of such termination, Participants will become fully vested in their accounts. Any unallocated assets of the Plan will be allocated to participant accounts and distributed in such a manner as the Employer may determine.

6. Tax Status

The underlying prototype non-standardized pre-approved profit sharing plan has received an opinion letter from the Internal Revenue Service ("IRS"), dated June 30, 2020, stating that the form of the plan is qualified under Section 401(a) of the IRC and that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the opinion letter, however, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan is qualified as of the financial statement dates.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. It is the Plan's policy to account for any uncertainties as described under the income tax laws. Under the income tax laws, the tax-exempt status of the Plan is considered a tax position. No such uncertain tax positions have been recognized by the Plan.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party-In-Interest Transactions

Plan investments include shares of mutual funds managed by Fidelity Investments, an affiliate of FMTC.
