The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Organichem Corporation Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's selection of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Organichem Corporation Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 — PLAN DESCRIPTION

The following brief description of the Organichem Corporation Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined benefit pension plan adopted as of October 1, 1994, to cover individuals who are employed by Organichem Corporation, a wholly owned subsidiary of Curia Global, Inc. (the “Company”), formerly known as Albany Molecular Research, Inc. Organichem Corporation was formerly known as Nycomed Inc.-Rensselaer (“Rensselaer”), a division of Nycomed Inc. (“Princeton”). On December 22, 1999, management of Rensselaer purchased the facility from Princeton and named the new company Organichem Corporation. Organichem Corporation took sponsorship of the Plan on January 1, 2001. Organichem Corporation became a wholly owned subsidiary of the Company as of February 12, 2003. This Plan includes individuals who prior to October 1, 1994, were employed by Sterling Winthrop Inc. (or subsidiary corporations or affiliates thereof). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. Albany Molecular Research Inc. was acquired by affiliates of The Carlyle Group and affiliates of GTCR LLC, effective August 31, 2017.

Freezing of Plan

On August 1, 2003, the Company froze the Plan effectively ceasing all future participation and benefit accruals for salaried employees. On March 1, 2004, the Company froze the Plan for Hourly Employees effectively ceasing all future participation and benefit accruals for hourly employees (Hourly Employees). Effective January 1, 2007, the Company merged the Plan for Hourly Employees with the Plan. Employees who worked for the Company on August 1, 2003 (March 1, 2004 for Hourly Employees) will continue to earn credit for years of service with the Company for vesting purposes and for purposes of eligibility, but not for purposes of pension calculations. Effective on or after the freeze date, participants accrue no additional benefits under the Plan.

Benefit Payments

The normal retirement date is the first day of the month following a participant’s 65th birthday. The participant’s benefit is determined by a computation based on years of service and final earnings (the highest average hourly regular earnings in any five consecutive years of service out of the last ten years of service effective as of the date of the freezing of the plan). Vested participants may elect early retirement between the ages of 55 and 65; however, benefits will be reduced by a percentage per year from the yearly benefit for each year, and proportionately for each month, that the retirement benefit starting date precedes age 62 (age 60 for Hourly Employees). A vested participant who terminates for any reason other than retirement, disability, or death is entitled to the monthly vested termination benefit beginning on the normal retirement date in the amount of the accrued benefit.

In the event of the death of a participant, prior to retirement, death benefits are paid to a beneficiary assigned by the participant. Death benefits are paid monthly to the beneficiaries and will typically be 50% of the amount a participant would have received, reduced to take into account the difference between the participant’s age and the age of the participant’s spouse or other beneficiary. In no event will this benefit exceed the amount that would have been payable to the participant if he or she lived until their normal retirement date and were paid in the form of a 50% joint and survivor annuity.

Benefit Payments (Continued)

Participants may elect to receive their distributions, subject to certain plan provisions, in some form of an annuity. If the participant's accrued benefit is \$5,000 or less, the participant is paid a lump-sum payment as soon as practicable after his or her termination date.

Participation

Generally, all employees who had attained 21 years of age and had completed one year of credited service prior to the applicable freeze date were eligible to participate in the Plan. Participants attained 100% vesting after five years of credited service from the date of employment.

Funding Policy

The Company's funding policy is to make annual contributions to the Plan in amounts that are sufficient to provide the retirement benefits and survivor's benefits, if any, for each participant as set forth in the Plan and to meet the minimum funding requirements under ERISA.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of its investments includes gains and losses on investments bought and sold as well as held during the year.

Investment Management Fees and Administrative Expenses

All investment management fees and administrative fees other than the Plan audit fees and the Pension Benefit Guarantee Corporation (PBGC) premiums paid by the Company were paid from the Plan assets for the years ended December 31, 2024 and 2023.

Subsequent Events

The Plan has evaluated subsequent events for potential recognition and/or disclosure through October 7, 2025, the date the financial statements were available to be issued.

NOTE 3 — INFORMATION CERTIFIED BY PLAN'S TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, SEI Private Trust Company, the trustee, has certified to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the investment activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, the supplemental schedule of reportable transactions for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 — FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of December 31, 2024 and 2023, level 1 inputs were utilized to measure fair value of all of the Plan's assets that are reported at fair value.

NOTE 5 — ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS

Accumulated plan benefits represent the estimated future periodic payments, including lump-sum distributions, under the Plan’s provisions that are attributable to the services rendered by the employees through the valuation date. Accumulated plan benefits include benefits expected to be paid to the following: (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. The accumulated plan benefits for active employees are based on their average compensation during the five years ended on the date as of which the plan was frozen then updated to the valuation date. Benefits payable under all circumstances – retirement, death, disability, and termination of employment – are included, to the extent they are deemed attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits is determined by the Plan’s actuary, and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuations are as follows:

NOTE 6 — PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth by ERISA. Certain benefits under the Plan, if the Plan terminates, are insured by the Pension Benefit Guaranty Corporation (PBGC).

In the event of termination of the Plan, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- a) Benefits attributed to employee contributions, if any;
- b) Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination;
- c) Other vested benefits insured by the PBGC up the applicable limitations;
- d) All other vested benefits; and
- e) All non-vested benefits.

Certain benefits under the Plan are insured by the PBGC if the plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, a statutory ceiling exists, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees. For plan terminations occurring during 2024 that ceiling is \$7,108 per month. That ceiling applies to those pensioners who elect to receive their benefits in the form of a single-life annuity and are at least 65 years old at the time of retirement or plan termination (whichever comes later). For older annuitants, the corresponding ceilings are actuarially adjusted upward. For younger annuitants or for those who elect to receive their benefits in some form more valuable than a single-life annuity, the corresponding ceilings are actuarially adjusted downward.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Company and the level of benefits guaranteed by the PBGC.

NOTE 7 — TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 11, 2008, that the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan was not timely amended to bring it into compliance with the requirements of the Pension Protection Act of 2006. The Plan was amended and restated effective January 1, 2022 under a Voluntary Fiduciary Correction Program (VFCP) submission in October 2022. In August 2023, the Company received an acknowledgement letter from the IRS, stating that the corrective action taken is consistent with the requirements of the VFCP.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 — PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are units of mutual fund accounts with SEI Private Trust Company, the Plan's trustee as defined by the Plan for the years ended December 31, 2024 and 2023 and, therefore, these transactions qualify as party-in-interest transactions.

NOTE 9 — RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Description of Actuarial Methods

Asset Valuation Method

The Actuarial Value of assets used in the development of plan contributions phases in recognition of the difference between the actual return on Market Value and the expected return on Market Value over a three-year period at 33.33% per year. The Actuarial Value is adjusted, if necessary, to comply with the IRC Sec. 430 requirement that the Actuarial Value of assets be within the range of 90% to 110% of the Market Value of assets. This method is equivalent to the smoothed market value method without phase-in described in Approval 3.16 of Revenue Procedure 2000-40. This was first used for the 2009 valuation.

Actuarial Cost Method

Funding Target Liability: Unit Credit Actuarial Cost Method.

Maximum Liability: Projected Unit Credit Actuarial Cost Method. The allocation of projected benefits between past years and future years is in proportion to the applicable rates of benefit accrual under the Plan.

Description of Actuarial Assumptions

Changes in Actuarial Assumptions as of January 1, 2024

The valuation reflects changes in the actuarial assumptions listed below. (The assumptions used before and after these changes are more fully described in the next section.)

- Mortality

With the exception of the valuation interest rate, the assumptions indicated were changed to represent the Enrolled Actuary's current best estimate of anticipated experience of the Plan.

Interest Rates

The American Rescue Plan Act of 2021 (ARPA) was signed into law on March 11, 2021. ARPA continues to use a 24-month bond averaging period methodology for determining the segmented interest rates used in the calculation of the Plan's target liability and a corridor based on a 25-year bond averaging period. However, now the corridor based on 25-year average segment rates and the applicable minimum and maximum percentages used for purposes of calculating the Plan's target liability to adjust the 24-month average segment rates has been extended. In addition, any 25-year average segment rate that is less than 5% is deemed to be 5%.

The Infrastructure Investment and Jobs Act was signed into law on November 15, 2021 that further extended funding stabilization. The corridors under the new laws are as follows:

This exhibit summarizes the major provisions of the Plan. It is not intended to be, nor should it be interpreted as a complete statement of all plan provisions. To the extent that this summary does not accurately reflect the plan provisions, then the results of this valuation may not be accurate.

Effective date

January 1, 2000.

The Organichem Corporation Pension Plan for Hourly Employees (ICWU-C) was merged into the Organichem Corporation Retirement Plan on December 31, 2006.

Plan year

The calendar year.

Participation

No new participants are permitted as of August 1, 2003 for the Salaried Plan and as of March 1, 2004 for the Hourly Plan.

Vesting service

Salaried Plan: Each plan year of at least 1,000 hours of service, beginning at date of hire.

Hourly Plan: Year of service following age 18.

Accrued benefit

Salaried Plan: Effective August 1, 2003, benefits are frozen and no additional benefits shall accrue under the plan.

Hourly Plan: Effective March 1, 2004, benefits are frozen and no additional benefits shall accrue under the plan.

Normal retirement

Eligibility: The first day of the month coinciding with or next following age 65.

Benefit: Accrued benefit as of normal retirement date.

Early retirement

Eligibility: The first day of the month following the later of age 55 and 5 years of vesting service.

Benefit: Accrued benefit as of early retirement date.

Reduction factors: Salaried Plan: 4/12 of 1% for each month benefit commencement precedes unreduced early retirement date if terminate after age 55. If terminate prior to age 55, the reduction is 5/12 of 1% for each month early. Unreduced early retirement date is the first day of month coincident with or next following the date the participant attains age 62. (Note: Early retirement reduction factors are different under the Nycomed Plan formula.)

Hourly Plan: 0.25% for each month benefit commencement date precedes age 65 if under 60 (1/6% for each month if over 60). If termination is after age 55 and benefit commencement is on or after age 60 there is no reduction.

Late retirement benefit

Accrued benefit as of late retirement date.

Termination prior to retirement

Vesting schedule: 100% after completion of 5 years of vesting service.

Benefit: Vested portion of accrued benefit as of date of termination, first payable upon normal retirement eligibility. Earlier benefit commencement may be elected, subject to early retirement eligibility and reduction factors.

Death prior to retirement

Salaried Plan: Completion of 5 years of vesting service. Must be married for at least 12 months prior to death.

Surviving spouse's benefit is 50% of the benefit that would have been payable to the participant if the participant had: (1) terminated immediately before death, (2) elected to retire at earliest retirement eligibility, or date of death if later, and (3) elected a 50% joint and survivor annuity. The surviving spouse's benefit is first payable on the date that would have been the participant's earliest retirement date. If the participant had already satisfied early retirement eligibility, the surviving spouse's benefit is payable immediately.

Hourly Plan: Return of member contributions with interest or, if vested, Survivor's Benefit may be paid to an eligible spouse or dependent.

Survivor's Benefit is 50% of normal retirement benefit based on service prior to death. Maximum benefit is that which would have been received on retirement at age 65 with a 50% Contingent Annuitant option in effect.

Form of benefit

Normal form: Life annuity. For married participants, payable as an actuarially equivalent 50% joint and survivor annuity.

Optional forms: Salaried Plan: Life annuity, 50%, 75%, and 100% joint and survivor annuity, or a life annuity guaranteed for the first 5 or 10 years.

Hourly Plan: Life annuity, 100%, 90%, 80%, 75%, 70%, 60%, or 50% joint and survivor annuity, a life annuity guaranteed for the first 5 or 10 years, or a level income benefit. Minimum benefit is return of excess employee contributions with interest over the aggregate amount of retirement benefit received prior to death.

Automatic lump sum: Payable immediately, without participant or spouse's consent, if the present value is \$1,000 or less.

Actuarial equivalence for optional forms (except lump sum)

Interest: Salaried Plan: 7% per year.

Hourly Plan: 6% per year.

Mortality: Salaried Plan: 1983 Group Annuity Mortality Table weighted 50% male and 50% female.

Hourly Plan: UP-1984.
