Notes to Financial Statements
December 31, 2024 and 2023

NOTE 1 – DESCRIPTION OF PLAN

The following description of Brevillier Village Foundation, Inc.'s 401(k) Profit Sharing Plan (herein "Plan") of Brevillier Village Foundation, Inc. (herein "Employer") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is an employer-matching, salary reduction plan under Internal Revenue Code Section 401(k) covering all employees who have attained age twenty-one. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Employee

Employees, age 21 and older with no minimum service requirement, may elect to make salary reduction contributions from 1% to 100% of compensation, as defined by the Plan, up to the maximum annual employee salary reduction contribution permitted under the Internal Revenue Code, and is adjusted annually.

Employer

The employer will match 100% of the salary reduction amount that does not exceed 3% of the employee's compensation, subject to the employee having twenty-four months of service. In no event may total contributions allocated to an employee during a plan year exceed lesser of (a) maximum contributions allowed under the Internal Revenue Code, or (b) 25% of an employee's compensation for the plan year. All contributions are invested in various investment funds maintained at Mutual of America Life Insurance Company (herein "Mutual of America").

Participant Accounts

Each participant's account reflects (a) participant's salary reduction contributions; (b) participant rollover contributions; (c) employer's matching contributions; (d) an allocation of employer base contributions; (e) an allocation of any forfeited amounts of former participants, based on account balances at the time of allocation; (f) an allocation of earnings and increases/decreases in the value of the account; (g) any payments or withdrawals on the participant's behalf from the account; and (h) an allocation of any administrative fees and expenses paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are at all times 100% vested in employee salary reduction contributions and all employer contributions, plus actual earnings thereon.

Participant Notes Receivable

Participants may receive loans from the Plan. Loan amounts may not exceed the lesser of (i) fifty percent (50%) of the participant's vested account or, (ii) \$50,000. There is a \$1,000 minimum loan amount. Loans must be repaid in level periodic payments of, generally, no more than five (5) years from the date of the loan. Participant loans will carry a commercially reasonable interest rate.

A participant must secure each loan with a pledge of not more than 50% of the participant's vested account balance.

Investment and Allocation Options

Upon enrollment in the Plan, a participant may direct amounts contributed on her/his behalf to any of various investment options, as periodically made available by the Plan. Participants may change their investment options and allocations at their discretion.

Payment of Benefits

Retirement Benefits - A participant may elect to retire and receive her/his vested benefit any time on or after attaining age 55. Retirement benefits will be provided as either (a) a single lump-sum payment equal to the total value of a participant's vested account, or (b) one of several annuity options under the Plan providing a monthly income for a participant's lifetime or a term certain. In lieu of an annuity, if a participant's vested account balance is \$1,000 or less, a lump-sum payment of the participant's account will be made.

Disability Withdrawals - While employed, participants may withdraw employee salary reduction contributions and vested employer contributions, if they become disabled.

Other Withdrawals - After reaching age 59 1/2, or after termination of service, participants may withdraw employee salary reduction contributions. Vested employer contributions may be withdrawn after a participant's termination of service with the employer.

Forfeitures

Forfeitures from participant accounts are allocated among the remaining participant accounts based on the balance of those accounts at the time of the allocation.

Administrative Expenses

All administrative expenses of the Plan are paid directly by the employer.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

Plan Termination

Although it has not expressed any intention to do so, the employer has the right at any time to amend the Plan document to discontinue future matching contributions or to terminate the Plan, subject to the provisions of ERISA. In the event that the Plan is terminated, participants are 100% vested in their accounts.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared in accordance with generally accepted accounting principles ("GAAP") in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest is reported on the accrual basis. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. Interest on participant loans is recognized as payments are received with unpaid interest included in the loan balance.

Investment Valuation and Income Recognition

Investments are stated at fair values. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Mutual funds are valued at quoted market prices that represent the net asset value of shares held by the Plan at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when credited to the respective investment mutual fund. Net appreciation (depreciation) includes the Plan's realized and unrealized gains and losses on investments bought and sold, as well as, held during the year.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Unadjusted quoted prices available in active markets for identical investments as of the reporting date.
- Level 2 – Observable inputs to the valuation methodology are other than Level 1 inputs, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies.
- Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability, and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

The Plan's policy is to recognize significant transfers between levels at the actual date of the event or circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers in or out of Levels 1, 2 or 3.

Payment of Benefits

Benefits are recorded when paid.

Income Tax Status

The Plan has received a favorable determination letter dated October 25, 2011 that finds the Plan was designed in accordance with the applicable IRC requirements and, therefore, the related trust is not subject to tax under current tax law. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its tax qualification. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, as a result, no provision for income taxes has been included in the financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the financial statements.
