## INDEPENDENT AUDITOR'S REPORT

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audits***

We have performed audits of the financial statements of Helix Environmental Planning 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

## HELIX ENVIRONMENTAL PLANNING 401(K) PROFIT SHARING PLAN

### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

#### NOTE 1: DESCRIPTION OF PLAN

The following description of Helix Environmental Planning 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

##### **General**

The Plan is a defined contribution plan established January 1, 1998 to provide retirement benefits for substantially all employees of Helix Environmental Planning Inc. (the “Plan Sponsor”) and its related participating employer, Helix Construction Group, Inc. (collectively referred to as the “Company”). Employees are eligible to participate upon attainment of 21 years of age and completion of six months of service. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (the “Code”) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is governed by an administrative committee, who monitors investment performance and determines the Plan’s investment offerings and reports to the Board. Empower Trust Company, LLC, serves as the trustee of the Plan.

The Plan was amended effective June 1, 2024 to allow as-needed hourly employees and independent contractors to participate, remove the 1,000 hours of service requirement, and remove the requirement for 6 months of service to be consecutive months. The amendment also states that the Safe Harbor and discretionary match for the as-needed hourly employees will be deposited into this Plan.

##### **Plan Year**

The Plan year begins January 1<sup>st</sup> and ends December 31<sup>st</sup>.

##### **Contributions**

The Plan allows for the following types of contributions:

- **Employee Salary Deferral Contributions**  
The Plan includes an elective salary deferral arrangement pursuant to Section 401(k) of the Internal Revenue Code. Employees may voluntarily contribute a portion of their compensation, subject to various limitations prescribed by the Code. The Plan also allows participants to make Roth salary deferral contributions.
- **Rollover Contributions**  
Employees may make rollover contributions from another qualified plan.
- **Employer Safe Harbor Contributions**  
The Plan permits the Plan Sponsor to contribute safe harbor contributions equal to 3% of eligible employee compensation. Safe Harbor contributions are funded into the Helix Environmental Planning, Inc. Employee Stock Ownership Plan except for as-needed employees which are funded to this Plan. The Plan Sponsor made safe harbor contributions of \$609,210 and \$554,107 to the Helix Environmental Planning, Inc. Employee Stock Ownership Plan for the years ended December 31, 2024, and 2023, respectively. The Plan Sponsor made safe harbor contributions of \$21,513 and \$0 to the Helix Environmental Planning, Inc. 401k Profit Sharing Plan for the years ended December 31, 2024 and 2023, respectively.

**NOTE 1: DESCRIPTION OF PLAN (Continued)**

- **Employer Discretionary Contributions**  
The Plan Sponsor may make a discretionary profit sharing and/or matching contribution in an amount determined by the Plan Sponsor for eligible employees. For employer discretionary profit sharing contribution, participants must be employed on the last day of the Plan year. The Plan Sponsor made an employer discretionary matching contribution in the amount of \$211,822 and \$122,470 for the years ended December 31, 2024, and 2023, respectively.
- **Employer Prevailing Wage Contribution**  
The Plan Sponsor will make an employer contribution for an employee participating in a prevailing wage service. Amount of contribution will be determined based on the required contribution rates for the employment classifications under the applicable federal, state or municipal prevailing wage laws. Employees participating in a prevailing wage service are immediately eligible for an employer prevailing wage contribution and are subject to special rules that apply without regard to other provisions under the Plan. Prevailing wage contributions amounted to \$84,128 and \$196,985 for the years ended December 31, 2024 and 2023, respectively.

**Participant Accounts and Allocations**

The Plan allows participants to direct their account balances and contributions among various investment options in self-directed accounts. Participants are allowed to direct their investments to a single fund or a combination of funds. Investment earnings and losses are allocated to participants' accounts based on the earnings or losses of the investments selected. The benefit to which a participant is entitled is limited to the vested interest in their individual account.

**Retirement**

Normal retirement under the Plan is the age 65.

**Payment of Benefits**

Payment of benefits may be made at the following times under the Plan: 1) normal retirement; 2) termination of employment of the participant; 3) in-service at 59½; 4) total disability; 5) upon demonstration of financial hardship; or 6) death of the participant. Benefit payments are distributed to participants in a single lump sum or installments for required minimum distributions. The Plan will make a mandatory distribution to any participant who has severed employment and has a vested account balance of \$7,000 or less. Effective January 1, 2024, in accordance with the SECURE 2.0 Act, the threshold for mandatory distributions was increased from \$5,000 to \$7,000. The mandatory distribution will occur as soon as administratively feasible following termination.

**Forfeitures**

The Plan allows forfeitures to be used to reduce employer contributions or pay administrative expenses at the discretion of the Plan Sponsor. In 2024 and 2023, forfeitures of \$0 were used to reduce employer contributions. The Plan had \$13,017 and \$7,526 of forfeited account balances as of December 31, 2024 and 2023, respectively.

**Vesting**

Participants are 100% vested in their salary deferral, safe harbor contributions, and prevailing wage contributions. Employer discretionary contributions are subject to a six-year vesting schedule, increasing by 20% after the first two years of service until they are 100% vested in year 6.

For vesting purposes, a year of service is equivalent to 1,000 hours of service during the Plan year. Participants who sever employment as a result of death or disability become fully vested in their accounts.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested account balance. Borrowings bear interest at prime plus 1% and are due no later than five years. Loans taken for the purpose of acquiring a principal residence are repaid within ten years. Loans are secured by the balance in the participant's account.

**Administrative Expenses**

Administrative expenses of the Plan are paid by the Plan and the Plan Sponsor. Expenses related to specific participant transactions are charged to the respective participant's account. Expenses for investment management services are recorded as a reduction of net appreciation in fair value of investments reported by the fund manager.

*NOTE 2:* **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are maintained on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (U.S. GAAP).

**Investment Valuation and Income Recognition**

Investments are reported at fair market value. Fair market value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year. Changes in the unit values of investments are reflected in each participant's individual account. Investments are valued daily.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan payments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Income Taxes**

The Plan has adopted a prototype plan which obtained a favorable opinion letter on January 15, 2021, in which the Internal Revenue Service stated that the Plan is acceptable under Section 401 of the Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has determined that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine examinations by taxing authorities; however, there are currently no examinations for any tax periods in progress.

**Estimates and Assumptions**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**NOTE 3: INFORMATION CERTIFIED BY THE TRUSTEE**

**NOTE 4: FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) ASC 820 provides a framework for measuring fair value. That framework provides a three-tier hierarchy that prioritizes the inputs to valuation techniques used for measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are as follows:

- Level 1 - Inputs are unadjusted quoted prices for identical assets or liabilities that the Plan has the ability to access.
- Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, model-based valuation techniques for which all significant assumptions are observable in the market, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3 - Inputs that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 4: FAIR VALUE MEASUREMENTS (Continued)**

*Common Collective Trust:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**NOTE 5: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 6: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 7: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Plan assets include notes receivable from participants. Administrative expenses for recordkeeping services are paid to third party service providers. Fees paid by the Plan for recordkeeping services are recorded in administrative expenses. These assets and transactions qualify as party-in-interest and are exempt from the prohibited transaction rules of ERISA.
