## Independent Auditor's Report

Plan Administrator and Trustees  
Copper Queen Community Hospital 403(b) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Copper Queen Community Hospital 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE A – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

1. Basis of Presentation

The accompanying financial statements of Copper Queen Community Hospital 403(b) Plan (the Plan) have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

2. Valuation of Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date.

As described in the Accounting Standards Codification ("ASC") 946, *Financial Services – Investment Companies*, investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Purchases and sales are recorded on the trade date. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan presents, in the statement of changes in net assets available for benefits, the net change in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

3. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

**NOTE A – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED**

4. Participant Direction of Investments

Subject to the provisions of the Plan, a participant has the right to direct the investment of the balance in their accounts in the specific investment funds made available by the Plan administrator. At December 31, 2024 and 2023, all investments are participant directed.

5. Payments of Benefits

Benefits are recorded when paid.

6. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**NOTE B – DESCRIPTION OF THE PLAN**

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering substantially all employees of Bisbee Hospital Association DBA Copper Queen Community Hospital (the Employer). The Board of Trustees is responsible for oversight of the Plan. An employee is eligible to participate in salary reduction contributions upon hire. An employee is eligible for a discretionary Employer contribution after completing 90 days of service and reaching age 18. Employee salary reduction contributions are not required to receive the Employer discretionary contribution. Each employee meeting minimum eligibility requirements can enter the Plan as soon as feasibly possible.

**NOTE B - DESCRIPTION OF THE PLAN - CONTINUED**

1. General - Continued

The Employer is responsible for appointing an administrator, custodian and a trustee for the Plan. The trustee has discretionary powers in executing investment transactions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code (IRC). The operating costs are shared by the Employer and participants. Reasonable administrative and investment expenses of the Plan may be paid by the Plan to the extent not paid by the Employer.

2. Contributions

The Plan allows participants to contribute up to 100% of their eligible compensation, as defined in the Plan, subject to limits imposed by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as allowed by the IRC. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or contribution plans.

The Employer makes a discretionary, nonelective contribution of 3% of a participant's eligible compensation. Additional amounts may also be contributed at the option of the Employer's board of directors. There were no additional contributions made during the year ended December 31, 2024. The Employer may not make a contribution to the Plan for any plan year to the extent the contribution would exceed the participant's maximum permissible amount.

3. Participant Accounts

Each participant account is credited with the participant's contribution and an allocation of (a) the Employer's discretionary contributions, (b) Plan earnings and (c) administrative expenses. Allocations are based on participant compensation or account balances, as defined.

Changes in a participant's deferral percentage for future contributions may be made at any time. Reallocation of participant investment accounts among the investment options may be made at any time during the Plan year.

4. Vesting

Participants immediately vest in their employee contributions plus earnings thereon. Participants are not vested in Employer discretionary contributions plus earnings until they reach three years of service, at which point they are vested 100%.

**NOTE B - DESCRIPTION OF THE PLAN - CONTINUED**

5. Payment of Benefits

Upon termination of service, death, disability, retirement, or any reason permitted under hardship regulations, a participant may elect to receive either a lump sum distribution or installment payments equal to the participant's vested account balance. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If the participant's account balance is below \$7,000, the Plan required the balance to be automatically distributed. The Plan allows for in-service distributions for hardship or upon attainment of age 59 1/2.

6. Notes Receivable from Participants

Notes receivable from participants are permitted up to the lesser of one-half of their vested balance up to a maximum of \$50,000 for each participant. The loans are secured by the balance in the participant's account and bear interest at Prime plus 2%. Principal and interest rates are paid ratably through payroll deductions over a period not to exceed five years or not to exceed 15 years for purchase of a principal residence.

7. Forfeited Accounts

Forfeited accounts are used to defray the cost of administrative expense of the Plan or reduce future Employer match and discretionary contributions. As of December 31, 2024 and 2023, the balance of unapplied forfeitures of non-vested accounts is \$14,393 and \$10,352, respectively. For the year ended December 31, 2024, forfeitures used to reduce Employer contributions and pay Plan expenses totaled \$25,495.

8. Risks and Uncertainties

The Plan is comprised of a combination of investments. Investments are exposed to various risks, such as interest, market, and credit. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE D – FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (ASC) Topic 820, Fair Value Measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE D – FAIR VALUE MEASUREMENTS - CONTINUED**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market and mutual funds:* Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E – GUARANTEED INTEREST ACCOUNT**

The guaranteed interest account of the Massachusetts Mutual Life Insurance Company is fully benefit-responsive and seeks to maintain a stable \$1.00 unit value, although there is no guarantee it will be able to do so. The account is stated at contract value. Contract value represents contributions made under the underlying contracts, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. The Plan believes the occurrence of any event that may limit the Plan's ability to transact at contract value with participants is not probable. The investment in the guaranteed interest account is backed by the general assets of the issuer. The balance in the guaranteed interest account as of December 31, 2024 and 2023 was \$0 and \$19,379, respectively.

**NOTE F – FEDERAL INCOME TAXES**

The Volume Submitter Sponsor obtained its latest advisory letter dated June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended to meet IRS requirements since receiving the advisory letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date. There are no reconciling differences between the financial statements and the Form 5500 as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

The Plan's policy is to evaluate the likelihood that any uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decision, and other evidence. The federal income tax returns of the Plan are subject to examination by the IRS, generally for three years after they were filed.

**NOTE G – PARTY-IN-INTEREST TRANSACTIONS**

Mid Atlantic Trust Company DBA Atlantic Trust Custody is the custodian of the Plan and holds the Plan's investments. Wipfli LLP is the Plan's record-keeper, and executes the Plan's transactions. Creative Planning HoldCo, Inc. is the Plan's financial advisor.

**NOTE H – ADMINISTRATIVE EXPENSES**

The Plan pays administrative expenses that consist primarily of administrative fees to the custodians and third-party administrator. The Plan also pays all other administrative expenses, such as professional fees, to the extent not paid by the Employer on behalf of the Plan. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses.

**NOTE I – SCHEDULE OF DELINQUENT PARTICIPANT CONTRIBUTIONS**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the Employer’s general assets. Delinquent participant contributions for 2023 totaled \$123,122 and have been corrected as of December 31, 2024.

**NOTE J – SECURE ACT 2.0**

On December 29, 2022, President Biden signed into law the Consolidated Appropriations Act of 2023, which includes the package of retirement provisions referred to as “SECURE Act 2.0”. SECURE Act 2.0 contains over 90 new retirement provisions continuing the reforms that began with the 2019 SECURE Act. These provisions have varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. There is no material impact to the Plan’s 2024 financial statements.

**NOTE K – SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 7, 2025, the date which the financial statements were available to be issued.
