To the Trustees and Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **VILLAGE RETIREMENT COMMUNITIES 401(k) PLAN**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Village Retirement Communities 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Village Retirement Communities 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Village Retirement Communities 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Village Retirement Communities 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note A – Description of Plan:

The following description of the Village Retirement Communities 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan was established on January 1, 1995 and amended and restated on October 15, 2021 for the benefit of qualifying employees of the Village Retirement Communities, LLC and the following related entities; Future Lifestyle Consultants, LLC and Village at Waterman Lake LP (the "Companies or the "Employers"), as a defined contribution plan covering all employees. The Plan was established to provide employees of the Companies with an opportunity to accumulate funds for retirement or disability and to provide death benefits for employees' dependents and beneficiaries. The Plan is intended to be a qualified retirement plan under the Internal Revenue Code of 1986 ("IRC") as amended and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan allows traditional 401(k) deferral (pre-tax) contributions.

Participant contributions:

Eligible employees generally include all employees of the Companies. Employees become eligible for contributions at the age of 21 and after completion of one year of service. Eligible participants will be able to enter the Plan on the first day of the Plan year and the first day of the seventh month of the Plan year coinciding with or following satisfaction of eligibility requirements.

Subject to limitations issued by the Internal Revenue Service (the "IRS"), participants may elect to contribute to the Plan from 1% to 100% of pre-tax eligible earnings. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions), subject to certain limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer contributions:

Participants who have completed one year of service, are 21 years of age and have elected to participate in the Plan will receive a matching contribution equal to 33% of each participant's deferral up to \$1,000. In addition, the Companies may make additional profit-sharing contributions at the discretion of the Board of Directors. No profit-sharing contributions were made during the year ended December 31, 2024.

Participant accounts:

Each participant's account is credited with the participant's contributions and the Companies' contributions, and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations of the Companies' contributions, investment income and administrative expenses are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

Investment options:

Plan assets are held in a trust fund and are invested in the Plan's investment options at the direction of the participants, in accordance with the Plan document. In general, participants may move their assets among the Plan's investment options through a fund transfer, reallocation, or rebalance on any business day on which the financial markets are open.

Vesting:

Participants are immediately vested in their deferral and rollover contributions, including the earnings on those amounts. Vesting in the Companies' contribution portion of their accounts is based on years of continuous service as follows:

In the event of death, disability or attainment of the Plan's normal retirement age, a Participant becomes 100% vested in their total account balance.

Notes receivable from participants:

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. Loan terms range from one to five years, except for loans to purchase a primary residence, which may be offered over a term of up to 30 years. The loans are secured by the balance in the participants' accounts and bear interest at the Prime Rate. The notes currently bear interest at rates ranging from 3.25% to 8.50%. Participants may have two loans outstanding at any given time. Generally, principal and interest are paid ratably through payroll deductions.

As of December 31, 2024, and 2023, there were outstanding notes receivable from participants of \$175,694 and \$95,245, respectively.

Payment of benefits:

Upon retirement, disability, death or termination of employment, the participant shall become entitled to the total value of his or her vested account. Distributions may be paid in either a lump sum, partial payments, installments over a number of years, or to purchase an annuity contract, based upon election of the participant or as defined in the Plan or the IRC. If a participant terminates employment for any reason and his or her vested account balance does not exceed \$1,000, the plan administrator may distribute such amount in a lump-sum payment to the participant without the consent of the participant. If the participant's balance is between \$1,000 and \$5,000, the plan administrator may roll the amount into an individual retirement account on behalf of the participant without the consent of the participant.

The Plan also provides for in-service withdrawals by participants who have attained the age of 59½. Upon financial hardship, a participant is entitled to the value of his or her deferral accounts, which is payable immediately in a lump-sum distribution.

Forfeitures:

If a participant withdraws his or her vested amount, any non-vested discretionary matching and profit-sharing contributions are forfeited. All benefits forfeited remain in the Plan and are used to reduce future employer contributions to the Plan. Forfeited nonvested discretionary matching accounts totaled \$377 and \$1,401 at December 31, 2024 and 2023, respectively. No forfeitures were used to reduce Company matching contributions for the years ended December 31, 2024 and 2023.

Note B – Recently issued accounting pronouncements

Recent accounting pronouncements issued by the FASB did not or are not believed by management to have a material impact on the Plan's present or future financial statements.

Note C – Summary of significant accounting policies:

Financial statement presentation:

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan, if applicable.

The Plan invests in the MetLife Reliance Stable Value Fund Series 25053, which is a collective trust. The collective trust invests in fully benefit-responsive investment contracts issued by insurance companies and other financial institutions (see investment valuation and income recognition).

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, additions to net assets, deductions from net assets, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions.

Plan expenses:

Certain expenses of maintaining the Plan are paid directly by the Companies. Fees related to distributions and investment advisory services are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Financial instruments with a concentration of credit risk:

The Plan's investments are held by third party custodians. The Plan's exposure to credit risk is associated with the outside entity's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. The Plan also provides for various investment options which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

Note C – Summary of significant accounting policies (continued):

Financial instruments with a concentration of credit risk (continued):

Users of these financial statements should be aware that the financial markets' volatility may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

Notes receivable from participants:

Notes receivable from participants represent participant loans and are valued at their unpaid principal balance plus any accrued but unpaid interest, which approximates fair value. Management has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Investment valuation and income recognition:

The Plan's investments, mutual funds and collective trust, are stated at fair value. Mutual funds are valued using quoted market prices from national exchanges. Investments in collective trust funds, including the MetLife Reliance Stable Value Fund Series 25053 ("Stable Value Fund"), which is an indirect investment in a fully benefit-responsive investment, are valued using Net Asset Value ("NAV") as a practical expedient, and are recorded at the Plan's proportionate share of the contract value as determined by the fund manager. This is considered the fair value. Investment transactions are recorded on a trade date basis. Dividend income is recognized on the ex-dividend date. Investment income is recorded on the accrual basis.

Payments of benefits:

Benefits paid to participants are charged to expense during the period paid.

Subsequent events:

Plan management has evaluated subsequent events through October 7, 2025, the date that the accompanying financial statements were available to be issued.

Note D – Investments certified by plan trustees:

Information presented in the accompanying financial statements and supplemental schedule for investments, notes receivable from participants, net appreciation (depreciation) in fair value of investments, interest and dividend income and interest income on notes receivable from participants was derived, without audit, from information certified to be complete and accurate by Ascensus, LLC, as agent for Ascensus Trust Company, the trustee, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA and were not subject to auditing procedures.

Note E – Fair value measurements:

Investments held by the Plan are reported at fair value. The Plan's investment in the Stable Value Fund holds investment contracts that are deemed to be fully benefit responsive investment contracts ("FBRIC"), however, this is considered to be an indirect FBRIC investment and it is reflected at NAV as a practical expedient which is considered to be fair value. The NAV is equal to contract value of the underlying investment and is equal to the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals or transfers. The Stable Value Fund is not available for sale or transfer on any securities exchange. The contract value is a relevant measurement attribute because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Stable Value Fund's one-year total return was 2.92% for 2024 and 2.86% for 2023.

The thirty-day effective yield, also known as the crediting interest rate, was 3.01% and 2.82% for the Stable Value Fund at December 31, 2024 and 2023, respectively. The crediting interest rate is calculated on a daily basis. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The existence of certain conditions can limit the Stable Value Fund's ability to transact at contract value. Specifically, any event outside the normal operation of the Stable Value Fund that causes a withdrawal from an investment contract may result in a negative market value adjustment with respect to such withdrawal. Examples of such events include, but are not limited to, partial or complete legal termination of the Stable Value Fund or a unitholder, tax disqualification of the Stable Value Fund or a unitholder, and certain Stable Value Fund amendments if issuers' consent is not obtained. As of December 31, 2024, the occurrence of an event outside the normal operation of the Stable Value Fund that would cause a withdrawal from an investment contract is not considered to be probable. To the extent a unitholder suffers a tax disqualification or legal termination event, under normal circumstances it is anticipated that liquid assets would be available to satisfy the redemption of such unitholder's interest in the Stable Value Fund without the need to access investment contracts.

Generally accepted accounting principles establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Note E – Fair value measurements (continued):

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurements. Valuation techniques used need to maximize the use of observable inputs (that is, Level 1 and Level 2 inputs that do not require significant adjustment) and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual Funds - The Plan’s investments in mutual funds are valued at the quoted price of shares held by the Plan at year-end.

There have been no changes in the methodology used at December 31, 2024 and 2023.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses excluded in changes in net assets available for benefits are reported in net appreciation of fair value of investments.

Changes in economic conditions or valuation techniques may require the transfer of financial instruments from one fair value input level to another. The Plan’s policy is to recognize transfers between levels as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no significant transfers between levels. The Plan’s mutual funds are redeemable on a daily basis without restriction.

Note F – Party-in-interest transactions:

Ascensus, LLC is the recordkeeper for the Plan and Ascensus Trust Company is the trustee of the Plan. Certain investment and administrative expenses were paid to Ascensus, LLC and Ascensus Trust Company. Additionally, certain Plan investments are mutual funds managed by Morgan Stanley Global. Therefore, these transactions qualify as party-in-interest transactions for the years ended December 31, 2024. Fees incurred by the Plan for administrative services provided by the trustees, recordkeepers and investment management companies totaled \$36,514 for the year ended December 31, 2024.

Certain employees and officers of the Companies, who are also participants in the Plan, perform administrative services for the Plan at no cost to the Plan. Also, the Plan issues loans to participants, which are secured by balances in the participants’ accounts. These transactions qualify as party-in-interest transactions and are exempted from the prohibited transaction rules of ERISA.

Cavanagh CPAs & Associates, LLC, the auditor of the Plan’s financial statements, is also a party-in-interest as defined by ERISA.

Note G – Plan tax status:

On October 15, 2021, the Plan adopted a Non-Standardized Pre-Approved Profit-Sharing Plan with a cash or deferral arrangement and the Internal Revenue Service has determined and informed the Companies by a letter dated June 30, 2020, that the form of the Non-Standardized Pre-Approved Profit-Sharing Plan was designed in accordance with applicable sections of the Internal Revenue Code (“IRC”).

Although the Plan has been amended since receiving the most recent determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan files the Annual Return/Report of Employee Benefit Plan (Form 5500) in the U.S. federal jurisdiction. The Plan is no longer subject to U.S. federal tax examinations for years before 2021.

Note H – Plan termination:

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
