Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

**Other Matter—Supplemental Schedule Required by ERISA**

The supplemental schedule, schedule H, line 4i—schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

#### Note 1. Description of the Plan

The following description of Lund Food Holdings, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan was established to provide retirement benefits to certain qualified employees of Lund Food Holdings, Inc. and Subsidiaries (collectively, the Company). The Plan is a defined contribution plan sponsored by the Company and is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan operations:** The Plan is administered by the Company, which appointed Empower Annuity Insurance Company of America and Empower Trust Company, LLC as the trustees of the Plan. The trustees are responsible for holding the investment assets of the Plan and making benefit payments to participants. The Company determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Investment options:** Participants are allowed to invest in a variety of investment choices, as more fully described in the Plan's literature. All investment choices vary in types of investments, rates of return, and investment risk. Participants may elect at any time to have all or part of their account balances and future contributions transferred from one investment choice to another or in any combination.

**Participant accounts:** Each participant's account is credited or charged with the participant's contributions, employer contributions, allocations of Plan investment results and administrative expenses. Allocations are based on the earnings and losses of the participant's investments, participant account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Eligibility and vesting:** Substantially all nonunion employees of the Company who have attained the age of 18 are eligible to participate in the Plan in the form of employee deferrals on the first day of the month following their hire date and in the form of employer contributions following one year of eligible service and at the attainment of the age of 21. Employees must be employed on the last day of the plan year to be eligible for the discretionary profit sharing contribution.

A year of service is defined as 1,000 or more hours of service in a calendar year. Years of service prior to age 18 are disregarded for eligibility and vesting purposes. Service with prior entities acquired by the Company may qualify for determination of eligibility and vesting purposes, as defined by the Plan.

Employees are immediately fully vested in their own contributions to the Plan and Company matching contributions, pursuant to the safe harbor match rules, as of the date they become eligible to participate. Discretionary profit sharing contributions vest ratably and become fully vested upon completion of five years of service, attainment of age 62, total disability or death during the term of employment, or termination of the Plan.

**Contributions and allocations:** Participants may make pretax and Roth deferrals up to 100% of their eligible compensation to the Plan. However, the total amount deferred may not exceed the maximum allowed by law in any plan year. Participants at least age 50 or that will attain age 50 before the end of the calendar year can elect to defer additional amounts, called catch-up contributions, to the Plan for the year.

#### Note 1. Description of the Plan (Continued)

The Company's matching 401(k) contribution is a mandatory 100% of the participant's salary deferrals into the Plan, up to 3% of the participant's eligible compensation, plus 50% of the participant's salary deferrals between 3% and 5% of eligible compensation. Company profit sharing contributions to the Plan are discretionary, as determined by the Board of Directors of the Company. The Company's profit sharing contributions are allocated to each participant's account on the basis of the participant's eligible base compensation as a percentage of the total eligible base compensation received by all eligible participants. The Company did not pay out a profit sharing contribution for the year ended December 31, 2024.

**Benefits paid to participants:** The Plan provides for distributions upon retirement, death, total disability or other termination of employment. A participant or beneficiary will receive a lump-sum amount if the vested account balance is \$7,000 or less. If the vested account balance is greater than \$7,000, the participant or beneficiary may elect to receive a lump-sum amount, have the balance paid directly to an eligible retirement plan, receive benefits in the form of installments over time, or defer the payment of benefits. The Plan allows participants to withdraw funds from their account after the age of 59½. Participants may also withdraw funds derived from their own contributions to the Plan in the event of hardship, as defined by the Plan.

**Forfeitures:** Amounts forfeited by former participants are used to fund Company contributions to the Plan or pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeitures available for future use were approximately \$17,000 and \$91,000, respectively. In 2024, approximately \$113,000 was used to fund Company contributions.

**Notes receivable from participants:** Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the remaining balance in the participant's account and bear a reasonable rate of interest charged for similar types of notes by other lenders. Principal and interest are paid ratably through payroll deductions. Note terms may not exceed five years unless the note is for the purchase of a primary residence. Notes receivable from participants range in interest from 4.25% to 9.50% and mature at various dates through September 2034.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The accompanying financial statements have been prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors and trustees. See Note 4 for a discussion of fair value measurements.

#### Note 2. Summary of Significant Accounting Policies (Continued)

Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. Realized gains and losses related to sales of investments are recorded on a trade-date basis, and unrealized gains and losses are recorded based on investment values as of the end of the period being reported on.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, are included as an investment in the supplemental schedule, schedule H, line 4i—schedule of assets (held at end of year).

**Contributions:** Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of benefits:** Benefits are recorded when paid.

**Administrative expenses:** The Company paid a portion of the costs relating to administration of the Plan for the year ended December 31, 2024, which are excluded from these financial statements. The remainder of the administrative expenses are the responsibility of the Plan (see Note 10). Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts. In addition, certain investment-related expenses are charged against investment results presented in the accompanying statement of changes in net assets available for benefits.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

#### Note 3. Information Certified or Provided by the Trustees

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, which was prepared or derived from information provided by the trustees and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustees that the information provided to the Plan Administrator by the trustees related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets certified by the trustees:

The trustees also certified to the completeness and accuracy of \$8,477,982 of net appreciation in fair value of investments, \$2,630,637 of interest and dividend income from the aforementioned investments, and \$54,799 of interest income on notes receivable from participants for the year ended December 31, 2024.

#### **Note 4. Fair Value Measurements**

Accounting guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

**Mutual funds:** Shares of registered investment companies (mutual funds) are valued based on unadjusted quoted prices in active markets for shares held by the Plan at year-end.

**Pooled separate accounts:** Pooled separate accounts are valued at the net asset value (NAV) used as a practical expedient to estimate fair value, based on quoted market prices for the underlying securities or similar instruments.

**Collective trust funds:** Collective trust funds are valued at NAV per share used as a practical expedient to estimate fair value is based on the fair value of the observable market prices of the underlying assets held by the funds.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5. Investment Contract

The Plan was invested in Empower Annuity Insurance Company (Empower) Key Guaranteed Portfolio Fund. The fund was credited with interest earned based on the stated interest rates over the life of the contract. Withdrawals could be made at any time for the purpose of participant withdrawals or benefit payments at contract value. Empower was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The contract is included in the 2023 financial statements at contract value, as it is fully benefit-responsive.

During 2024, the Plan replaced the Key Guaranteed Portfolio Fund with other investment options, and thus, during the period ended December 31, 2024, participants with a balance in the fund had their balances transferred to other investment offerings, at their election.

#### **Note 6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that those changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

#### **Note 7. Termination**

Although it has not expressed any intent to do so, the Company reserves the right to partially or completely terminate the Plan, subject to Plan provisions. Upon a complete or partial termination of the Plan, all accrued benefits of affected employees shall become fully vested.

#### **Note 8. Transfer of Assets to and From the Plan**

The Board of Directors of Lund Food Holdings, Inc. created the Lund Food Holdings, Inc. 401(k) Plan solely for employees covered by eligible collective bargaining agreements. During 2024, net funds held by the Lund Food Holdings, Inc. 401(k) Plan totaling \$286,108 were transferred into the Plan. These transfers are the result of employees changing positions within the Company.

#### **Note 9. Tax Status**

The Plan adopted a nonstandardized form of a preapproved plan sponsored by Empower Retirement, LLC. The preapproved plan provider has received an opinion letter dated November 14, 2022, from the Internal Revenue Service (IRS) as to the preapproved plan's qualified status. The preapproved plan opinion letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 10. Related-Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds and investments in a guaranteed investment contract managed by the trustees. The trustees qualify as parties in interest. The Plan Administrator has approved these activities and transactions. A portion of the administrative costs for the Plan is paid directly by the Company. The remainder of the administrative expenses become the responsibility of the Plan. Administrative costs and audit fees paid by the Plan were approximately \$141,000 for the year ended December 31, 2024.
