A plan is top-heavy if over 60% of the value of all accrued benefits in all of the employer's plans are for the benefit of key employees. A key employee is generally an officer or owner of the company. This plan is currently top-heavy.

Actuarial Equivalent of the accrued benefit earned to date of death

**Change in Plan Provisions**

The Plan was Frozen Effective as of May 31, 2023. The Plan was unfrozen effective January 1, 2024 with the current formula.
