Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Magnolia Regional Medical Center 401(k) Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of fiduciary net position as of December 31, 2024 and 2023 and the related statements of changes in fiduciary net position for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from an agent on behalf of a qualified institution for the period of April 18, 2024 through December 31, 2024 and from a qualified institution for the period of January 1, 2023 through April 17, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1. Description of the Plan

General

The following description of Magnolia Regional Medical Center 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Magnolia Regional Medical Center (Hospital) for the benefit of its employees who are not excluded employees. An excluded employee is defined as a nonresident alien, union employee, leased employee, part-time employee (less than 1,000 hours in the relevant eligibility computation period), temporary employee, and seasonal employee. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Newport Trust Group was the custodian of the Plan from January 1, 2023 to April 17, 2024. Beginning April 18, 2024, Ascensus, LLC serves as the custodian of the Plan.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Hospital make annual contributions of up to the maximum amount allowed by law of their eligible compensation. Employee rollover and Roth contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Hospital may make discretionary matching and profit-sharing contributions as determined by the Hospital's board of directors. The Hospital's discretionary matching contribution was 3% for 2024 and 2023. Contributions are subject to certain limitations.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Hospital's contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Hospital's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after five years of credited service.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, participants may elect to receive a lump-sum distribution of their vested account balance if their total account balance exceeds \$5,000. If the vested account balance is \$5,000 or less, an automatic lump-sum IRA rollover will occur.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$2,360, respectively. These accounts will be used to pay plan expenses or reduce employer contributions. The Hospital utilized \$10,030 and \$6,506 to pay administrative expenses in 2024 and 2023, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States of America as applied to governmental units using the accrual basis of accounting. The Governmental Accounting Standards Board (GASB) is the accepted standard setting body for establishing governmental accounting and financial reporting principles.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of fiduciary net position, changes in fiduciary net position, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan.

Collective trust funds and stable value funds are valued at estimated fair value as provided by Ascensus, LLC at December 31, 2024 and Newport Trust Group at December 31, 2023. The purpose of these funds is to invest primarily in a pool of investments that consist of mutual fund shares, shares of other collective trusts, separate account shares, money market, and stable value products.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan provides for investments in various investment securities that, in general, are exposed to risk, such as interest rate, credit, and overall price and market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities held in participants' accounts will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of fiduciary net position.

Contributions

Contributions from plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants before March 15, 2024. There were no excess contributions payable as of December 31, 2024.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Hospital or the Plan at the Hospital's discretion.

Note 3. Certification of Plan Custodians

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the respective custodians noted below, which are qualified institutions, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Ascensus, LLC has certified investments as shown in the accompanying statement of fiduciary net position as of December 31, 2024
- Newport Trust Group has certified investments as shown in the accompanying statement of fiduciary net position as of December 31, 2023
- Ascensus, LLC has certified investment income as shown in the accompanying statement of changes in fiduciary net position for the period from April 18, 2024 to December 31, 2024
- Newport Trust Group has certified investment income as shown in the accompanying statement of changes in fiduciary net position for the period from January 1, 2023 to April 17, 2024
- Ascensus, LLC has certified investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the accompanying financial statements and ERISA-required supplemental schedule.

Note 4. Investments

Investment securities are exposed to various risks that can affect the value of the Plan's investments, such as custodial credit risk, foreign currency risk, interest rate risk, credit risk, and concentration of credit risk.

Custodial Credit Risk – Custodial credit risk is the risk that in the event of a failure by the counterparty the Plan will not be able to recover the value of its investments that are in the possession of an outside party. The Plan's policies do not specifically address custodial credit risk.

Foreign Currency Risk – Foreign currency risk is the risk that changes in exchange rates will adversely impact the fair value of an investment denominated in a foreign currency. The Plan does not hold any direct investments of instruments denominated in a foreign currency.

Interest Rate Risk – Interest rate risk arises from the likelihood that interest rates will rise or fall during the holding period of a fixed-rate security and adversely affect the selling price of the security prior to maturity. The price of a debt security typically moves in the opposite direction of the change-in-interest rates. The Plan's policies do not specifically address interest rate risk. As of December 31, 2024 and 2023, the Plan had investments in mutual funds, common/collective trusts, a money market fund, and a stable value fund whose underlying assets are subject to interest rate risk.

Credit Risk – Credit risk exists when there is a possibility that the issuer or other counterparty to an investment may be unable to fulfill its payments on a security under the original term. The Plan's policies do not specifically address credit risk. As of December 31, 2024 and 2023, the Plan had investments in mutual funds, common/collective trusts, a money market fund, and a stable value fund that do not report individual credit ratings. The mutual funds may have underlying holdings in securities subject to credit risk.

Note 5. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan paid \$12,507 and \$9,284 of record-keeping fees to Newport Trust Group during the years ended December 31, 2024 and 2023, respectively. The Plan paid \$17,848 and \$15,668 during the years ended December 31, 2024 and 2023, respectively, to an investment advisor. The Hospital provides certain administrative services at no cost to the Plan.

Note 6. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and significant to the fair value of the assets or liabilities

Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

For the period from January 1, 2023 through April 17, 2024, the Plan operated under a volume submitter 401(k) profit sharing plan agreement and trust/custodial document sponsored by Newport Group, Inc. This volume submitter plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
