### NOTES TO FINANCIAL STATEMENTS

#### (1) Description of plan

The following description of the Beaver Manufacturing 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator. Beaver Manufacturing Company, Inc. (the "Company" or "Sponsor") is the sponsor of the Plan.

The Plan is administered by the Sponsor's Investment and Administrative Committee ("Committee"), which consists of Sponsor personnel. The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, and monitors investment performance. A member of the Investment and Administrative Committee is the Plan's trustee.

**General** - The Plan, established on July 1, 1998, is a defined contribution plan covering all full-time employees of Beaver Manufacturing Company, Inc. who have one year of service and are age eighteen or older. The Plan was amended on October 12, 2022 to adopt certain provisions of the Setting Every Community Up for Retirement Enhancement (SECURE) Act of 2019, including allowing long-term part-time employees (those with 3 consecutive years of 500 hours of service) to contribute to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions** - Participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan allows for both pre-tax and post-tax Roth contributions. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. The Company contributes a safe harbor contribution of 100% of the employee deferral up to 4% of compensation that a participant contributed to the Plan. Additional amounts may be contributed at the option of the Company. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

**Participant investment account options** - As of December 31, 2024, the Plan offered a variety of pooled separate accounts and a fixed income account from the custodian as investment options for participants.

**Participant accounts** - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings and account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their contributions and Company contributions plus actual earnings thereon.

**Payment of benefits** - On termination of service due to death, disability, normal retirement at age sixty, or severance of service, a participant may elect to receive a lump sum distribution equal to the value of the participant's vested interest in his or her account. Participants that are age fifty-nine and one-half or older are eligible to take in-service distribution of their vested account balance.

**Forfeitures** - Forfeiture of a participant's employer contribution account occurs when the participant incurs five consecutive one-year breaks in service or receives a complete distribution of the vested portion of the participant's account. Forfeitures can be utilized to reduce the safe harbor employer matching or discretionary contributions, pay plan expenses, or allocated to participants as an additional discretionary nonelective contribution. Forfeitures allocated to participants as an additional discretionary nonelective contribution are allocated to participants employed as of the last day of the year based on each participant's Plan compensation in relation to total employer Plan compensation. At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$20,000 and \$11,000, respectively. During 2024, no forfeitures were utilized to pay plan expenses or reduce employer contributions.

(2) **Summary of significant accounting policies**

**Basis of accounting** - The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Administrative expenses** - Certain expenses of the Plan are paid by the Sponsor and are not included in the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation of fair value of investments.

**Investment valuation and income recognition** - Investments are reported at fair value, except for the Voya Fixed Account, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the plan's gains and losses on investments bought and sold, as well as held during the year.

#### (2) Summary of significant accounting policies - continued

**Investment contracts** - The Plan holds investment contracts with the Voya Fixed Account, which is maintained under a directed trust with Voya Institutional Trust Company ("Voya"). The Voya Fixed Account is a fully benefit-responsive investment contract. An investment contract held by a defined contribution plan that is fully benefit-responsive is required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Contributions to this contract are maintained in a general account that is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses. The contract provides for a guaranteed annual rate of no less than 1% and is included in the financial statements at contract value as reported to the Plan by Voya. Contract value represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion, of their investment at contract value. There are no reserves against contract value for credit risk.

There are no unfunded commitments. Under the terms of the contracts, the Plan Sponsor must provide a minimum of 90-day notice to Voya prior to redemption of the contracts.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (2) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (3) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

**Unit values** - Individual participant accounts for the pooled separate accounts funds are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds but do have an interest therein represented by units valued daily. The funds earn dividends and interest which are automatically reinvested in additional units. Revenue sharing is provided by the custodian and automatically reinvested in participant accounts. Generally, contributions to and withdrawals from each fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

**Payment of benefits** - Benefits are recorded when paid.

#### (3) Fair value measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been changes in the types of investments held by the Plan, but there have been no changes in the methodologies used at December 31, 2024.

*Pooled separate accounts:* Valued at the NAV of units of the separate account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### (3) **Fair value measurements - continued**

The fair value of the investments in the pooled separate accounts has been estimated using the NAV of the investments. The pooled separate accounts invest in mutual funds. The pooled separate accounts listed in the above charts are redeemed on a daily basis and do not have any redemption restrictions.

Gains and losses (realized and unrealized) included in the changes in net assets for the periods above are reported in net appreciation/(depreciation) in fair value of investments in the statements of changes in net assets available for benefits.

#### (4) **Information prepared and certified by the custodian**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company has certified that the following data included in the accompanying 2024 and 2023 financial statements and supplemental schedule of assets (held at end of year) are complete and accurate with respect to investments:

- Investments at fair value and contract value
- Net appreciation/(depreciation) in fair value of investments
- Interest and dividends
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

#### (5) **Party-in-interest transactions**

During 2024, the Plan made direct payments from participant accounts to the investment advisors and recordkeeper/trustee of approximately \$31,000, which were not covered by revenue sharing fees.

The Plan Sponsor pays directly any other fees related to the Plan's operations.

#### (6) **Tax status**

The Internal Revenue Service ("IRS") has determined that the volume submitter profit sharing plan is designed in accordance with applicable sections of the IRC and informed the third-party administrator of such in a letter dated June 30, 2020. The Plan administrator has adopted the volume submitter and although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

(6) **Tax status - continued**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(7) **Risks and uncertainties**

The Plan provides for various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. At December 31, 2024 and 2023, approximately 41% and 39% of the Plan's investments were invested in two and three investment options, respectively, as elected and directed by the Plan participants.

(8) **Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

(9) **Delinquent participant contributions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. While the Company remitted all employee contributions to the Plan, contributions of \$51,857 and \$21,568 were not remitted within the required time period during the years ended December 31, 2022 and 2021, respectively. The Company fully corrected the 2022 and 2021 delinquent contributions in 2024 through the remittance of lost earnings to the Plan.
