Independent Auditors' Report

To the Plan Administrator and Participants of
ARM, Inc. 401(k) Savings Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of ARM, Inc. 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Notes to Financial Statements Year Ended December 31, 2024

1. Description of Plan

The following brief description of ARM, Inc. 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan covering substantially all employees of ARM, Inc. (the “Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan’s recordkeeper is Schwab Retirement Plan Services, Inc. (the “Recordkeeper”) and the Plan’s trustee is Charles Schwab Trust Bank (the “Trustee”). Company management personnel act as the administrator of the Plan.

Eligibility - Employees who are at least eighteen years of age are eligible to participate in the Plan on the first day of the month coinciding with or next following the completion of one month of service. Certain employee classes are excluded from participation in the Plan, as defined.

Contributions - All newly eligible and rehired employees are automatically enrolled in the Plan with a pre-tax deferral percentage of 3%, unless the employee changes the election. This percentage increases annually by 1%, up to a maximum of 10%, for all automatically enrolled employees and any other participants that select the automatic increase feature. Participants have the option to contribute pre-tax, Roth and other after-tax contributions. A participant may authorize the Company to withhold up to 75% of his or her eligible compensation, not to exceed the annual limit established by the Internal Revenue Code (“IRC”). A participant’s pre-tax, Roth and other after-tax contributions are separately accounted for, as are the gains and losses attributable to each. Participants who reach fifty years of age before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans or individual retirement accounts.

The Plan provides for a discretionary employer matching contribution which, if elected, may not exceed 100% of the participant’s contribution, excluding other after-tax contributions, not to exceed 6% of eligible compensation. The Company may elect the frequency of the employer matching contribution, and a true-up calculation is at its discretion. The Company elected to use this formula for an employer matching contribution for the year ended December 31, 2024, and performed a true-up calculation as well.

Participants direct the investment of contributions into various investment options offered by the Plan.

Participant Accounts - Each participant’s account is credited with the participant’s contributions, the Company’s contributions and an allocation of Plan earnings, and may be charged with an allocation of Plan expenses, as applicable. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Notes Receivable from Participants - Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum of 1) \$50,000 reduced by the excess, if any, of i) the highest outstanding note receivable balance during the prior twelve-month period, over ii) the outstanding note receivable balance on the date the new note receivable is made or 2) 50% of their vested account balance preceding the new note receivable, whichever is less. Participant notes receivable are secured by the vested balance in the participant's account and bear interest at a reasonable interest rate as determined by the Company. Participants may have a maximum of two notes receivable outstanding at a time. Note receivable repayments are deducted through after-tax payroll deductions over a period not to exceed five years, unless the note receivable is for the purchase of a participant's primary residence, in which case the repayment period may not exceed fifteen years.

Vesting - Participants are immediately vested in their voluntary and employer matching contributions plus actual earnings thereon.

Payment of Benefits - Benefits are generally payable upon age 59.5, disability, death, retirement or termination of employment. Benefits equal to the participant's vested account balance may be paid to a participant or beneficiary by lump sum, substantially equal installments or rollover into a qualified plan, subject to regulatory requirements. Required minimum distributions are made to applicable participants in the absence of adequate distribution elections. Generally, if no longer employed by the Company, participants must either take a lump sum distribution or begin systematic, actuarially determined withdrawals by April 1 of the year following the year in which the participant turns 73 years of age. The Plan administrator may, without the participants' consent, distribute separated participants' account balances that are less than \$1,000 in a lump sum or transfer separated participants' account balances that are at least \$1,000 but less than \$7,000 (an increase from \$5,000 effective January 1, 2024) into an individual retirement account. In-service distributions of rollover and other after-tax contributions may be taken at any time. Other in-service distributions, including hardship distributions, are permitted if certain criteria are met.

Current Legislation - The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income and simplify plan rules and administrative procedures. Each of the provisions in SECURE 2.0 has its own effective date, and any SECURE 2.0 amendments must be adopted by the Plan no later than December 31, 2026, although it may operate under the new provisions as required or elected prior to amending the Plan document. The Company is currently evaluating the impact of the remaining required and voluntary provisions of SECURE 2.0 on the Plan and its participants.

2. Significant Accounting Policies

Basis of Accounting - The Plan's financial statements are prepared on the accrual basis of accounting.

Accounting Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Investment Committee determines the Plan's valuation policies utilizing information provided by the Trustee and investment advisor. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the Plan year.

Contributions Receivable - Contributions from participants and any related employer matching contributions are recorded in the year in which the participant contributions are withheld from compensation. The Company recognizes an allowance for credit losses based on factors such as the age of the contribution receivable balance, historical experience, current economic conditions, and reasonable and supportable forecasts. There was no allowance for estimated credit losses as of December 31, 2024 or 2023 as management deemed the outstanding contribution receivable balances collectible.

Notes Receivable from Participants - Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Benefits Paid to Participants - Benefits are recorded when paid.

Expenses - The Company may pay certain administrative and operating costs of the Plan at no obligation to the Plan. Fees related to the administration of notes receivable from participants and distributions, recordkeeping fees, and certain other fees paid to service providers are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses, such as management fees and operating expenses, are deducted from earnings recorded to net appreciation in fair value of investments.

Risks and Uncertainties - Financial instruments which potentially subject the Plan to concentrations of credit risk consist primarily of investment securities in which the Plan invests. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. The Plan has cash deposited with certain financial institutions and is exposed to credit risk related to the potential inability to access liquidity in financial institutions where its cash is concentrated.

Plan Termination - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

3. Information Certified by the Trustee

Certain information in the accompanying financial statements, notes and supplemental schedule related to the Plan's investments and notes receivable from participants held as of December 31, 2024 and 2023, and the related net investment gain and interest income on notes receivable from participants during the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee, a qualified institution.

4. Fair Value Measurements

The Plan follows a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. The mutual funds are registered with the Securities and Exchange Commission and are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts: Common/collective trusts are pooled investment vehicles designed primarily for certain qualified retirement plans. The fair values of these investments have been estimated using the net asset values per unit as a practical expedient, as provided by the fund managers, and are based on the fair value of the underlying investments held by each fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the funds will sell the investments for an amount different from the reported net asset values. Unit holders may be required to provide up to a thirty-day notice prior to redemption, although the notice period may be reduced or waived by the issuer. Otherwise, units may be redeemed daily and there are no unfunded commitments.

Common stock, exchange-traded funds and exchange-traded notes: Common stock, exchange-traded funds and exchange-traded notes are valued at the closing price reported by the active market on which the individual securities are traded.

Interest-bearing cash and cash equivalents: Interest-bearing cash and cash equivalents are stated at cost, which approximates fair value.

The self-directed brokerage accounts include mutual funds, common stock, exchange-traded funds, exchange-traded notes, interest-bearing cash, and cash equivalents.

5. Tax Status

The Company has adopted a pre-approved plan document from the Recordkeeper that received an Internal Revenue Service ("IRS") opinion letter dated September 21, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Party-in-Interest and Related Party Transactions

The Plan's interest-bearing cash is managed by the Trustee and an affiliate, and there are self-directed brokerage accounts whose services are provided by another affiliate. Additionally, the Plan paid fees to the Recordkeeper and investment advisor. Transactions such as these, as well as notes receivable from participants, qualify as exempt party-in-interest transactions. The Company may pay directly certain other fees related to the Plan's operations.

7. Subsequent Events

The Company has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended to eliminate the eligibility service requirement, and employees who are at least eighteen years of age may enter the Plan immediately.
