### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Kirkwood Holdings, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ## Notes to Financial Statements For the Year Ended December 31, 2024

### 1. Description of the Plan

The following description of the Kirkwood Holdings, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan covering all eligible employees of Kirkwood Holdings, Inc. and its subsidiaries, Kirkwood Printing Company, Inc., Kirkwood Digital LLC., KP-JMP LLC., Kirkwood Direct, LLC, Kirkwood Holdings, Inc. and the Perrone Group (collectively, the “Employer”). The Plan specifies an age requirement of 21 years to be eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### *Participant Contributions*

Each participant may contribute up to 100% of their annual compensation, subject to annual statutory limits of \$23,000 in 2024. Participants aged 50 or older before the end of the Plan year were eligible to make “catch-up” contributions of \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (“participant rollovers”). Participants direct the investment of their contributions into various investment options offered by the Plan. The total of these contributions is subject to additional limitations imposed by the United States federal tax code.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contribution, the Employer’s matching contribution, Plan earnings and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### *Employer Matching Contributions*

The Employer contributes 20% of the first 6% of eligible compensation of each participant’s contributions to all participants that are eligible on the last day of the Plan year, subject to limitations.

#### *Forfeitures*

The Plan provides that forfeited non-vested accounts are used to offset Employer contributions or to pay administrative expenses of the Plan. At December 31, 2024, the forfeited non-vested accounts total \$3,328. During the year ended December 31, 2024, the Plan did not apply the forfeitures to reduce Employer contributions.

#### *Vesting*

Upon enrollment in the Plan, participants are fully vested at all times in their contributions plus actual earnings thereon. Vesting in the Employer’s matching and profit-sharing contribution portion of their accounts plus actual earnings thereon is as follows:

### 1. Description of the Plan (continued)

#### *Notes Receivable from Participants*

Loans to participants are made subject to statutory limits. Loan transactions are treated as a transfer between investments and the notes receivable from participant fund. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest as determined by the Plan administrator. The interest rate on loans outstanding at December 31, 2024 is 3.36%.

#### *Payment of Benefits*

Participants are entitled to receive their entire interest in the Plan in a lump sum whenever their employment with the Employer terminates for any reason. Hardship withdrawals are allowed prior to retirement or termination of employment. Participants over the age of 59 1/2 or participants who become disabled may withdraw all or part of their contributions without regard to financial need.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting*

The following accounting policies, which conform with accounting principles generally accepted in the United States of America ("GAAP"), have been used consistently in the preparation of the Plan's financial statements.

#### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements, as well as the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

#### *Notes Receivable from Participants*

Loans to participants are measured at their unpaid principal balance plus any accrued and unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

#### *Benefits to Participants*

Benefits are recorded when paid.

#### *Basis of Fair Value Measurement*

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below.

#### *Basis of Fair Value Measurement (continued)*

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurements and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

#### *Investment Valuation and Income Recognition*

The Plan's investments in pooled separate accounts are stated at fair value. Pooled separate accounts are measured at the net asset value of the underlying investments as reported to the investment manager. The Plan's investment in fully benefit-response investment contracts is measured at contract value. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income.

#### *Income Taxes*

The Plan evaluates all significant tax positions as required by generally accepted accounting principles in the United States. As of December 31, 2024, the Plan does not believe that it has taken any tax positions that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. The Plan's income tax returns are subject to examination by the appropriate taxing jurisdictions. If the plan were to incur interest and penalties on uncertain tax positions, such amounts would be reflected as income tax expense on the statement of changes in net assets available for benefits. No interest or penalties were recognized during the year ended December 31, 2024.

#### *Subsequent Events*

The Plan has evaluated all subsequent events through October 8, 2025, the date the financial statements were available to be issued. Management did not identify any events requiring adjustment to or disclosure in the financial statements.

### 3. Information Prepared and Certified by Trustee

The following is a summary of investment information regarding the Plan as of December 31, 2024 and 2023 and for the year December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared or derived from information prepared by Voya Retirement Insurance and Annuity Company ("Voya"), the trustee of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certification from the trustee that such information is complete and accurate.

### 4. Fair Value Measurements

All investments included in the statements of net assets available for benefit at December 31, 2024 and 2023 are pooled separate accounts measured at fair value using net asset value per share based on the fair value of the underlying investments. In accordance with Financial Accounting Standards Board Accounting Standards Codification Topic 820-10, such investments are not required to be classified within the fair value hierarchy described in Note 2 *Basis of Fair Value Measurement*.

### 5. Guaranteed Annuity Contract

The Plan offers the option to invest in a guaranteed annuity contract with Voya who maintains the contributions in a general account. The contract is considered fully benefit-responsive and is reported at contract value. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Voya is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by Voya, but may not be less than 1%. For the year ended December 31, 2024, both the average yield based on actual interest credited to participants and the crediting yield to participants were 1.5%.

The Plan's ability to receive amounts due in accordance with the contract is dependent on Voya's ability to meet its financial obligations. Voya's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with Voya. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Internal Revenue Code Section 401(a) or the failure of the trust to be tax-exempt under Internal Revenue Code Section 501(a)
- Premature termination of the contract
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the Employer or other events that significantly affect the Employer's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Voya and that also would limit the ability of the Plan to transact at contract value with the participants.

Certain events, which are not probable of occurring, would allow Voya to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events may include:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- An amendment to the agreement without the consent of Voya

### 6. Party-in-Interest Transactions

Certain plan investments are shares of pooled separate accounts managed by Voya. Additionally, the Plan makes loans to participants. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

### 7. Plan Expenses

Administrative expenses are the responsibility of the Plan. The Employer, at its discretion, may pay some of these expenses, but it is under no obligation to do so. The Employer paid substantially all other Plan expenses for the year ended December 31, 2024.

### 8. Tax Status

Pursuant to an adoption agreement of a prototype plan offered by Ascensus, LLC, on which the Internal Revenue Service determined and informed Ascensus, LLC by letter dated June 30, 2020 that the prototype plan was qualified under IRC Section 401(a), the Plan administrator and the Plan's tax counsel believe that the Plan is qualified under IRC Section 401(a). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### 9. Plan Termination and Amendment

Although the Employer has not expressed any intent to do so, the Employer has the right, under the Plan agreement, to amend any or all provisions of the Plan, as well as discontinue contributions and terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts, and the assets of the Plan must be allocated among the participants and beneficiaries in the order provided for by ERISA.

### 10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.

### 11. Use of Service Organizations

The Plan utilizes Voya to process transactions, maintain participant account balances, and hold plan investments. The Plan's management has obtained and reviewed the service auditor's report on the design and operating effectiveness of controls at ADP (SOC 1, Type 2 report), covering the period of January 1, 2024 to December 31, 2024. Management has also considered user entity controls identified in the SOC 1 report and implemented complementary procedures where required.

Based on its review, management has determined that the controls at the service organization, together with the Plan's own complementary user controls, provide reasonable assurance that plan transactions are processed completely and accurately. No material issues were noted in the SOC 1 report that would have a significant impact on the Plan's financial statements.

### 12. Participant Count

In accordance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the number of participants with account balances as of December 31, 2024, is disclosed on Form 5500. The methodology used to determine the participant count for purposes of the Form 5500 may differ from the methodology used in preparing the financial statements, which presents only those participants with account balances.
