Note 1 – Plan Description

The following description of the Columbia Cedar, Inc. 401(k) Plan (the Plan), provides only general information. Participants should refer to the official plan document for important details not included in these notes.

- a. **General** – The Plan is a participant-directed, defined contribution plan qualifying as a salary reduction plan covering all employees of Columbia Cedar, Inc. (the Company), who have completed one year of service (1,000 hours and 12 consecutive months beginning with the first day of employment) and have attained the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.
- b. **Contributions** – Participation in the Plan is voluntary. Participants make voluntary tax-deferred contributions to the Plan through payroll deductions subject to Internal Revenue Service (IRS) limitations. The employer may elect to contribute an amount determined annually. During the year ended December 31, 2024, the employer may contribute up to 29% of participant deferrals but not to exceed 29% of compensation to eligible participants. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants may direct contributions to any of the available options offered by the Plan. Participants become eligible for matching contributions when they have completed one year of service.
- c. **Participant accounts** – Individual accounts are maintained for each plan participant. Each participant’s account is credited with the participant’s and the employer’s matching contributions as well as allocations of plan earnings or losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Each participating employee may designate the percentage of his or her total contribution, including the employer’s matching portion, to be invested in any of the available investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- d. **Vesting** – Participant contributions and actual earnings thereon are 100% vested. Employer matching contributions for each plan year are vested for those employees who have completed a year of service during the plan year in accordance with the following schedule:

- e. **Payment of benefits** – Normal retirement under the Plan occurs at age 65. The Plan also provides for payments to persons under age 65 if certain conditions are met as specified in the plan document. Participants, or their beneficiaries, are eligible to receive benefits in the event of the participant's retirement, death, disability, termination of employment, or the termination of the Plan. Benefits are distributed according to provisions set forth in the plan document. All vested account balances less than \$5,000 shall be distributed in a lump-sum payment or rolled over into another qualified plan. If the participant's vested account balance exceeds \$5,000, distribution shall be in a lump-sum payment or installment payments over a specified period of time.
- f. **Forfeited accounts** – Forfeitures may be used to pay plan administrative expenses or reduce future employer contributions to the Plan. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,605 and \$15,771, respectively. Forfeitures of \$17,389 and \$17,872 were used to reduce expenses during 2024 and 2023, respectively.
- g. **Administration of the Plan** – Plan assets are invested in accordance with the employee's instructions and are maintained by Voya Retirement Insurance and Annuity Company (Voya), the Plan's custodian. Records of participant account activity are processed and maintained by Randall & Hurley, Inc., which also performs other administrative support services for the Plan. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses of the Plan are paid by the Plan or by the Company, as provided in the plan document.

Note 2 – Summary of Significant Accounting Policies

- a. **Basis of accounting** – The accounting records of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.
- b. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make significant estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.
- c. **Investment valuation and income recognition** – Investments are stated at fair value (except for the fully benefit-responsive guaranteed interest contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of shares are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2 – Summary of Significant Accounting Policies (Continued)

- d. **Payment of benefits** – Benefits are recorded when paid.
- e. **Administrative expenses** – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of certain benefit payments are charged to the participants and are included in benefits paid to participants and beneficiaries. Investment related expenses are included in net appreciation in fair value of investments.
- f. **Reclassifications** – Certain amounts in the 2023 financial statements have been reclassified for comparative purposes to conform with the 2024 presentation with no effect on previously reported net assets available for benefits.
- g. **Subsequent events** – The Plan has evaluated subsequent events through **DATE**, the date that the financial statements were available to be issued.

Note 3 – Information Certified by the Plan Custodian

As permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator has elected that information certified by Voya, the Plan's custodian, not be subjected to any auditing procedures except for comparing such information to the related information contained in the accompanying financial statements and supplemental schedule.

The following information has been certified by Voya as complete and accurate:

- (a) Investments as indicated on the statements of net assets available for benefits;
- (b) Net appreciation in fair value of investments as indicated on the statements of changes in net assets available for benefits; and
- (c) Supplemental schedule – assets held for investment.

Note 4 – Fair Value Measurements

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Note 4 – Fair Value Measurements (Continued)

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Level 1 – The Plan had no investments that are classified as Level 1 for either year ended December 31, 2024 or 2023.

Level 2 – The Plan had no investments that are classified as Level 2 for either year ended December 31, 2024 or 2023.

Level 3 – The Plan had no investments that are classified as Level 3 for either year ended December 31, 2024 or 2023.

Investments measured at net asset value (NAV):

Pooled separate account: Valued at NAV provided by investment manager:

Government Securities Fund Separate Account No. 390 is valued at net asset value provided by the fund management. Pooled separate accounts are based on market prices determined by pricing services from Voya and other reliable sources. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

Note 4 – Fair Value Measurements (Continued)

This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The fair value of units in pooled separate accounts is determined by dividing the market value of the fund by the total number of units in the fund.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to the total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2, or 3.

Pooled Separate Account: The Government Securities Fund Separate Account No. 390 is a direct filing entity that is reported in Schedule D of the Plan's Form 5500. Investment objectives are no longer required to be disclosed in the Plan's financial statements under *Accounting Standards Update 2015-07*.

Note 5 – Investment Contract with Insurance Company

In 2015, the Plan entered into a guaranteed investment contract with Voya. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on an annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity dates.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts, because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Note 5 – Investment Contract with Insurance Company (Continued)

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) a violation of the Plan's investment guidelines that has not been remedied; (2) a breach of material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the agreement without the consent of the issuer.

Note 6 – Party-in-interest Transactions

The plan administrator is an employee of the plan sponsor. There are no transactions between the parties other than contributions to the Plan. Certain plan investments are shares of pooled separate funds managed by Voya, the Plan's custodian, as defined by the Plan. These transactions qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, all affected participants' accounts and rights to benefits shall be nonforfeitable. Upon termination, all assets remaining in the Plan will be distributed to the participants in accordance with participant account values as of the date of termination.

Note 8 – Plan Tax Status

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code (IRC) and, accordingly, the trust's net investment income is exempt from income taxes. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement dates. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of the liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the Plan's tax-exempt status; however, there are currently no audits for any tax periods in progress.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Note 10 – Benefits Payable

The amount included in benefits payable consists of the cumulative amount of distributions made to eligible participants prior to December 31, 2024 and 2023, and the distributions remain outstanding.


