Note 1. Description of Plan

The following is a brief description of New York Daily News 401(k) Plan (the Plan). Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on May 25, 2021, as a result of the purchase of the Daily News, LP (the Daily News) by NY Daily News Enterprises LLC on May 25, 2021. The Plan became active, and participation began at August 1, 2021. The Plan is a 401(k)-plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility and Contributions

Employees who are leased employees, or are classified as Interns are not eligible to participate in the Plan. All other employees will become eligible to participate in the plan after the attainment of age 21. Participants may make both pre-tax and Roth contributions, in an amount equal to a dollar amount or percentage of the Contributing Participant's Compensation not to exceed the limits imposed by the Internal Revenue Code (IRC). Additionally, participants who are at least 50 years old may make additional catch-up contributions as defined by the IRC.

The plan was amended on April 1, 2023 to remove the exclusion of employees covered by a collective bargaining agreement.

The Daily News may make discretionary contributions to the Plan. The employer also makes a qualified automatic safe harbor contribution equal to 100% of the first 2% and 50% of 2% to 6% of participant's elective deferral contributions. The Daily News may also make discretionary matching contributions. No such discretionary contributions were made for the year ended December 31, 2024.

Vesting

Participants are always fully vested in their own contributions plus earnings thereon. Participants become fully vested in the employer profit sharing and safe harbor contributions plus earnings thereon after two years of service.

Forfeitures

The portion of a participant's account balance, which is not vested upon termination of employment, is forfeited and remains in the Plan. Forfeitures can be used to reduce employer contributions, or to pay allowable Plan expenses. As of December 31, 2024 and 2023, the forfeiture balance was \$8,700 and \$6,531, respectively. Forfeitures for the year ended December 31, 2024 totaled \$9,690 and \$7,494 were used to pay Plan expenses during the year ended December 31, 2024.

Benefit Payments

Upon attaining the age of 59½, a participant is entitled to a lump-sum distribution from the Plan or may elect periodic distributions as described in the Plan. In addition, participants may withdraw funds from the Plan upon termination of employment or, in certain other cases and subject to the approval of the Retirement Plan Committee; participants may request a withdrawal of a portion of their balances in the case of financial hardship. In the event of death while employed, the non-vested benefit becomes vested and can be distributed to beneficiaries as described in the Plan.

Notes Receivable from Participants

Loans may be available to the participants subject to the approval of the Plan administrator. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Their vested account balances also serve as collateral for the loan. Interest rates on the loan outstanding at December 31, 2024 was 4.25% to 9.50%. Loans that are in defaults are accounted for as a distribution in the year the default occurs. There were no loan defaults for the year ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with their contributions plus the Daily News contributions, and earnings thereon. Contributions are invested by Ascensus Trust Company (the Trustee) according to the options elected by the participants. The investment options include various mutual funds.

Administrative Expenses

Participants pay for certain individual transaction charges. All other plan expenses are paid for by the Daily News.

Note 2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Benefits Paid to Participants

Benefits paid to participants are recorded when paid.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amount of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.

Note 3. Information Certified by the Plan's Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 4. Fair Value Measurements

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023:

Mutual funds: Valued at unadjusted quoted market prices in an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related Party Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives or such persons.

Ascensus is the recordkeeper as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid to Ascensus by the plan amounted to \$8,288 for the year ended December 31, 2024.

The Company provides certain administrative services at no cost to the Plan.

Note 6. Plan Termination

Although it has not expressed any intention to do so, Daily News has the right to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants would become 100% vested.

Note 7. Tax Status

On June 30, 2020, the Internal Revenue Service (IRS) stated that the prototype plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the DOL or IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan provides for various investment options to the participants in any combination of mutual funds. These investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.
