INDEPENDENT AUDITORS' REPORT

To the Trustees of

Opinion

We have audited the accompanying financial statements of Housecalls Health Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

- 1. DESCRIPTION OF PLAN:** The following description of the Housecalls Health Plan (the Plan) provides only general information about the Plan's provisions. Participants should refer to the plan agreement for a complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

General

The Plan is available to regular full-time employees of House Calls Home Care (the Company). The Company provides a wide range of home health services in the New York metropolitan area.

The Plan was established on January 1, 2015, to provide health benefits to eligible employees of the Company and covered dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

At each annual enrollment, provisions, such as participant contribution rates, coverage, deductibles, copays, and out-of-pocket maximums, may change.

Benefits

The Plan provides health benefits including coverage for medical, dental, vision, and prescription drugs. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Self-Insured Benefits

The claims for self-insured medical benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants using funds received from the Plan's trust or the general assets of the Company. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The claims for self-insured dental and vision benefits are processed by a third-party insurance company under a discount plan agreement. Despite the Plan's utilization of a third-party insurance company, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Telehealth benefits are provided monthly, per capita. The Plan pays benefits on behalf of participants using funds received from the Plan's trust or the general assets of the Company. Despite the Plan's utilization of third-party administrators, ultimate responsibility for payments to providers and participants is retained by the Plan.

Contributions

The Company makes contributions to the Plan as needed to fund benefits. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

- 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**
- Basis of Accounting and Use of Estimates***
The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- Interest Income Recognition***
Interest income is recorded on an accrual basis.
- Payment of Benefits***
Benefit payments are recorded when paid to providers and are reported as benefits paid in the accompanying statement of changes in net assets available for benefits. Plan obligations at year end for benefits incurred by the Plan and claims incurred by active participants but not reported at that date are reported in the accompanying statement of benefit obligations.
- Rebates***
Rebates due from the Plan's PBM are recorded when earned. Rebates due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid.
- Subsequent Events***
Management has evaluated subsequent events through October 10, 2025, the date which the financial statements were available to be issued.
- 3. CLAIMS INCURRED BUT NOT REPORTED:** Plan obligations at December 31 for claims incurred but not reported are estimated by the plan administrator based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.
- 4. ADMINISTRATIVE EXPENSES:** The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party benefit administrators. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. Such transactions are party-in-interest transactions under ERISA. Administrative expenses paid by the Company on behalf of the Plan are excluded from these financial statements.
- 5. TAX STATUS:** The plan administrator believes that the Plan is designed and is currently being operated in compliance with Internal Revenue Code requirements applicable to a qualified health and welfare plan.
- The Plan currently reports as a trust and files an annual Form 1041, *U.S. Income Tax Return for Estates and Trusts*, with the Internal Revenue Service (IRS). The plan administrator believes that, based upon applicable rulings of the U.S. Treasury Department, contributions to the Plan do not constitute gross income of the Plan, and that the amounts paid or credited to employees may be deducted against investment income. The Plan is not required to pay federal, state or municipal income taxes.

TAX STATUS (continued): Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain tax position that more likely than not would not be sustained upon examination by the relevant taxing authorities.

6. TERMINATION OF THE PLAN: Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

7. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS: Certain plan investments, such as interest-bearing cash accounts are managed by the custodian as defined by the Plan, making any transactions qualify as party-in-interest transactions.

House Calls Home Care provides the Plan with certain accounting and administrative services for which no fees are charged. In addition, administrative expenses reported on the statement of changes in net assets available for benefits include \$549,490 of indirect compensation paid by the third-party benefit administrator to SBH Financial Group LLC, a related party and party-in-interest to the Plan, for administrative and broker services.

9. CONCENTRATIONS: At times, the Plan maintains cash balances in excess of the Federal Deposit Insurance Corporation's insured limits. Financial instruments that subject the Plan to concentrations of credit risk include cash on deposit with a financial institution that is not federally insured or otherwise collateralized. Therefore, the Plan may be exposed to credit losses in the event of non-performance by the financial institution. The Plan has not experienced such losses.

10. RISKS AND UNCERTAINTIES: On occasion, the Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.
