Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements

December 31, 2024 and 2023

NOTE A – DESCRIPTION OF PLAN

The following description of the Bristol Bay Native Association 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan was originally established on October 1, 1980 as a money purchase pension plan covering all employees of Bristol Bay Native Association (the Employer) under Bristol Bay Native Association Pension Plan. As of January 1, 2016 the plan was restated and changed to Bristol Bay Native Association 401(K) Plan. Employees needed to complete 30 days of continuing service to be eligible to make deferrals to the Plan. For Employer contributions, employees are eligible to participate when they have completed one year of service and 1,000 hours of service. As of April 30, 2018, employees had to complete one year of service and 1,000 hours to be eligible to make deferrals to the Plan. The Plan also has a semiannual entry date. As of July 1, 2021, the plan was amended to allow Roth contributions. Therefore, employees may elect to contribute funds on a post-tax basis. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions. Contributions to the Plan are made as follows:

Salary Deferrals. Active participants may elect to make tax deferred contributions to the Plan, not to exceed \$23,000 and \$22,500 for the years ended December 31, 2024, and 2023, respectively. Eligible participants age fifty and over may defer an additional \$7,500 and \$7,500 of catch-up contributions for the years ending December 31, 2024 and 2023, respectively. This limit may be reduced for participants covered by more than one retirement plan. Deferrals are deposited biweekly, by the Employer, in the plan. Participants may contribute funds to the plan that have been distributed from other qualified plans as rollover contributions upon entry to the plan.

Profit Sharing Contribution. At the discretion of the Board of Directors the Employer may contribute an approved amount on behalf of each participant. In 2024 and 2023 the Board approved a 5% contribution based on participant's annual compensation.

Participant Accounts. Each participant's account is credited with the participant's contribution, Employer's discretionary contributions, allocation of forfeitures of terminated participant's non-vested accounts, and allocation of the Plan earnings. Allocations are based on the participant's compensation or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's accounts.

Vesting. Participants are 100% vested in their salary deferrals. Participants become vested in the Employer's discretionary profit sharing contributions through a five year graded vesting schedule, one year 20%, two years 40%, three years 60%, four years 80% and at five years 100%.

Notes to Financial Statements, Continued

Forfeited Accounts. Forfeitures are non-vested accounts of participants who terminate employment. If termination of employment occurs and the participant's entire account was forfeited due to not meeting the vesting standards, the forfeited account will be fully restored if the participant is reemployed and a break in service does not exceed five years. If any of the participants are forfeited, it is up to the Employer's discretion how to use those forfeited amounts. Forfeitures may be used to pay Plan expense. If any forfeitures are not used to pay Plan expenses, such forfeitures may be allocated as additional Employer contributions or may be used to reduce other Employer contributions under the plan. Forfeited non-vested accounts totaled \$13,722 and \$6,060 for years ended December 31, 2024 and 2023, respectively. During the year ended December 31, 2024 \$6,060 of forfeited accounts were allocated to participants.

Investment Options. All participant contributions and Employer discretionary profit sharing contributions are deposited with John Hancock Life Insurance Company (USA). The funds are then invested in one or more funds according to the direction of individual participant. Upon enrollment in the Plan, a participant may direct contributions in any of the investment options, which consists of different fund types.

Payments of Benefits. Upon attaining normal retirement age of 59 1/2, death, disability, or termination of employment, a participant, or his or her beneficiary, may elect to receive a lump-sum distribution equal to the participant's vested account balance or annuity payments. In the event the participants vested account balance is less than \$5,000 and participant makes no election, the distribution is made regardless of whether the participant consented to receive it. Financial hardship withdrawals are permitted, as defined in the Plan agreement.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The accompanying financial statements have been prepared on the accrual basis of accounting. In accordance with accounting principles generally accepted in the United States of America ("US GAAP").

Investment Valuation and Income Recognition. The Plan's Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment adviser, trustee and custodian. See Note E. for further discussion of fair value measurements.

Purchases and sales of securities are recorded on trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes gains and losses on investments bought and sold as well as held during the year.

Benefit Payments. Benefits paid to participants and beneficiaries are recorded upon distribution.

Administrative Expenses. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

Notes to Financial Statements, Continued

Use of Estimates. The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Cash. The Plan considers its forfeiture account which is held in a non-interest bearing account to be cash.

NOTE C – INFORMATION CERTIFIED BY JOHN HANCOCK LIFE INSURANCE COMPANY (USA)

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, as permitted under such election, the following information contained in the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, was certified by John Hancock Life Insurance Company (USA), to be complete and accurate.

- (a) Cash and investments, at fair value, as shown in the Statements of Net Assets Available for Benefits;
- (b) Net appreciation in fair value of investments, as shown in the Statement of Changes in Net Assets Available for Benefits; and
- (c) All information included in the Schedule of Assets (Held at End of Year), as shown in the supplemental schedule.

NOTE D – PLAN TERMINATION

Although it has not expressed any intent to do so, Bristol Bay Native Association, the Plan sponsor, has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will remain 100 percent vested in their accounts. Upon termination of service, a participant may elect to receive a lump sum distribution, or to rollover their account balance to another qualified plan.

NOTE E – FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board issued authoritative guidance establishing a framework for measuring fair value. That framework provides a fair value hierarchy based on the inputs used to measure fair value and expanded disclosures about the use of fair value measurements. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements), and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1** Inputs to the valuation method are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation method include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 Inputs to the valuation method are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurements requires judgment and may affect the valuation of the assets and liabilities being measured and their level within the fair value hierarchy.

Following is a description of the valuation methods used for assets measured at fair value. There have been no changes in the methods used at December 31, 2024 and 2023.

Pooled Separate Accounts: According to the Plan custodian, the pooled separate accounts are invested in investments such as stocks, mutual funds, short-term investments, bonds, etc. John Hancock Life Insurance Company, USA owns the underlying investments in separate accounts. While the underlying asset values are quoted prices, the NAV (net asset value) of a separate account is not publically quoted.

NOTE F – INVESTMENT AT CONTRACT VALUE

Guaranteed Interest Account. These accounts are held in John Hancock Life Insurance Company, USA's general account. Guaranteed Interest Accounts guarantee the return of principal plus compound interest earned over the defined term of the account which is 3, 5, or 10 years. Interest rates are established on the first day of each calendar month and apply to all regular ongoing contributions made to the account in that month. At the end of each reporting year, a composite rate of interest is determined and is the effective annual rate earned by all contributions to that account during that reporting year.

The Guaranteed Interest Accounts meet the fully benefit responsive criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by the participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made plus earnings, less participant withdraws, and administrative costs.

The contract value of the Guaranteed Interest Account was \$25,406 and \$12,419 at December 31, 2024 and 2023, respectively. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer and the account is not federally insured. The crediting interest rate is based on a formula agreed upon with the issuer. The current rates for the 3, 5 and 10-year accounts were 1.25%, 1.27% and 1.29%, respectively.

Notes to Financial Statements, Continued

NOTE G – RECONCILIATION OF FINANCIAL STATEMENTS TO SCHEDULE H OF FORM 5500

Per The Plan's Form 5500 net investment gain from pooled separate accounts are \$780,897. This line item is reported net administrative fees and interest revenue from the plans guaranteed accounts in the form 5500. Administrative fees and interest revenue are reported as separate line items in the financial statements.

NOTE H – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of pooled separate accounts managed by John Hancock Life Insurance Company (USA). John Hancock Life Insurance (USA) is the custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions as defined by ERISA. Any transactions involving these investments are on the open market at fair value or contract value. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party in interest transactions under ERISA.

NOTE I – TAX STATUS

The Employer adopted a volume submitter profit sharing/401(k) plan ("Volume Submitter Plan") which received a favorable opinion letter dated March 31, 2014, in which the Internal Revenue Service (IRS) stated that the Volume Submitter Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the plan administrator and the Plan's advisors believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Administration errors, if any, which are insignificant or operational in nature, are handled by the administrator in accordance with applicable IRS correction policies. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan Management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan's policy is to report interest and penalties associated with uncertain tax positions, if any, as administrative expenses. With few exceptions, the Plan is no longer subject to examination by federal tax authorities for years before 2021.

NOTE J – RISKS AND UNCERTAINTIES

The Plan has placed its investments with John Hancock Life Insurance Company. Investment securities are exposed to various risks such as interest rate, market, and credit risks. This institution has professionally managed money market funds and investment funds whose investments consist of numerous and diverse pooled separate accounts. As part of the Plan's investment strategy, the trustees perform periodic evaluations of the relative credit standing and investment performance of financial institutions.

Notes to Financial Statements, Continued

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE K – ADMINISTRATIVE COSTS

The Plan permits the payment of Plan expenses to be made from the Plan's assets. If expenses are paid using the Plan's assets, such fees or expenses will generally be allocated to the accounts of participants either proportionally based on the value of their account balances or as an equal dollar amount based on the number of participants in the Plan. Participants may be assessed fees directly associated with the administration of their account.

NOTE L – SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 2, 2025 the date which the financial statements were available for issue. No events were identified that would require adjustment or disclosure according to generally accepted accounting principles.
