Note 1 – Description of the Plan

The following description of the Spark Fun Electronics Inc 401(k) Plan (the “Plan”) provides only general information. Participants and all others should refer to the Plan Document for a more complete description of the Plan’s provisions.

General. The Plan is a defined contribution plan, which went into effect March 26, 2007, that is available to all employees of Spark Fun Electronics Inc (the “Company”, “Employer”, “Plan Sponsor”, or “Plan Administrator”) who are age 21 or older. Employees may enter the Plan on the first day of the month coinciding with or next following the date after meeting the Plan’s eligibility requirements. The Plan excludes union employees, nonresident aliens, leased employees and employees who become employees as result of Code §410(b)(6)(C) transaction until the end of the transition period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Benefits under the Plan are not guaranteed by the Pension Benefit Guaranty Corporation.

Contributions. The following types of contributions are allowable under the Plan:

- Elective Deferral Contributions – Participants may contribute a percentage of their eligible pre-tax compensation, as defined in the Plan document, subject to limitations. Participants may also contribute a percentage of their after tax compensation and designate it as a Roth deferral contribution. A participant’s total contribution cannot exceed \$23,000 (\$30,500 if 50 or older) in calendar year 2024.
- Safe Harbor Employer Matching Contributions – Each payroll period, the Employer will make a safe harbor Employer matching contribution equal to 100% of the participant’s contributions up to 5% of compensation.
- Discretionary Employer Nonelective Contributions – The Employer may make a discretionary Employer nonelective contribution to eligible participants employed on the last day of the Plan year or participants that have completed 501 hours of service during the plan year, with certain exceptions for participants who die, become disabled, or reach their normal retirement date during the year. This contribution is allocated to each eligible participant’s account in the ratio that each participant’s compensation bears to the compensation of all eligible participants. During 2024, the Employer did not make a discretionary Employer Nonelective contribution.
- Rollover Contributions – Amounts distributed to participants from other qualified employee benefit plans may be rolled into the Plan.

All contributions are allocated to the Plan’s investment funds at the direction of the participants.

Participant Accounts. Each participant’s account is credited with the participant’s elective deferral contributions (if any) and an allocation of (a) the Employer’s contributions (safe harbor matching and discretionary nonelective, if any) (b) fund earnings or losses, and (c) administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options. Participants may currently direct their investments into various pooled separate accounts and an investment contract with insurance company.

Note 1 – Description of the Plan (continued)

Vesting. Participants are immediately 100% vested in their elective deferral contributions, rollover contributions, and safe harbor Employer matching contributions, plus actual earnings thereon. Vesting in the discretionary Employer nonelective contributions is based on a 4 year graded vesting schedule, whereas participants become 100% vested after 4 years of service. Additionally, employed participants become 100% vested in their accounts upon reaching normal retirement age of 65, death, becoming disabled, or upon Plan termination or partial Plan termination.

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (i) \$50,000 or (ii) 50% of their vested account balance. Loan terms range up to a maximum of 5 years (10 years if used for the purchase of a principal residence). The loans are secured by the balance in the participant's account and bear a reasonable rate of interest as determined by the Plan Administrator at the date the loan is granted. Principal and interest payments are paid ratably through payroll deductions.

Payment of Benefits. Benefits to participants or beneficiaries generally are payable as a lump sum, partial payments, or installments equal to the value of their vested account balance upon retirement, termination, death, or disability of the participant. A terminated employee with a balance less than a certain dollar threshold, as defined by the Plan document, may be automatically paid out by the Plan upon termination. Participants may also elect to rollover their vested account balance into an IRA or another qualified plan. Additionally, participants may request in-service withdrawals upon attainment of age 59½, for a deemed severance of employment, for a qualified reservist distribution, or upon incurring a financial hardship, as defined in the Plan Document, if certain criteria are met.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates. The financial statements of the Plan are prepared using the accrual method of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value, except for the Plan's investment in an investment contract with insurance company which is stated at contract value (see Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions. Participant contributions and the related Employer matching contributions are recognized in the period in which participant contributions are withheld from compensation.

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Benefits Payments. Benefits are recorded when paid.

Expenses. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Also, included in administrative expenses are recordkeeping, participant communication, investment advisory, investment management, and other expenses. Certain investment related expenses are included in net appreciation in fair value of investments.

Note 3 – Fair Value Measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

- The pooled separate accounts ("PSAs") are valued at the net asset value ("NAV") of units held by the Plan at year end. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less their liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Investment Contract With Insurance Company

In 2012, the Plan entered into a traditional benefit-responsive investment contract, the Stable Value Account ("SVA"), with American United Life Insurance Company ("AUL"). AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed rate, which may not be less than 0%, is established by the contract issuer 35 days prior to January 1st and stays in effect for the subsequent calendar year. The investment contract permits either party to terminate the agreement with 90 days notice.

This contract meets the fully benefit-responsive criteria and, therefore, is reported at contract value. Contract value is the relevant measurement attribute for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value, except that participants may not transfer any amount from the SVA to a competing investment. A participant who transfers funds from the SVA to a non-competing investment may not transfer funds from the non-competing investment to the SVA or a competing investment until 90 days from the date of their last transfer from the SVA. A competing investment available under the investment contract is an investment with an average effective duration of three years or less, a money market investment account, a stable value investment account that is not the AUL SVA, or any other investment account deemed competing by AUL.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$726,609 and \$719,226, respectively. The investment contract does not have a defined maturity specified in the contract.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) the Plan's sponsor's rejection of the new Guaranteed Rate declared for the SVA, (2) Plan termination, (3) partial Plan termination, (4) bankruptcy of the Plan sponsor, (5) other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (6) contract termination.

The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Note 5 – Certified Information

The following information disclosed in the accompanying financial statements and ERISA-required supplemental schedule was obtained by management and agreed to or derived from information certified as complete and accurate by American United Life Insurance Company, the custodian, of the Plan:

- Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023;
- Notes receivable from participants, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023;
- Investment amounts, as shown in Notes 3 and 4;
- Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024;
- Interest income on notes receivable from participants, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024;
- The investment information in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown in the supplemental schedule.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination or a partial Plan termination, affected participants will become 100% vested in their accounts.

Note 7 – Tax Status

The Company has adopted an OneAmerica Financial Partners Inc Non-Standardized Pre-Approved Profit Sharing Plan ("pre-approved plan"). The pre-approved plan received an opinion letter from the Internal Revenue Service ("IRS") on August 19, 2020, which stated that the pre-approved plan is qualified under the applicable sections of the Internal Revenue Code ("IRC"). Although the pre-approved plan and Plan have been amended since receiving the IRS opinion letter, the Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified under Section 401(a) of the IRC and the related Trust is tax exempt as of December 31, 2024 and 2023. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7 – Tax Status (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Party-In-Interest Transactions

The Company provides to the Plan certain accounting and administrative services for which no fees are charged.

The Plan's investments consist of pooled separate accounts and an investment contract with an insurance company offered by AUL. As AUL is the custodian of the Plan, these transactions qualify as party-in-interest transactions. Additionally, the Plan maintains notes receivable from participants. Fees paid for services rendered by parties-in-interest were based on customary and reasonable rates for such services.

Note 9 – Concentrations, Risks, and Uncertainties

The Plan provides for various investment options. Investment securities, in general, are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts presented in the statements of net assets available for benefits. As of December 31, 2024 and 2023, there was three and four investments, respectively, which individually represented more than 10% of net assets available for Plan benefits. See supplemental Schedule of Assets (Held at End of Year) for a complete listing of investments held at December 31, 2024.

Additionally, some investments held by the Plan are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

Note 10 – Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

Effective June 6, 2025, the Plan changed service providers to Voya Financial. In connection with this change in service providers the following occurred:

- The Plan Sponsor adopted a Voya Retirement Insurance and Annuity Non-Standardized Pre-Approved Profit Sharing Plan ("Voya pre-approved plan". In connection with the adoption of the Voya pre-approved plan, the Plan document was amended and restated;
- A blackout period began on May 30, 2025 and ended on June 27, 2025; and
- Plan assets of approximately \$10.3 million transferred from AUL/OneAmerica to Voya in June 2025.

We have audited the financial statements of the Spark Fun Electronics Inc 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit] for the year ended December 31, 2024, and we will issue our report thereon dated October 9, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by American United Life Insurance Company, the qualified institution, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedule, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the U.S. (“GAAP”). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated April 4, 2025. Professional standards also require that we communicate to you the following information related to our audit.

Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor’s report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan’s financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. Management has corrected all such misstatements. In addition, none of the misstatements detected as a result of audit procedures and corrected by management were material, either individually or in the aggregate, to the financial statements taken as a whole.

Disagreements with Management

For purposes of this letter, a disagreement with management is a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated October 9, 2025.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Reportable Finding

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention. We identified the following reportable findings:

Interest Rates on Participant Loans

During the course of our audit, Brock noted the loans issued to participants during 2024 had an interest rate of 4.25%. If a plan sponsor does not use a commercially reasonable or market interest rate for a participant loan, the loan may be treated as a prohibited transaction, potentially subjecting the disqualified person (usually the participant) to excise taxes, potentially risking plan disqualification, and potentially breaching fiduciary duties. Typically Plan documents have defined this commercially reasonable or market interest rate as the prime rate. As of September 27, 2025, the prime rate is 7.25%. Brock recommends Plan management work with an ERISA attorney and the Plans recordkeeper and take corrective action as necessary.

Ability to Prepare Financial Statements

As you are no doubt aware, employee benefit plans are subject to unique accounting and disclosure requirements. As your auditors, we are now required to specifically consider whether plan personnel have the necessary knowledge to apply generally accepted accounting principles in recording financial transactions and preparing financial statements for the Plan. While we can recommend adjusting journal entries and prepare draft financial statements as part of our audit, we are prohibited from acting as your internal control. Based upon the extent of our involvement in these processes, we consider this to be a significant deficiency. While this is a desirable control, we understand that the cost of additional training or additional personnel may not be justified to correct this control deficiency.

*Other Audit Findings or Issues**Discussion with Management*

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Definition of Compensation

During the course of our audit, Brock and Company CPAs P.C. ("Brock") noted "ADD", "GTL", "LTD", and "STD" compensation was included for purposes of determining participant and Employer contributions to the Plan during 2024. The Plan document's definition of compensation for purposes of calculating Plan contributions is W-2 wages with certain exclusions. Brock recommends Plan management review eligible compensation to the terms of the Plan document to determine if they were improperly included and correct any improperly included compensation by following the guidance provided under the IRS's Employee Plans Compliance Resolution System ("EPCRS"). Furthermore, Brock recommends Plan management strengthen internal controls surrounding the proper definition of compensation to ensure all participants are allocated the proper amount of Plan contributions.

Minutes of the Plan's Administrative Committee

During the course of our audit, Brock noted that there were no minutes of meetings of the Plan's Administrative Committee during 2024. With the significant number of investment failures within benefit plans, the complexity of investment alternatives, and the complexity of the tax laws covering the qualifications of the Plan and fiduciary responsibilities of the Administrative Committee, it is important that the Administrative Committee adequately document the due diligence they exercise over operations of the Plan, including selection of an Investment Policy and investment alternatives to offer participants who defer their earnings into the Plan's investments, and monitor investment performance against the Plan's objectives.

The Plan's Administrative Committee should meet at least annually to review the investment returns, review the soundness of the investments, determine investment strategies, monitor the Plan's service providers, review Plan fees and expenses for reasonableness, and monitor tax and qualification compliance.

We recommend the Administrative Committee establish procedures for carrying out the preceding and document the establishment of those procedures in formal minutes. Procedures should include performance and documentation in the minutes of (a) an annual review of the investment performance of each investment offered in light of the objectives established for that investment option, compared with market benchmarks for each related market sector; (b) a periodic review of the operations of the Plan as carried out by Plan's service providers; (c) review of the Plan's fees and expenses for reasonableness, and (d) tax and qualification compliance. If the Plan is amended to modify or change certain elections on operating the Plan, the Plan Sponsor is already documenting its approval of the Board resolution; documentation of any actions taken or recommendations made by the Plan's Administrative Committee leading to the modification of such operations should be included.

Other Matters

Our responsibility for the ERISA-required supplemental schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

This information is intended solely for the use of the Plan's Committee and management of the Plan, and is not intended to be, and should not be, used by anyone other than these specified parties.

Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of the Spark Fun Electronics Inc. 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan’s internal control over financial reporting (“internal control”) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan’s internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan’s internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by American United Life Insurance Company that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that were not identified. However, as discussed below, we identified a certain deficiency in internal control that we consider to be a significant deficiency.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the Plan’s financial statements will not be prevented, or detected and corrected, on a timely basis. We did not identify any deficiencies in internal controls that we consider to be material weaknesses.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider the following deficiencies in the Plan’s internal control to be significant deficiencies:

Interest Rates on Participant Loans

During the course of our audit, Brock noted the loans issued to participants during 2024 had an interest rate of 4.25%. If a plan sponsor does not use a commercially reasonable or market interest rate for a participant loan, the loan may be treated as a prohibited transaction, potentially subjecting the disqualified person (usually the participant) to excise taxes, potentially risking plan disqualification, and potentially breaching fiduciary duties. Typically Plan documents have defined this commercially reasonable or market interest rate as the prime rate. As of September 27, 2025, the prime rate is 7.25%. Brock recommends Plan management work with an ERISA attorney and the Plans recordkeeper and take corrective action as necessary.

Ability to Prepare Financial Statements

As you no doubt are aware, employee benefit plans are subject to unique accounting and disclosure requirements. As your auditors, we are now required to specifically consider whether plan personnel have the necessary knowledge to apply generally accepted accounting principles in recording financial transactions and preparing financial statements for the Plan. While we can recommend adjusting journal entries and prepare draft financial statements as part of our audit, we are prohibited from acting as your internal control. Based upon the extent of our involvement in these processes, we consider this to be a significant deficiency. While this is a desirable control, we understand that the cost of additional training or additional personnel may not be justified to correct this control deficiency.
