## INDEPENDENT AUDITORS' REPORT

To the Participants and Board of Advisors  
KDM Signs, Inc. 401(k) Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the KDM Signs, Inc. 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

## 1. DESCRIPTION OF PLAN:

The following description of the KDM Signs, Inc. 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan covering substantially all full-time employees of KDM Signs, Inc. (the "Company" or "Employer") who have completed two months of service and attained the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Management and the Board of Advisors are responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to management and the Board of Advisors.

### Contributions

The Plan permits participants, through a salary deferral election, to make pre-tax or Roth contributions of up to 100% of eligible compensation, subject to the maximum annual amount permitted under Section 402(g) of the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect another deferral rate election. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Plan allows for the Company to make discretionary matching contributions. In 2024 and 2023, the discretionary matching contributions were equal to 10% of participant contributions that were allocated to participant accounts. From the direction of Plan management, discretionary profit-sharing contributions may be made into the Plan. During 2024 and 2023, the Company did not make any discretionary profit-sharing contributions. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

### Participant accounts

Each participant's account is credited with the participant's contributions and the employer discretionary matching contributions, as well as any allocation of the employer discretionary contribution and Plan earnings thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer contributions portion of their accounts is based on years of continuous service with at least 1,000 hours credited each year. A participant is 100% vested after five years of credited service.

**Notes receivable from participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Generally, the term of the loan may not exceed five years; however, if the loan is for the purchase of a participant's principal residence, the Company may permit a longer term. The loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through bi-weekly payroll deductions.

**Payment of benefits**

On termination of service, death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. A participant who has incurred a hardship, as approved by the Plan Administrator, may elect in writing to make a hardship withdrawal, subject to Plan provisions and limitations of rules and regulations established by the IRC.

**Forfeited accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$13,665 and \$251, respectively. These accounts may be used to reduce future employer contributions and administrative expenses. In 2024, employer contributions were reduced by \$254 from forfeited non-vested accounts and there were no forfeitures used to reduce administrative expenses. In 2023, administrative expenses were reduced by \$2,240 from forfeited non-vested accounts and there were no forfeitures used to reduce employer contributions.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

**Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded on the basis of the terms of the Plan document.

**Payment of benefits**

Benefits are recorded when paid.

**Administrative expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of benefits paid and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent events**

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

**3. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE AND CUSTODIANS:**

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln Financial Group Trust Company, Inc., the trustee, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the completeness and accuracy of all investments reflected on the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statements of changes in net assets available for benefits for the year ended December 31, 2024 and for the period December 16, 2023 through December 31, 2023.

Ascensus, LLC, as an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC, a prior custodian, has certified to the completeness and accuracy of all investment activity and interest income on notes receivable from participants reflected in the statements of changes in net assets available for benefits for the period June 26, 2023 through December 15, 2023.

Newport Trust Company, LLC, a prior custodian, has certified to the completeness and accuracy of all investment activity and interest income on notes receivable from participants reflected in the statements of changes in net assets available for benefits for the period of January 1, 2023 through June 25, 2023.

#### 4. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. During 2024, the Plan changed its investment methodology for the capital preservation option. The Plan previously offered participation in a stable value collective trust fund. During the year ended December 31, 2024, the Plan terminated its investment in the stable value collective trust fund and replaced it with the guaranteed investment contract (GIC) issued by The Lincoln National Life Insurance Company that was introduced to participants in 2023. See Footnote 5 for disclosure of the GIC. The change in investment option did not have a material impact on the Plan's net assets available for benefits or the amounts allocated to participants' accounts.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value collective trust fund:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts. It is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer

reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

In December 2023, the Plan transitioned service providers and the investment related to the stable value collective trust fund was in-transit and recorded as a receivable as of December 31, 2023. Therefore, the investment is not classified by level within the fair value hierarchy for 2023 (see Footnote 11 for further information). The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

As disclosed above, the Plan transitioned service providers and the investment related to the stable value collective trust fund was in-transit and recorded as a receivable as of December 31, 2023. Therefore, the investment is not measured and disclosed at net asset value per share practical expedient for the year ended December 31, 2023 (see Footnote 11 for further information).

**5. GUARANTEED INVESTMENT CONTRACT WITH LINCOLN NATIONAL:**

In 2023, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with The Lincoln National Life Insurance Company ("Lincoln National") with a balance of \$2,858,656 and \$15,620,234 at December 31, 2024 and 2023, respectively. Lincoln National maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does permit the insurance company to terminate the agreement prior to the scheduled maturity date, if certain events occur.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln National, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative

expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without consent of the issuer.

#### **6. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS:**

Certain Plan investments are managed by Lincoln Financial Group Trust Company, Inc., the trustee, and Ascensus, LLC and Newport Trust Company, LLC, the prior custodians. Therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Company pays directly certain other fees related to Plan operations.

#### **7. PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in Company contributions.

#### **8. TAX STATUS:**

The Company adopted a non-standardized pre-approved profit-sharing plan sponsored by the trustee, Lincoln Financial Group, which received a favorable opinion letter from the IRS on June 30, 2020, that stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan did not obtain its own determination letter. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

**9. RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**10. PLAN OPERATIONS IMPACTED BY COVID-19:**

On March 27, 2020, the U.S. Congress passed the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The CARES Act provided temporary relief for retirement plan sponsors and their participants with respect to distributions and participant loans during 2020. The provisions of the CARES Act could be effective and operationalized immediately, prior to amending the Plan document.

The Plan Administrator has adopted the distribution relief provisions included in the CARES Act which permitted qualified individuals to request a pre-approved distribution, through participant self-certification of eligibility. The maximum dollar amount that could be requested per participant was \$100,000 up through December 30, 2020. In December 2023, the Company formally amended the Plan to reflect such provisions in the Plan document.

**11. TRANSITION IN RECORDKEEPING PLATFORMS AND SERVICE PROVIDERS:**

Due to the merger of Newport Group, LLC and Ascensus, LLC, the Plan transitioned recordkeeping platforms from Newport Group to Ascensus effective June 26, 2023. As a result, the Plan experienced a blackout period between June 21, 2023 and June 26, 2023. During the blackout period, participants were unable to direct or diversify assets credited to their accounts, obtain participant loans, or receive distributions from the Plan.

Effective December 18, 2023, the Plan transitioned service providers from Ascensus to Lincoln Financial Group. As a result, the Plan experienced a blackout period between December 8, 2023 and January 8, 2024. During the blackout period, participants were unable to direct or diversify assets credited to their accounts, obtain participant loans, or receive distributions from the Plan. Furthermore, all participant accounts and Plan assets were converted from Ascensus to Lincoln Financial Group. During the conversion, \$15,597,126 in mutual funds were transferred to the Lincoln Stable Value Account and held in this account through year-end. In January 2024, the assets held in the Lincoln Stable Value Account were allocated among the Plan's mutual funds originally elected by the participants.

During the blackout period, the Plan's assets related to the stable value collective trust fund as well as the notes receivable from participants were in-transit and held in Lincoln Financial Group's general account. As of December 31, 2023, the Plan recorded other receivables on the Form 5500 as well as on the Statement of Net Assets Available for Benefits in the aggregate amount of \$1,228,815. These assets were allocated to the respective participant accounts in January 2024. See allocation of the stable value collective trust fund and notes receivable from participants below:
