To the Plan Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Pete's Tire Barns, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO THE FINANCIAL STATEMENTS
December 31, 2024 and 2023

1. Description of the Plan

The following description of the Pete's Tire Barns, Inc. 401(k) Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a participant directed defined contribution plan covering all eligible employees of Pete's Tire Barns, Inc. (the Employer or the Plan Administrator) who have completed three months of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer is also the administrator of the Plan. As administrator, the Employer has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. EPIC Retirement Plan Services (EPIC) is the recordkeeper of the Plan. Matrix Trust Company (Matrix) and Charles Schwab Trust Bank are the custodian and trustee of the Plan, respectively.

Contributions

Participants may elect to contribute up to 92% of pretax or after-tax annual compensation not to exceed annual limitations as provided by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also rollover amounts representing distributions from other qualified defined benefit or contribution plans.

The Employer may contribute, at the discretion of the Employer's management, a matching contribution equal to a percentage of each employee's salary deferral, excluding catch-up contributions. During 2024, the Employer matched 25% of the first 6% of eligible compensation, as defined, that a participant contributed to the Plan. The Employer may also make additional discretionary profit-sharing contributions. There were no discretionary profit-sharing contributions made for 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Employer's contribution, and their allocation of the Plan earnings/losses and any expenses incurred. Allocations are based on participant compensation or individual participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Participant notes receivable are treated as directed investments. A participant may have up to two loans outstanding at a time. The maximum loan term is 5 years, unless the proceeds are for the purchase of a primary residence, in which case the maximum term is 10 years. The notes are secured by the balance in the participant's account and bear interest at the prime rate (7.50% and 8.50% at December 31, 2024 and 2023, respectively) plus 1%. Principal and interest are paid ratably through payroll deductions.

Excess Contributions Payable

Amounts refundable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants subsequent to year end.

Payment of Benefits

Upon retirement, permanent disability, or death of a participant, the balance in the participant's account can be distributed to the participant or their beneficiaries in a lump sum amount equal to the value of the participant's vested interest in his or her account or in annual installments over a period not to extend beyond the life expectancy of the participant or beneficiary. Upon termination of employment for reasons other than death, disability or retirement, the vested portion of the participant's account can be distributed to the participant in a lump sum. Participant vested account balances that are \$1,000 or less upon termination will be paid in an immediate lump-sum distribution.

Early Withdrawals

Hardship distributions are permitted from participant's elective deferral account subject to limitations imposed by the IRC. If a participant has reached age 59½, distributions may be made, at the participant's election, for any accounts which are 100% vested without requiring the participant to terminate employment.

Vesting

A participant's right to their voluntary contributions, plus earnings thereon, is fully vested and non-forfeitable at all times. A participant shall have a non-forfeitable and vested right to a percentage of the Employer's contributions determined in accordance with the following schedule:

Less than 1	0%
1 but less than 2	20%
2 but less than 3	40%
3 but less than 4	60%
4 but less than 5	80%
5 or more	100%

Each participant shall be 100% vested in the Employer contributions upon attaining normal retirement age, death or disability.

Forfeitures

Participants in the Plan who leave the employment of the Employer before completing the required years of service forfeit the non-vested portion of their accounts. Forfeited non-vested accounts in the amount of \$17,506 and \$13,598 were available to reduce future employer contributions or pay plan expenses at December 31, 2024 and 2023, respectively. During 2024, no forfeitures were used to offset Plan expenses or Employer contributions.

Plan Termination

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. If the Plan is terminated, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Valuation of Investments and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). The Plan invests in several collective trust funds. The Plan's interest in the collective trust funds is valued at the net asset value (NAV) practical expedient of the underlying investments reported by the issuer of the collective trust funds at year end. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and the trustees.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest and are secured by the balance in the respective participant's account. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within the stated terms. Delinquent participant notes receivable are reclassified as distributions based on terms of the Plan document.

Contributions

Participant and Employer matching contributions are recorded weekly when the Employer remits the payroll deductions for investment into the Plan.

Payment of Benefits

Benefits are recognized when paid to participants or their designated beneficiaries.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Employer, unless the Employer directs that such expenses shall be paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Participant notes receivable set-up and maintenance fees and fees associated with distributions are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan held three collective trust funds and one mutual fund that accounted for approximately 55% of total Plan investments at December 31, 2024. At December 31, 2023, the Plan held two collective trust funds and one mutual fund that accounted for approximately 45% of total Plan investments.

Financial Instruments with a Concentration of Credit Risk

The Plan's investments are held by a single custodian. The Plan's exposure to credit risk is associated with the outside entity's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

3. Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis.

Money Market Funds: The carrying amount of the money market funds are deemed to be valued at deposit amount plus accrued interest, as determined according to stated terms.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds: Valued at net asset value of units of a collective trust. The net asset value, as provided by Morningstar, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the funds less its liabilities. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported net asset value. Unit values are determined by dividing the fund's net assets at fair value by its units outstanding at the valuation dates. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments or redemption restrictions for the individual participants within the Plan, however, there is up to a 12-month redemption for this investment at the Plan.

4. Income Tax Status

The Plan has adopted a prototype plan which has received a favorable opinion letter, dated June 30, 2020, from the IRS in accordance with the applicable sections of the IRC. The Plan may have been amended since receiving the opinion letter, but the Plan Administrator believes the Plan and related trust are currently designed and being operated in compliance with applicable IRC requirements. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Summary of Financial Data Certified by the Custodian

The following is a summary of financial information and data certified by the custodian, Matrix:

Statements of Net Assets Available for Plan Benefits at December 31, 2024 and 2023, except for participant notes receivable and excess contributions payable;

Investment income on the Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024; and,

Investment information provided in the supplemental schedule, Schedule of Assets (Held at End of Year) at December 31, 2024, except for participant notes receivable.

6. Differences from Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

7. Related Party Transactions and Party-in-Interest Transactions

Plan investments are held and managed by Matrix, the custodian of the Plan. EPIC is the recordkeeper of the Plan and Morningstar Investment Management (Morningstar) provides investment management services. Therefore, these transactions qualify as party-in-interest transactions. During the year ended December 31, 2024, the Plan made direct payments to EPIC and Morningstar of \$43,657 and \$29,079, respectively. Participant notes receivable also qualify as party-in-interest transactions.

8. Subsequent Events

Effective January 1, 2025, the Plan adopted a provision of the SECURE Act 2.0 allowing certain eligible participants to make increased catch-up elective deferrals, referred to as “super catch-up” contributions. Under this provision, the maximum catch-up deferral amount for participants between the ages of 60 and 63 increased from \$7,500 to \$11,250.

Management has evaluated subsequent events through October 9, 2025, which is the date these financial statements were available to be issued.
