### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Turf Care Supply Corp. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

#### Note 1. Plan Description

The following description of the Turf Care Supply Corp. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all eligible employees of Turf Care Supply Corp. (the Company or Plan Sponsor) and was established on October 11, 2005. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility:** Employees are eligible to participate in the Plan upon completion of 90 days of service.

**Contributions:** Participants can contribute up to 60% of compensation for a given pay period not to exceed limits established by the Internal Revenue Code (IRC). The Company makes matching contributions equal to 100% on the first 3% of participant's eligible compensation and an additional 50% on the next 2% of participant's eligible compensation. The Plan contains a catchup option for participants who have attained age 50 before the end of the year permitting them to make additional elective deferral contributions up to amounts limited by the IRC. Participants may contribute amounts representing roll-over distributions from other defined benefit or contribution plans.

**Participant accounts:** Plan assets are held in a trust fund established with Fidelity Management Trust Company (the Trustee). Each participant account is credited with the participant's contribution and an allocation of the Company's contribution and Plan earnings. Allocations are based on participant elections or default investment alternatives, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are generally immediately vested in participant deferral and employer matching contributions at all times. Certain top heavy contributions, as defined by the Plan, are subject to seven-year graduating vesting schedule of 20% per year beginning in the second year.

**Payment of benefits:** On termination of service, a participant may elect to receive installment payments over a period of time as described in the Plan document or a lump-sum amount equal to the value of his or her account in accordance with Internal Revenue Service (IRS) regulations. The participant also has the option of deferring payment until their normal retirement date. Balances of terminated participants of less than \$7,000 are automatically distributed to the participants. Hardship withdrawals, as defined by the Plan, are also available to participants.

**Forfeited accounts:** Amounts forfeited are to be held in a separate account and used to reduce administrative expenses of the Plan or applied to reduce future employer contributions. At December 31, 2024 and 2023, unallocated forfeited accounts and forfeitures applied to plan expenses during the year were not material to the financial statements.

**Notes receivable from participants:** The Plan allows for loans to participants from their individual account balances, which are limited to the lesser of \$50,000 or 50% of the participant's available balance, reduced by the excess of the highest outstanding loan balance of loans from the Plan to the participant during the one-year period ending on the day before the date on which such loan is made, or the outstanding balance of loans from the Plan to the participant on the date on which such loan was made. The minimum loan amount is \$1,000. Principal and interest payments are made through payroll withholding according to each note's term per the promissory note. The loans have repayment terms ranging from one to five years, or up to 10 years for the purchase of a principal residence, and bear interest at a reasonable rate based on prevailing interest rates at the inception of the loan.

#### Note 1. Plan Description (Continued)

**Administrative expenses:** All expenses of maintaining the Plan are paid by the Plan or the Company, at the discretion of the Company.

**Plan termination:** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The accounting records of the Plan are maintained on the accrual basis.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

**Contributions:** Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of benefits:** Benefits are recorded when paid.

**Investment valuation and income recognition:** The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as, held during the year.

**Notes receivable from participants:** Notes receivable from participants represent participant loans and are measured at their unpaid principal balance plus any accrued unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Repayments of principal and interest are recognized in the period in which payroll deductions are processed.

**Risks and uncertainties:** The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Subsequent events:** The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued. Effective April 1, 2025, the Plan adopted a three percent auto enrollment deferral provision for all new entrants, plus a one-time re-solicitation of any current participants without a deferral election. All auto enrolled participant's deferral rate will increase by one percent annually up to a cap of 10% of eligible compensation.

#### Note 4. Fair Value Measurements

Accounting standards established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification 820, as described below:

**Level 1:** Observable inputs such as quoted prices in active markets.

**Level 2:** Inputs, other than the quoted prices in active markets, that are observable either directly or indirectly.

**Level 3:** Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Valued at quoted market prices which represent the net asset value (NAV) of the shares held by the Plan at year-end.

**Money market fund:** Valued at the accumulation unit value of shares in the active market held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To assess the appropriate classification of assets within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of assets from one fair value level to another. There were no transfers in or out of Level 3 for the year ended December 31, 2024.

Certain Plan investments are managed by the Trustee as defined by the Plan and, therefore, these transactions are party-in-interest transactions. In addition, an affiliate of the Trustee provides investment consulting services.

Fees paid by the Plan for trust and consulting services to the Trustee and its affiliates amounted to approximately \$36,000 for the year ended December 31, 2024.

#### Note 6. Investment Contract

The Plan holds a traditional fully benefit-responsive guaranteed investment contract with Standard Insurance Company (The Standard). The Standard maintains the contributions in a general account and is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. A rate of interest contractually guaranteed by The Standard is credited to participant account balances. This minimum crediting rate is 1%.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by The Standard, represents contributions made under the contract, plus earnings, less participants withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. No such events are probable of occurring that would limit the Plan's ability to transact at contract value with the participants.

#### Note 7. Tax Status

The IRS has determined and notified the Trustee by letter dated June 30, 2020, that the prototype plan, which was adopted by the Plan on October 28, 2020, is qualified under Section 401(a) of the IRC and is exempt from tax under present income tax laws. The prototype plan has been amended since receiving the determination letter. However, the Plan Sponsor is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status and believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 8. Reconciliation of Financial Statements to IRS Form 5500

Notes receivable from participants are reported on the Form 5500 as participant loans and considered plan investments while in the Plan's financial statements they are classified as receivables from participants.
