Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the ECI Technology, Inc. 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of March 31, 2023 (in liquidation) and December 31, 2022 (ongoing), and the related statement of changes in net assets available for benefits in liquidation for the period then ended March 31, 2023 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of ECI Technology, Inc. 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 31, 2023 and December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the ECI Technology, Inc. 401(K) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter - Terminating Plan and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the Board of Directors of ECI Technology, Inc. voted to terminate the Plan as of the sale of business on February 28, 2021. In accordance with accounting principles generally accepted in the United States of America, the Plan's financial statements are presented on the liquidation basis of accounting as of and for the period ended March 31, 2023. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the ECI Technology, Inc. (the "Company") 401K Plan (the "Plan") is provided for general information purposes. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

Prior to termination, the Plan is a defined contribution plan covering substantially all full-time employees of the Company. Excluded employees of the Plan include temporary, seasonal or part-time employees with less than 1,000 hours per year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and was established to provide eligible employees, and their beneficiaries, funds for retirement. The Plan was originally effective on January 1, 1999, and amended on July 1, 2016.

Prior to termination of the Plan, ECI Technology Inc. is the Plan Sponsor. The Plan Administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, and monitors investment performance. ADP Retirement Services is the 401k recordkeeper, ADP Broker-Dealer provides the investment platform and Reliance Trust Company is the trustee of the investment assets.

The Plan Sponsor has been acquired by KLA Corporation (KLA) on February 28, 2021. The Plan Sponsor freezes the Plan effective on December 31, 2022, and becomes a participating employer in the KLA's 401(k) Plan, effective as of January 1, 2023. All participants' investments assets, including the note receivable, have been gradually transferred to KLA's 401(k) Plan.

Employee Eligibility and Contributions

Prior to termination of the Plan, employees of the Company who are twenty-one years of age or older and have completed two months of service are eligible to participate in the Plan. The plan entry date is the date that eligibility is met. Eligible employees are automatically enrolled at an initial pre-tax deferral rate of 1% of compensation once they are eligible. Employees may contribute pre-tax or in Roth-401K contributions up to the 90% of their eligible compensation up to the Internal Revenue Service's contribution limits. Participants who have attained age 50 before the end of the plan are eligible to make catch-up contributions. Excess contributions will be refunded to participants and deducted as an expense in statement of changes in net assets available for benefits in liquidation.

Participants may also contribute certain rollover amounts representing distributions from other qualified plans.

Employer Contributions

Prior to termination of the Plan, after one year of service and completion of 1,000 hours, employees will be eligible for discretionary employer matching contributions and employer profit sharing contributions although the Company is not required to do so. The Company makes matching contributions equal to 25% of the elective participant contributions up to 25% of 5% of the participant's eligible compensation. The employer contributions are subject to a vesting schedule discussed in the vesting section on page 7. Excess employer contribution is treated as payable and forfeiture.

Participant Accounts and allocations

Prior to termination of the Plan, individual accounts are established for each participant. Each participant's account is credited with the participant's contributions, employer contributions, Plan earnings and charged with an allocation of investment gains or (losses), withdrawals, and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Investments

Prior to termination of the Plan, participants direct the investment of their contributions into various investment options offered by the Plan upon enrollment in the Plan.

Vesting

Prior to termination of the Plan, participants' contributions are 100% vested immediately. Employer matching and profit -sharing contributions have the following vesting schedule:

Payment of Benefits

Prior to termination of the Plan, upon termination of service due to death, retirement, or disability, a participant or participant's beneficiary may elect to receive a lump-sum equal to the value of the participant's vested interest in his or her account, equal installments or partial withdrawals if the benefit amount is over \$5,000. If the benefit amount is under \$5,000, only a lump sum distribution is available. The Plan also allows for participant withdrawals in the event of financial hardship, rollovers and withdrawals while employed at age 59 1/2.

Notes Receivable from Participants

Prior to termination of the Plan, the Plan permits participants to borrow a minimum of \$1,000 up to 50% of their vested account balance minus any loan balance not to exceed \$50,000. The notes are secured by the balance in the participant's account and bear interest from 3.25% to 8%. Interest on loans is charged at prime rate plus 1% as published in the Wall Street Journal on the first business day of the month the loan is originated. Principal and interest are paid ratably through payroll deductions and notes must be fully paid within five years unless the loan is used for the purchase of a primary residence which carries a term of fifteen years.

Forfeited Accounts

Forfeited amounts are used to pay administrative fees and then reduce employer's contributions. There was \$6,124 in forfeitures for the period ended March 31, 2023 has been transferred to KLA's 401(K) Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

This summary of significant accounting policies of the Plan is presented to assist in understanding the financial statements. The financial statements and notes are representations of the Plan's administrator, who is responsible for their integrity and objectivity. The accounting policies conform to accounting principles generally accepted in the United States of America ("GAAP") and have been consistently applied in the preparation of financial statements.

Basis of Accounting

The accompanying financial statements have been prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of certain assets and liabilities and change therein, disclosures of contingent assets and liabilities. Accordingly, the actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Plan-to-Plan Transfers

Prior to termination of the Plan, participants within the Plan were permitted to transfer their account to another plan provided by the KLA in the event they change employers. This activity is shown, net, on the statements of changes in net assets available for benefit in liquidation.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on the investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are recorded when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. As of March 31, 2023, and December 31, 2022, the Plan had outstanding notes to participants with principal balances totaling \$ -0- and \$124,000, respectively. All loan receivables have been transferred to KLA's 401k plan.

Contributions

Contributions from employees are recorded as they are withheld from the participant's wages. There are no wages for the period from January 1, 2023, through March 31, 2023.

Payment of Benefits

Benefits payments to participants are recorded when paid.

Administrative Expenses

The expenses necessary to administer the Plan, including but not limited to, retaining necessary professional assistance from an attorney, an accountant or investment advisor are paid by the employer. Account maintenance fees, transaction fees and investment fund management fund fees have been paid by the Plan. Certain investment-related expenses have been offset with net investment income (loss) and are not readily available. Participants are charged service fees for any and distribution transactions they require.

Recent Accounting Guidance

There are no recent Financial Accounting Standards Board (FASB) pronouncements that impact the Plan's financial position and the change in net assets available for benefits in liquidation.

NOTE 3 - INVESTMENTS AND INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan's investments were held and administered by the trustees and Reliance Trust for the period ended March 31, 2023. Based on the information provided and certified by the custodian, there are no fixed income obligations, leases, or debt instruments in default or deemed uncollectable as defined by ERISA, as of March 31, 2023. Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period ended March 31, 2023, was obtained by management, and agreed to or derived from information certified as complete and accurate by Reliance Trust.

NOTE 4 - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board ("FASB") established a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include: 1) quoted prices for similar assets or liabilities in active markets; 2) quoted prices for identical or similar assets or liabilities in inactive markets; 3) inputs other than quoted prices that are observable for the asset or liability and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan's assets measured at fair value at December 31, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 - FAIR VALUE MEASUREMENTS (CONTINUED)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

ADP Inc. is the recordkeeper, ADP Broker-Dealer provides the investment platform, and the Reliance Trust Company is the trustee and therefore, these transactions qualify as party-in-interest transactions. The total fees paid by the Plan to ADP Broker-Dealer were \$650 and \$1,512 for the period from January 1, 2023, through March 31, 2023, and year ended December 31 2022, respectively.

NOTE 6 - FEDERAL INCOME TAX STATUS

The Company adopted a prototype volume submitter profit sharing 401(k) plan with ADP, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore exempt from federal income taxes. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of March 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions however, there are currently no audits for a tax period in progress. In addition, there are no tax related interest or penalties presented in these financial statements.

NOTE 7- RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits in liquidation and the statement of changes in net assets available for benefits in liquidation.

NOTE 8 - SUBSEQUENT EVENTS

For the period from January 1, 2023 through March 31, 2023, the Plan Sponsor evaluated subsequent events for potential recognition and disclosure through December 13, 2023, the date of financial statements issuance.
