Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of E Light Electric Services, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Description of the Plan

General

The following description of E Light Electric Services, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document and *Summary Plan Description*, which are available from the plan administrator, for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by E Light Electric Services, Inc. (the Company or the Employer) for the benefit of its employees who have at least one month of service and are age 18 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Company is the plan administrator. The President and Chief Executive Officer and the Vice President Finance are the trustees of the Plan. Ameritas Life Insurance Corp. (Ameritas) serves as the insurance company for the Plan, record keeper and issuer of the guaranteed investment contract.

Contributions

The Plan permits eligible employees, through a salary deferral election, to have the Company make annual contributions of up to 100% of eligible compensation. Employee rollover and catch-up contributions are also permitted. The Company may elect to make matching and/or profit-sharing contributions to the Plan. The Company's matching and profit-sharing contributions are discretionary as determined by the Company's Board of Directors. To be eligible to share in an allocation of the Company's matching, if any, a participant must be employed by the Company on the last day of the plan year and, effective January 1, 2018, credited with 1,000 hours of service. To be eligible to share in an allocation of the Company's profit-sharing contributions, if any, a participant must be employed by the Company on the last day of the plan year and credited with 1,000 hours of service. The Company made matching contributions of \$250,803 and \$206,009 for 2024 and 2023, respectively. The Company did not make any profit-sharing contributions for 2024 and 2023. The Company will make a contribution for each participant's prevailing wage service, as defined, based on the hourly contribution rate for the participant's employment classification. Such contributions will offset any qualified nonelective contributions made by the Company. The Company prevailing wage contributions for 2024 and 2023 totaled \$246,579 and \$25,364, respectively. Contributions are subject to certain limitations.

Participant Investment Account Options

Investment account options available include various pooled separate accounts and a guaranteed investment account. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

The Plan document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise. However, the Company elected not to utilize this feature in 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, if any, and plan earnings and is charged with an allocation of administrative expenses. Participants who have terminated employment with the Company, and who have elected to maintain their accounts in the Plan, are charged a \$20 annual fee. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and employer contributions plus earnings thereon.

Payment of Benefits

Upon termination of service, an employee may elect to receive payment in either a lump-sum equal to the vested value of their account or in installment distributions. The employee may also roll over the vested account balance to an account of their choice. A forced distribution will occur with all terminated participants with a vested account balance equal to or less than \$1,000. A forced distribution to a traditional individual retirement account (IRA) will occur with all terminated participants with a vested account balance between \$1,000 and \$5,000.

Participants may withdraw amounts from their accounts subject to certain limitations imposed by the Plan. Such withdrawals are also subject to certain taxes and penalties as assessed by the Internal Revenue Service.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited accounts totaled \$0. Any forfeitures would be used to reduce future employer contributions. During 2024 and 2023, forfeitures of \$0 were used to reduce employer contributions.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will remain 100% vested in their accounts.

Note 2. Summary of Significant Accounting Policies

The Plan's accounting policies conform to accounting practices prescribed by the *Employee Retirement Income Security Act of 1974*. The following policies are considered to be significant:

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value).

Pooled separate accounts are valued at estimated fair value as provided by Ameritas. Fair value of the pooled separate accounts is determined as the net asset value (NAV) of the units held by the Plan at year-end. The NAVs of the pooled separate accounts are based on the underlying mutual fund NAVs, including dividends and capital gains, and adjusted by a daily expense factor. The underlying mutual funds are considered open-end mutual funds, meaning that the fund is ready to redeem its shares at any time and offers its shares for sale to the public, either through retail outlets or through institutional investors continuously.

For institutional funds, NAVs are received daily from the fund managers, and the managers stand ready to transact at these quoted amounts. Ameritas transacts in these funds on a daily basis as part of the pooled separate account trading activity. The calculation of the NAV for funds composed of other funds (e.g., retirement target date funds) is essentially the same as the calculation of the NAV for any other fund: the total market value of assets across all underlying funds less any liabilities is divided by the outstanding shares. Again, this resulting NAV is published and/or the fund managers are ready to transact at the quoted prices.

The guaranteed investment account is an investment contract with Ameritas, which is considered fully benefit-responsive and is stated at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses. Interest rate guarantees of the deposit account are backed by assets of Ameritas. Credited rates are set based on yields earned on new purchases of fixed income securities for the general account. Credited rates are guaranteed for the duration of the guaranteed period elected by the Company and do not vary with the subsequent performance of assets of the general account that backs these guarantees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought, sold and held during the year.

Investment Contract with Ameritas

The Plan is invested into a fully benefit-responsive, traditional investment contract with Ameritas with a contract value of \$808,130 and \$787,412 at December 31, 2024 and 2023, respectively. Ameritas maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is considered fully benefit-responsive; thus, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Ameritas, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 3.0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Plan Tax Status

The Plan operates under a volume submitter adoption agreement in connection with a defined contribution volume submitter plan and trust document sponsored by Ameritas. This volume submitter plan document has been filed with the appropriate agency and the volume submitter plan sponsor has obtained an opinion letter from the Internal Revenue Service stating that the form of the volume submitter plan is acceptable under the Internal Revenue Code (IRC). The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan at the Company's discretion.

Note 3. Certification of Plan Insurance Company

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ameritas, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at year-end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are units of pooled separate accounts sponsored by Ameritas. The guaranteed investment contract is part of the general account of Ameritas. Ameritas is the insurance company and record keeper for the Plan; therefore, these transactions qualify as party-in-interest transactions. Ameritas charges the Plan fees and expenses for investment management and operating expenses, as well as contract management charges, through an expense charge. The expense charge is deducted from each investment and is reflected in the unit value of the investments held by the Plan. The Plan paid \$2,457 and \$1,451 for 2024 and 2023, respectively, to Ameritas. The Plan paid \$33,617 and \$28,966 to an external investment advisor during 2024 and 2023, respectively.

Additionally, the Plan incurs expenses related to general administration, and for certain accounting and auditing fees. The Company pays these expenses and provides certain administrative services at no cost to the Plan.

Note 5. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Recurring Measurements

In accordance with Subtopic 820-10, the Plan's investments in pooled separate accounts, that were measured at net asset value per share (or its equivalent) totaling \$8,770,462 and \$7,235,639 at December 31, 2024 and 2023, respectively, have not been classified in the fair value hierarchy. The individual separate accounts seek investment returns consistent with the underlying mutual funds.

Following is a description of the valuation methodologies and inputs that would be used for assets measured at fair value, but not measured at net asset value per share (or its equivalent), on a recurring basis and which may be recognized in the accompanying statements of net assets available for benefits, as well as the expected general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities would be classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values would be estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities would be classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities would be classified within Level 3. The Plan does not have any investments classified in the fair value hierarchy, as its investments in pooled separate accounts are the only investments stated at fair value.
