INDEPENDENT AUDITORS' REPORT

To the Participants and Board of Trustees

Opinion

INDEPENDENT AUDITORS' REPORT

To the Participants and Board of Trustees
Heat & Frost Insulators and Allied Workers Local #50 Annuity Plan

Opinion

We have audited the accompanying financial statements of Heat & Frost Insulators and Allied Workers Local #50 Annuity Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Heat & Frost Insulators and Allied Workers Local #50 Annuity Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. 1. DESCRIPTION OF THE PLAN:

The following brief description of the Heat & Frost Insulators and Allied Workers Local #50 Annuity Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution pension plan that covers employees of those employers who have agreed to make the required employer contributions to the Plan per a collective bargaining agreement between the International Association of Heat and Frost Insulators and Allied Workers Local Union #50 and the Insulation Contractors Association of Local #50. The Plan covers work performed primarily in Central and Southwest Ohio. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The contributing employers are primarily located in Southwest and Central Ohio. Therefore, the Plan is affected by the economic conditions of the region.

Contributions

No participant contributions to the Plan are permitted, other than contributions representing distributions from other qualified defined benefit or defined contribution plans (rollovers). In accordance with the collective bargaining agreement, employers are required to make monthly contributions at a fixed dollar amount for each hour worked by participants. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

Participants of the Plan and participants of the benefit plans of other affiliated local unions may have temporary employment assignments outside of the jurisdiction of their local union. Therefore, the Plan has entered into reciprocity agreements with other affiliated locals to ensure that contributions are forwarded to the benefit plans of the participant's local union.

Participant accounts

Each participant's account balance is credited with employers' contributions, plan earnings, and charged with all allocation of administrative expenses and any fees associated with distributions from the participant's account. Allocations are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in the contributions made on their behalf by employers plus actual earnings thereon.

Notes receivable from participants

Participants may borrow a minimum of \$1,000 from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one loan outstanding at a time. Payments will be made in equal monthly installments over a period not to exceed five years. Interest will be charged at a rate set by the Board of Trustees that is currently the prime rate plus 1%.

Payment of benefits

Upon termination of service due to retirement, disability or death, a participant and/or beneficiary may elect to receive either a lump sum payment, month certain annuity, life annuity, or joint and survivor annuity based on the remaining balance in the participant's account. For deemed termination of service due to 6 months without contributions, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Concentration

The Plan received contributions from three employers that accounted for 71% of contributions and 84% of contributions receivable as of and for the year ended December 31, 2024. The Plan received contributions from four employers that accounted for 69% of contributions and five employers that accounted for 84% of contributions receivable as of and for the year ended December 31, 2023.

Concentration of credit risk

Periodically during the year, the Plan may have cash on deposit with financial institutions in excess of federally insured limits. The Plan has not experienced any losses in such accounts, and the plan administrator believes that the Plan is not exposed to any significant credit risk with its cash on deposit with financial institutions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Employer contributions receivable

Employer contributions receivable represents amounts due from employers that were received subsequent to year end. Therefore, the carrying amount of these receivables is not reduced by an allowance for amounts that will not be collected. In addition, it is impractical to estimate revenue recognition for amounts due but erroneously unreported by employers.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan deems the participant to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Benefit payments

Benefit payments to participants are recorded upon distribution.

Expenses

Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. Investment related fees are included in net appreciation in fair value of investments. Fees related to participant directed transactions are charged directly to the participant's account and are included in administrative expenses. Certain expenses are paid through revenue sharing rather than direct payment.

Subsequent events

The Plan has evaluated subsequent events through August 28, 2025, the date the financial statements were available to be issued.

3. TAX STATUS:

The Internal Revenue Service (IRS) has determined and informed the Plan by a letter dated July 8, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

4. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the funds. The funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarch table is based on the lowest level of any input that is significant to the fair value measurement.

5. GUARANTEED INVESTMENT CONTRACT:

In 2021, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Massachusetts Mutual Life Insurance Company (MassMutual). The account balances are backed by the general assets of MassMutual. On December 31, 2020, Empower acquired the retirement business of MassMutual. Empower became the sole administrator and responsible for the business in 2021. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. The Plan administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with participants.

6. PLAN TERMINATION:

In the event the Plan is terminated, any obligations of the Plan would be paid, and all remaining net assets would be distributed to participants in the manner specified in the Plan.

7. PARTY IN INTEREST TRANSACTIONS:

Empower receives revenue from certain investments for services Empower provides to the funds. If the revenue received by Empower exceeds the amount owed under the service agreement with Empower, such amounts may be applied to Plan administrative expenses. Empower is the current custodian and, therefore, these transactions qualify as a party in interest transactions.

9. RISKS AND UNCERTAINTIES:

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
