Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### 1. Description of Plan

The following description of the Entelligence, L.L.C. 401 (k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the comprehensive Plan Document for a more complete description of the Plan's provisions.

#### *General*

The Plan was adopted effective January 1, 1998 by Entelligence, L.L.C., ( the Company). The Company is the sponsor of the Plan. The Plan is a defined contribution plan covering substantially all employees of the Company, as defined below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was most recently amended and restated effective November 30, 2021 to conform to new tax laws.

#### *Trustee and Administration of the Plan*

The trustee and recordkeeper of the Plan is Ascensus Trust Company. The trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

All employees of the Company who have reached age 21 and have completed three consecutive months of service with the Company are eligible to participate in the Plan. Employees may enter the Plan on the first day of the month on or after meeting the age and service requirements.

#### *Contributions*

The Plan provides for voluntary participant contributions expressed as a percentage of the participant's eligible pre-tax compensation or dollar amount. This percentage is not to exceed the limits set by the Internal Revenue Code (IRC), which limits the annual amount of salary deferrals that may be made by any participant. A participant may elect to have all or a portion of the participant's elective deferrals to be Roth elective deferrals when contributed to the Plan. Roth elective deferrals are subject to federal income taxes in the year of deferral and are not subject to federal income taxes when distributed. Participants who have attained or will attain age 50 by the end of the calendar year may make additional catch-up contributions. Rollovers are also permitted from distributions received from other qualified retirement plans.

The Company may make a discretionary matching contribution equal to a uniform percentage of the participant's salary deferrals for the benefit of its employees. Each year, the Company will determine the amount of discretionary percentage for matching contributions. During 2024, discretionary matching contributions were equal to 50% of the first 5% of an employee's elective deferral, for a maximum match of 2.5%. The Company may elect to make an annual discretionary profit-sharing contribution on behalf of its participants. In order to be eligible for the discretionary profit sharing contribution, the participant must be employed on the last day of the Plan year and have completed at least 1,000 hours of service for the Plan year. During 2024, the Company did not make a discretionary profit-sharing contribution to the Plan.

### *Participant Accounts*

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

### *Vesting*

Participants are 100% vested in their individual deferral, Roth, after-tax, and rollover contributions and the allocated earnings thereon.

A participant's vested interest in their matching contributions and profit-sharing contribution are based upon the participant's years of continuous service. Employer matching and profit-sharing contributions are subject to the following vesting schedule below:

Vesting Service (in Years)	Vesting Percentage (%)
Less than 1	-
1 but less than 2	20
2 but less than 3	40
3 but less than 4	60
4 but less than 5	80
5 years or more	100

Participants become fully vested in the event of retirement, death, and disability, as defined by the Plan.

### *Notes Receivable from Participants*

Participants may take a loan from the Plan. The minimum loan amount is \$1,000 up to a maximum of \$50,000 (reduced by the highest outstanding loan balance in the previous 12 months) or one-half of their vested account balance (reduced by the current outstanding loan balance, if any), whichever is less. Loans are secured by the balance in a participant's account and bear interest at rates that are commensurate with market rates for similar loans. Principal and interest payments are paid ratably through payroll deductions over a term not to exceed five years, unless the loan was obtained to acquire a principal residence. Participants are permitted to have one loan outstanding at any time.

### *Payment of Benefits*

Upon termination of employment, participants may take a payout of the vested portion of their account balance. Distributions from the Plan will be made in a lump sum, partial payments, or installment payments. If the vested balance at the time of termination is \$1,000 or less, the participant must take it out or the Company will distribute as a lump sum. If the vested account balance is between \$1,000 and \$5,000, the participant must take the vested account balance from the Plan or the Company will roll it over to an IRA. If the vested account balance is greater than \$5,000, the participant is not required to take a payout from the Plan until the required minimum distribution rules apply.

Participants may take an in-service distribution when they reach age 59½, normal retirement age, or have a qualifying financial hardship.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### ***Forfeited Accounts***

If a participant terminates employment before being fully vested, the non-vested portion of their Plan balance remains in the Plan as a forfeiture. Forfeitures may be used to pay the Plan's administrative expenses or to reduce future employer contributions to the Plan. Forfeitures totaled \$28,712 and \$52,655 at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024 the Plan used \$68,931 to fund employer contributions and \$22,689 to pay administrative expenses.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### *Payment of Benefits*

Benefits are recorded when paid.

### **3. Certified Investment Information**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income comprised of net appreciation in fair value of investments and interest and dividend income, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the supplemental Schedule H (Form 5500) Line 4i-Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

### **4. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - This level consists of inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - This level consists of inputs to the valuation methodology that include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - This level consists of inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money Market Fund* - The money market fund is valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund registered with the SEC. The fund is required to publish its daily net asset value (NAV) and to transact at that price. The money market fund is deemed to be actively traded.

*Mutual Funds* - The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

## **5. Related Party and Party-in-Interest Transactions**

Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party in interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

## **6. Risks and Uncertainties**

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of

risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### **7. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

### **8. Tax Status**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan has been amended from the original non-standardized preapproved plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **9. Subsequent Events**

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.
