To the Participants of
Doehler North America 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Doehler North America 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

1. DESCRIPTION OF PLAN

The following description of the Doehler North America 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Adoption Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution retirement plan sponsored by Doehler North America, Inc. (the “Sponsor”). The Plan covers substantially all employees, excluding non-residents and union employees, of the Sponsor, Doehler USA Inc., Doehler Juice Solutions, and Menu Collective Real Estate (collectively, the “Employers”), who are twenty-one or older and have completed one month of service. The Plan became effective on February 1, 2011, and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”) and the Internal Revenue Code (“IRC”).

Contributions

Each eligible participant may contribute, on a pre-tax or after-tax basis, a percentage of eligible compensation (as defined) to the Plan, through a salary reduction program. For any calendar year, elective deferrals may not exceed a specific dollar amount prescribed by the IRC, which is adjusted annually by the Internal Revenue Service (“IRS”). The Plan also allows participant rollover contributions from other qualified plans.

For active participants in the Plan, the Employers make safe harbor matching contributions equal to 100% of the first 3% plus 50% of the amount that exceeds 3% but does not exceed 5% of participant’s elected salary deferral. The Employers may also make discretionary matching and profit-sharing contributions. There were no discretionary matching or profit-sharing contributions made during the year ended December 31, 2024.

Investment options

The Plan’s assets are held by John Hancock Trust Company, LLC (the “Custodian”), the custodian of the Plan’s assets. Under this arrangement with the Custodian and upon enrollment in the Plan, participants may direct all contributions in any whole percentage increments into any of the available funds. Participants may change their allocation to the various investment options at any time via the internet.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless the loan qualifies as a home loan, for which the term may be extended beyond five years. The loans are secured by the balance in the participant’s account and bear interest at a fixed rate as determined by the plan administrator. Principal and interest are paid ratably through periodic payroll deductions. Interest rates ranged from 4.25% to 9.50% on loans outstanding at December 31, 2024 and 2023. A participant is permitted to have one outstanding loan for general purpose and one loan for the purchase of a primary residence.

Participant accounts

Each participant’s account is credited with (a) the participant’s contributions, (b) the Employers’ contributions on behalf of the participant and (c) the earnings and losses of the participant’s investments and is charged with any expenses incurred as a result of transactions initiated by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Vesting

Participants are immediately vested in their contributions and Employer’s safe harbor matching, discretionary, and profit-sharing contributions, and actual earnings thereon.

Payment of benefits

Upon termination of employment, attainment of retirement age, or for reasons of death or disability, participants may withdraw the vested portion of their account in the form of a lump sum. Participants still employed with the Sponsor may withdraw all or a portion of their account balance upon attainment of age 59½ or for reasons of a financial hardship, as allowed under the IRC. A participant whose vested account balance does not exceed \$1,000 will receive a lump sum distribution of their vested account balance as soon as administratively feasible following termination. A participant whose vested account balance exceeds \$1,000 but does not exceed \$7,000 will have their vested account balance rolled over into an Individual Retirement Account (“IRA”) outside of the Plan in their name as soon as administratively feasible following termination of employment.

Administrative expenses

Administrative costs associated with certain participant-initiated transactions are paid by the Plan and are charged to the accounts of the participants who initiate the transactions. The Plan also pays investment advisory fees.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment valuation and income recognition

Investments, except for fully benefit-responsive investment contracts, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Dividends are recorded at the ex-dividend date. See Note 6 for discussion of fair value measurements. Interest income is recorded when earned. Net appreciation/depreciation in the fair value of investments includes realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Fully benefit-responsive investment contracts are stated at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements.

Use of estimates in financial statement preparation

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan’s management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance.

Subsequent events

The Sponsor has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

3. RELATED PARTY TRANSACTIONS

The Employers pay certain costs on behalf of the Plan for insurance, accounting, and custodial fees. The Employers also provide recordkeeping and administrative services to the Plan at no cost.

The Plan offers investment options which are managed by the Custodian. Accordingly, transactions in these investments qualify as party-in-interest transactions under ERISA.

4. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by the Custodian, except for comparing such information certified by the Custodian to information included in the Plan’s financial statements and supplemental schedule.

5. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a guaranteed investment contract with The Lincoln National Life Insurance Company, who maintains the contributions in a general account. The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

Transfers by participants from the general account to other funds are generally permitted at contract value. Certain non-participant directed events could also limit the ability of the Plan to transact with the issuer at contract value. Such events include the following: (a) termination of the Plan, (b) merger of the Plan into another plan, or (c) premature termination of the contract by the Sponsor.

The specified contract interest crediting rate is adjusted semi-annually and is guaranteed to be at least 1.00%. During the year ended December 31, 2024 interest rates ranged between 2.50% and 2.60%.

6. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) *Accounting Standards Codification* (“ASC”) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used during the year ended December 31, 2024.

- Mutual funds: Valued at the net asset value (“NAV”) of shares held by the Plan at year end. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Employers have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts balances and the amounts reported in the statements of net assets available for benefits.

9. INCOME TAX STATUS

The Plan uses a volume submitter plan document sponsored by John Hancock Retirement Plan Services LLC, who was informed by the IRS by a letter dated June 30, 2020, that the Plan, as amended, is designed in accordance with the applicable sections of the IRC. The Plan has not obtained a determination from the IRS on its adoption of the volume submitter profit-sharing plan. In accordance with Revenue Procedure 2002-6, the Sponsor has chosen to rely on the opinion letter of the volume submitter plan. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Sponsor believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress and the Sponsor believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

11. PLAN AMENDMENT

Effective January 1, 2024, the Sponsor increased the threshold for forced distributions of terminated participants from \$5,000 to \$7,000 as permitted under the SECURE Act 2.0.

12. SUBSEQUENT EVENTS

Effective January 1, 2025 the Plan document was amended and restated to reflect the merger of the SVZ USA Washington, Inc. 401(k) Profit Sharing Plan into the Doehler North America 401(k) Plan. As part of this restatement, the following changes were made:

- Eligibility requirements were lowered from age 21 to age 18
- Prior contributions under the SVZ USA Washington, Inc. 401(k) Profit Sharing Plan were 100% vested as of the date of merger
- Eligibility requirements for employer profit sharing contributions were changed to employment on the last day of the year, regardless of service.

 - Vouched remittances to payroll records and sampled participant accounts.

Planned scope and timing of the audit

We conducted our audit consistent with the planned scope and timing we previously communicated to you in our engagement letter and during the course of the audit.

Qualitative aspects of accounting practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during the year. No matters have come to our attention that would require us, under professional standards, to inform you about (1) the methods used to account for significant unusual transactions and (2) the effect of significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. We did not note any such sensitive accounting estimates during the course of our audit.

The financial statement disclosures are neutral, consistent, and clear.

Significant unusual transactions

Professional standards require us to communicate to you significant unusual transactions identified during our audit. We did not identify any significant unusual transactions during the course of our audit.

the relevant classes of transactions, account balances or disclosures, and the financial statements as a whole. A listing of uncorrected misstatements was included with managements representation letter dated October 6 2025. Management determined that this misstatement was not material to the financial statements as a whole.

In addition, none of the misstatements detected as a result of audit procedures and corrected by management were material, either individually or in the aggregate, to the financial statements taken as a whole.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Internal control deficiencies and reportable findings

In planning and performing our audit of the financial statements of the Plan as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Company's internal control over financial reporting ("internal control") as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Company's internal control. Accordingly, we do not express an opinion on the effectiveness of the Company's internal control.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the entity's financial statements will not be prevented, or detected and corrected, on a timely basis.

A reasonable possibility exists when the likelihood of an event occurring is either reasonably possible or probable as defined as follows:

- Reasonably possible. The chance of the future event or events occurring is more than remote but less than likely.
- Probable. The future event or events are likely to occur.

Our consideration of internal control was for the limited purpose described in the first paragraph and was not designed to identify all deficiencies in internal control that might be material weaknesses. Given these limitations, during our audit we did not identify any deficiencies in internal control that we consider to be material weaknesses. However, material weaknesses may exist that have not been identified.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider the following deficiencies in the Company's internal control to be significant deficiencies:

Finding:

During our 2023 audit, we noted that Management was unable to reconcile compensation on the safe harbor match true up calculation with payroll records. We noted during the 2024 audit that certain individuals with eligible compensation and deferrals were excluded from the safe harbor match true up calculation.

Recommendation:

We recommend that the Company implement procedures to ensure proper safe harbor match census maintenance. We further recommend reconciliation to payroll and source documents to ensure match true up calculations are accurate and complete. Management should review and reconcile variances to ensure that safe harbor match true up is calculated appropriately and determine whether corrective contributions are required as soon as administratively feasible.

Finding:

During our audit, we noted that for certain individuals tested, eligible compensation for safe harbor match true up included compensation paid prior to eligibility.

Recommendation:

We recommend that management implement procedures to ensure that safe harbor match true up census is reconciled to eligible compensation and make any necessary corrections as soon as administratively feasible.

Finding:

During our audit, we noted two remittances received by John Hancock, which were lower than payroll withholdings by an amount traced to two separate participants.

Recommendation:

We recommend that management implement procedures to reconcile payroll remittances payroll withholdings and make any necessary corrections as soon as possible.

Disagreements with management

For purposes of this letter, professional standards define a disagreement with management as a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of our audit.
