## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of LifeQuest 403(b) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of LifeQuest 403(b) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

## **Basis for Opinion**

**1. Description of Plan**

The following description of the LifeQuest 403(b) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General*

The plan is a defined contribution plan covering all employees of LifeQuest and its controlled not-for-profit entities (the “Organization”). All employees of the Organization are eligible to participate upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

*Eligibility*

An employee becomes a participant in the Plan on their date of hire with no minimum age requirement.

*Contributions*

There are several types of contributions that can be added to a participant’s account: an employee salary deferral contribution, an employee Roth elective deferral, and an employer matching contribution.

Each year, participants may contribute a portion of their compensation, as defined in the Plan, subject to certain limitations under the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans, as well as catch-up contributions. The Organization makes matching contributions equal to 100% of the amount of eligible participant’s elective deferrals, up to 2.00% of the participant’s compensation.

Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations. Participants may change their deferral election at times throughout the year as defined in the plan document.

*Participant Accounts*

Each participant’s account is credited with the participant’s contribution, any rollover contributions, and allocations of (a) the Organization’s matching contribution and (b) Plan earnings, and are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**1. Description of Plan (Continued)**

Vesting

Participants are vested immediately in their contributions and rollover account plus actual earnings thereon regardless of the number of years of service. Vesting in Organization contributions are based on years of service. Participants hired prior to January 1, 2018 vest immediately in all contributions plus actual earnings thereon. For participants hired after January 1, 2018, vesting in Organization contributions are based on years of service. One year of service is defined as a period of twelve consecutive months of employment, with 1,000 hours of service.

A participant becomes 100 percent vested after four years of credited service, as follows:

<u>Full Years of Service</u>	<u>Vesting Percentage</u>
Less than 1 Year	0%
1 Year	25%
2 Years	50%
3 Years	75%
4 Years	100%

Notes Receivable from Participants

Notes receivable from participants are permitted under the Plan in an amount not to exceed the lesser of one-half of the participant's vested interest under the Plan or \$50,000. The minimum of any loan shall be \$1,000. Participants may only have one loan outstanding at any one point in time. The loans are secured by the balance in the participant's account and bear interest at fixed rates. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

The Plan allows participants to make in-service withdrawals at age 59½, at normal retirement age, and withdrawals from rollover contributions accounts. The Plan allows participants to make hardship withdrawals from salary reductions and rollover contribution accounts. Benefits are recorded when paid.

Forfeiture Accounts

Forfeited non-vested accounts totaled \$-0- as of December 31, 2024 and 2023. These accounts may be used to reduce future employer contributions or pay plan expenses. During the years ended December 31, 2024 and 2023, forfeitures applied to employer contributions were \$11,312 and \$11,174, respectively.

**2. Summary of Accounting Policies**

*Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

*Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

Investments are reported at fair value (except for fully-benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on the investments bought and sold as well as held during the years.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest is recorded on the accrual basis. If a participant ceases to make loan payments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

*Investment Fees*

Net investment returns reflect certain fees paid by the investment funds to their affiliated investment advisors, transfer agents, and others as further described in each fund prospectus or other published documents. These fees are deducted prior to allocation of the Plan's investment earnings activity and thus are not separately identifiable.

*Plan Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative fees. Certain investment-related expenses are included in net appreciation of fair value of investments.

*Benefit Payments*

Benefits are recorded when paid.

*Excess Contributions Payable*

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction in contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants during February 2025 and March 2024, respectively.

**3. Investment Contract with Insurance Company**

The Principal Fixed Income Option is a fully benefit-responsive single group annuity contract issued by Principal Life Insurance Company ("Principal"). The annuity contract is backed by Principal's general account. The contract is included in the financial statements at contract value as reported to the Plan by Principal. Contract value is the aggregation of contributions, plus earnings, less participant withdrawals and administrative expenses. Participants direct the withdrawal or transfer of all or a portion of their investment at contract value without adjustment.

The contract has a surrender charge of 5% if the Plan terminates its interest in the contract without 12 month's advance notice. Plan management believes that the occurrence of events that would cause the plan to transact at less than contract value is not probable. Principal may not terminate the contract at any amount less than contract value.

Principal is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. Effective January 1, 2014, the crediting interest rate, as determined by the formula, may not be less than 1% or greater than 3%.

The crediting interest rates for the 6-month periods through December 31, 2024 are as follows:

The Principal contract is a single group annuity contract with a fixed rate of interest. It is not a portfolio of contracts whose yields are based on changes in fair value of underlying assets. As a result, the average yield earned by the Plan and the average yield earned by the Plan with an adjustment to reflect the actual interest credited to the participants is the yield earned (i.e. - interest credited) on the group annuity contract.

**4. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Investments classified within Level 3 whose fair value measurements consider several inputs may include Level 1 and/or Level 2 inputs as components of the overall fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**4. Fair Value Measurements (Continued)**

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Information Certified by the Trustee**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023 and net appreciation/(depreciation) in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator who has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and certified as complete and accurate by Principal Life Insurance Company, the trustee of the Plan.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and the supplemental Schedule of Assets (Held at End of Year).

**6. Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**7. Tax Status**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The plan administrator and the plan's tax counsel believe that the terms of the plan have been prepared to conform to the listing of 403(b) plans that have been pre-approved by the Internal Revenue Service (IRS) and in a letter dated March 31, 2017, the IRS noted the form of the plan is acceptable under Section 403(b). The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. Transactions with Parties in Interest**

Certain routine plan administrative expenses are incurred and/or paid by the plan sponsor. Notes receivable from participants also qualify as exempt transactions with parties-in-interest. Certain plan investments are shares of mutual funds managed by Principal Life Insurance Company. Principal Life Insurance Company is the trustee as defined by the Plan and therefore these transactions qualify as party-in-interest transactions. Other than the aforementioned, the Plan has no agreements or transactions with parties-in-interest.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risk such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.
