**1. Description of the Plan**

The following description of the Samy's Camera, Inc. Employees' 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan established under the provisions of Section 401(k) of the Internal Revenue Code. The Plan, and related trust, are subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

The Plan covers all eligible employees of Samy's Camera, Inc. and SSTBS, Inc. (collectively known as the Company) who have reached age eighteen and have three months of credited service, as defined by the Plan. The Plan provides that an employee enters the Plan immediately upon satisfaction of these eligibility requirements.

***Contributions***

*Participant contributions:*

Each year, participants may contribute up to 100% of their annual pretax compensation or after-tax compensation as defined by the plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and insurance investment contracts as investment options for participants. Participants may not make annual contributions in excess of the government-imposed limit, which was \$23,000 during the year ended December 31, 2024. The government-imposed limit is increased by \$30,500 for participants who reach age 50 by year-end. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

*Employer matching contributions:*

Each year, the Company may make a matching contribution for Plan participants each year equal to 25% of participant contributions that do not exceed 4% of their compensation. During the year ended December 31, 2024, the employer matching contributions to the Plan were \$43,775.

*Employer profit-sharing contributions:*

Each plan year, the Company may make an additional discretionary profit sharing contribution on behalf of all participants employed by the Company on the last day of the plan year. During the year ended December 31, 2024, there were no employer profit sharing contributions made to the Plan.

***Investment options***

Participants must direct their salary deferral contributions and their share of the Company's contributions into various investments as made available and determined by the Plan Administrator, which are more fully illustrated in the Plan's literature.

***Participant accounts***

Each participant account is credited with the participant's contribution and Company matching contributions, as well as allocation of the Company's profit sharing contribution and Plan earnings. Participants accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

***Vesting***

Participants are immediately vested in their voluntary, and Company matching and profit-sharing contributions, plus actual earnings thereon. A participant is also fully vested upon death, total disability or normal retirement.

***Notes receivable from participants***

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest which approximate with the prevailing rates as determined by the Plan administrator. Interest rate for all loans is 4.25% – 10.5%. Principal and interest are paid ratably through bi-weekly payroll deductions.

***Payment of benefits***

Upon termination of service due to death, disability, or retirement, a participant or the participant's beneficiary will receive a value of the vested account balance in the form of a joint and survivor single-life annuity. The participant, or the participant's beneficiary, may also elect to either receive a lump-sum amount, or substantially equal installments, equal to the value of his or her account. The participant may also elect partial withdrawals in increments of not less than \$1,000. For termination other than death, disability, or retirement, the participant will receive a lump-sum distribution of his or her vested account balance within an administratively reasonable period of time after termination. There is an automatic cash-out provision for participants with balances not exceeding \$5,000.

**2. Summary of accounting policies**

A summary of the significant accounting policies followed by the Plan in the preparation of the accompanying financial statements is as follows:

***Basis of accounting***

The accompanying financial statements have been prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America

***Investment valuation and income recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

***Notes receivable from participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. During the year ended December 31, 2024, there were no participant loans considered in default and recorded as benefit payments.

***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Expenses***

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and are charged directly to the participant's account.

***Payment of benefits***

Benefits are recorded when paid.

***Risks and uncertainties***

The Plan invests in a variety of investment funds. Investments, in general, are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

***Subsequent events***

The Plan has evaluated subsequent events through October 9, 2025, the date which the financial statements were available to be issued. There were no subsequent events noted that would require adjustment to or disclosure in these financial statements.

**3. Certified investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income, and administrative expenses for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Life Insurance Company (USA).

**4. Fair value measurements**

The framework for measuring fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level I – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level II – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in active markets;
- Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level III – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**5. Plan termination**

Although it has not expressed any intent to do so, the Company has the right under provisions of the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**6. Related party transactions and party in interest transactions**

Certain Plan investments are shares of mutual funds managed by John Hancock Life Insurance Company (USA) (John Hancock). John Hancock is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

**6. Related party transactions and party in interest transactions (continued)**

Fees incurred by the Plan for the investment management services are included in net appreciation in the fair value of investments, because they are paid through revenue sharing rather than direct payment. The Plan or the Company may make a payment for administrative expenses not covered by revenue sharing.

**7. Tax status**

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
